Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jones Dairy Farm Bargaining Employees' Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 DESCRIPTION OF PLAN

The following brief description of the Jones Dairy Farm Bargaining Employees' Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and is intended to be a qualified retirement plan under the Internal Revenue Code (IRC) for the purpose of providing eligible employees to save for retirement. The Plan covers all union employees of Jones Dairy Farm (the Company) and their wholly owned subsidiary, Ralph and Paul Adams, Inc., who have completed six months of service. The Plan is subject to the provisions of ERISA, as amended.

Contributions

Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Effective February 19, 2024, automatically enrolled participants have their deferral rate set at 5.5% of eligible compensation. Prior to February 19, 2024, automatically enrolled participants had their deferral rate set at 5%. The contributions of automatically enrolled participants are invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a nondiscretionary matching contribution equal to 100% of the participant's contribution up to a maximum of 4% of eligible compensation for participants hired prior to January 1, 2019 and a nondiscretionary matching contribution equal to 100% of the participant's contribution up to a maximum of 5.5% of eligible compensation for participants hired subsequent to January 1, 2019. The Company may contribute a discretionary amount for a Plan year which the Company will designate as qualified nonelective contributions. The Company will allocate these contributions to the participants who are eligible for an allocation based upon the participant's share of the total compensation paid during that Plan year. In 2024, no such contribution was made.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and an allocation of (a) the related Company matching contribution and (b) the Plan's investment earnings (losses) and charged with an allocation of administrative expenses, net of available forfeitures. Plan investment income or loss within each fund is allocated to participants based upon their relative account balances as a percentage of the total account balances of all participants in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Investment Options

Participants direct the balance of their account into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and one collective fund as investment options for participants. Participants may also invest in self-directed brokerage accounts, which include common stock, mutual funds, and money market funds. All investments are participant-directed.

Vesting

The balance in a participant's account relating to Company contributions becomes 100% vested after three or more years of credited service. All participant contributions and nonelective Company contributions are immediately fully vested. Participant accounts are 100% vested upon retirement, disability, or death.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are retained in the Plan and are used to reduce administrative expenses or future Company contributions. The balance in the forfeiture account at December 31, 2024 and 2023 was \$72,894 and \$68,746, respectively. The Plan used \$44,791 to reduce Company contributions for the Plan during the year ended December 31, 2024.

Payment of Benefits

Upon termination of employment, a participant or the participant's beneficiary is entitled to receive the vested portion of the participant's entire account balance. Distributions of Plan benefits are paid to participants in the form of a single lump sum payment or rollover. If a terminating participant's account balance does not exceed \$1,000, the Plan will distribute the benefit in a lump sum as soon as administratively practicable. The Plan provides for participant hardship withdrawals under terms described in the Plan document.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance. Loan amounts may not exceed \$50,000. The loans will bear a reasonable rate of interest as determined by the Plan administrator. Loan terms range from one to five years, or longer if for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through periodic payroll deductions.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participants' accounts are charged for fees associated with loan and early withdrawal requests. Management fees paid to the investment managers of the individual funds are netted against the investment income allocated to participant accounts.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of security investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS

Fidelity Management Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Generally accepted accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – One or more inputs to the valuation methodology are unobservable and significant to the fair value measurement. Includes items valued using pricing models, discounted cash flows, and items supported by little or no market activity.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Fund: Valued at the NAV of the units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-Directed Brokerage Accounts: Consist of common stock and money market funds and are valued at the closing price reported on the active market on which the individual securities are traded.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PARTY-IN-INTEREST

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company (Fidelity). Fidelity is the qualified institution as defined by the Plan, and therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 INCOME TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is designed in accordance with applicable sections of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become fully vested in their account balances.
