We have performed audits of the accompanying financial statements of American Truetschler, Inc. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. DESCRIPTION OF PLAN:

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General - The Plan is commonly known as an Internal Revenue Code Section 401(k) profit sharing plan intended to conform to and qualify under Section 401 and Section 501 of the Internal Revenue Code, as amended. The Plan covers all employees who have completed the length of service requirement, as defined. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee determines the appropriateness of the Plan's investments offerings, monitors investment performance, and reports to the Board of Trustees.
- B. Sponsor Contributions - Each year, the Plan sponsor's Board of Directors determines the amount, if any, of the profit-sharing contribution to the Plan. The contribution cannot be greater than 15% of the total compensation of all the Plan participants, as defined. In addition, the Plan sponsor has elected to contribute 50% of base compensation that a participant contributes to the Plan.
- C. Employee Pre-Tax Contributions - All participants may make tax deferred cost contributions of up to 100% of total compensation, as defined, subject to statutory limitations. Participants over age 50 may defer an additional amount each year to the Plan as defined which are deemed "catch-up contributions."
- D. Forfeited Accounts - Forfeited, non-vested participant accounts are reallocated to remaining participants for the Plan year immediately following the Plan year in which the forfeiture occurs.
- E. Participant Accounts - Each participant's account is credited with the participants' contributions and allocation of the Sponsor's contributions and Plan earnings. Profit sharing allocations are based on a ratio of the participants' compensation to the total of all participants' compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account.

1. DESCRIPTION OF PLAN: (CONTINUED)

- F. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

- G. Payment of Benefits - On termination of service, due to death, disability, retirement, or termination, participants generally receive the value of their benefits in one lump sum payment. Hardship distributions are permitted in the Plan subject to certain conditions as defined by the Plan.

- H. Operating Expenses - The sponsor generally pays most of the costs of Plan administration including legal, audit and record keeping expenses. However, trustee expenses are paid by the Plan directly.

- I. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expense when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

- J. Eligibility - Eligibility within the plan begins immediately upon employment.

2. SUMMARY OF ACCOUNTING POLICIES:

- A. Basis of Presentation - The financial statements have been prepared in compliance with Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- B. Basis of Accounting - The Plan's financial statements are prepared on the accrual basis of accounting under principles generally accepted in the United States of America.

- C. Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Participant notes receivable are valued at their outstanding balances, including accrued interest, which approximates fair value.

- D. Payment of Benefits - Benefits are recorded when paid.
- E. Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- F. Fair Value Measurements - The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of quoted market prices in active markets for identical assets or liabilities. An active market for the asset or liability is a market in which the transaction for the asset or liability occurs with sufficient frequency and volume to provide pricing information on an ongoing basis.
- Level 2 input consist of observable market-based inputs or unobservable inputs that are corroborated by market data, such as quoted prices for similar assets or liabilities or model-derived valuations.
- Level 3 inputs consist of unobservable inputs that are not corroborated by market data. These inputs reflect a company's own assumptions a market participant would use in pricing the asset or liability.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at the end of the year, a level 1 input. The fair value of common and collective trusts is based on significant other observable inputs, a level 2 input. The Plan did not rely on level 3 inputs.

4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2024, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a pooled account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. INVESTMENTS:

Principal Life Insurance Company is the Plan trustee, and as such, executes the Plan's transactions and holds the Plan's assets. The information presented in the accompanying financial statements and supplemental schedule was prepared by Principal and presented to the Plan's administrator together with a certification that such information is complete and accurate. Consequently, the Plan administrator has elected to limit the scope of the accountants' examination and opinion as permitted by Section 2520.103.8 of the Department of Labor's Rules and Regulations Income Security Act of 1974 (ERISA).

6. RELATED PARTY TRANSACTIONS:

The Plan's participant loans are managed by Principal Life Insurance Company (Principal). Principal is the trustee as defined by the Plan and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the

transactions with participant loans amounted to \$744 for the year ended December 31, 2024. Additionally, certain Plan investments are held in a Principal guaranteed investment contract which are also party-in-interest transactions. Fees paid by the Plan investments amounted to \$14,886 for the year ended December 31, 2024.

These party-in-interest transaction is exempt from the prohibited transaction rules of ERISA.

7. PLAN TERMINATION POLICY:

Although it has not expressed any intent to do so, the Plan sponsor has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. INCOME TAX STATUS:

The Plan has adopted the Principal Life Insurance Company (Principal) Pre-Approved Plan Document For Savings Plans. The Plan has placed reliance on the Principal IRS determination letter most recently obtained on June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax council believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
