#### ***Opinion on the 2024 Financial Statements***

We have audited the accompanying 2024 financial statements of Synopsis, Inc. Short Term Disability Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statement of net assets available for benefits and of the Plan's benefit obligations as of December 31, 2024, and the related statement of changes in net assets available for benefits and of changes in the Plan's benefit obligations for the year then ended, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of Synopsys, Inc. Short Term Disability Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a self-insured health and welfare established on January 1, 1998 and provides salary replacement payments to participants in the event of short-term disability to eligible employees of Synopsys, Inc. (the Company) (with at least 20 hours of service each week at a Company location outside of California but in the United States) and covered dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Participant contributions into the Plan are at the discretion of the Plan administrator and were 0.40% participants' annual earnings up to a maximum of \$168,600 and \$153,264 for the years ended December 31, 2024 and 2023, respectively.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

**Benefits**

The Plan provides income protection during short-term disabilities up to a duration of 180 days and paid family leave (PFL) benefits for up to 6 weeks to eligible members. Claimants were eligible to receive 75% of their weekly earnings with a maximum weekly benefit of \$3,000 and \$3,000 for the years ended December 31, 2024 and 2023, respectively.

**Self-Insured Benefits**

The Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor, The Larkin Company (Larkin). The claims processor pays claims directly to participants from plan assets. Despite the Plan's utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of Credit Risk**

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The plan management does not believe the Plan is exposed to any significant credit risk on cash.

**Administrative Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator and the independent auditor. These expenses are reported on the statements of changes in net assets available for benefits as Administrative Expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

**Payment of Benefits**

Claim payments are recorded when paid by the Plan. Amounts due to participants not yet paid by the claims processor are recorded as claims payable in the accompanying statements of benefit obligations.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 BENEFIT OBLIGATIONS**

The estimate amount for benefit obligations at December 31, 2024 and 2023 represents the present value of benefit obligations of all incurred disability claims, including claims incurred but not reported (paid). The amount of benefit obligation was determined by Larkin. Claims incurred but not reported were approximately \$91,000 and \$101,000 as of December 31, 2024 and 2023, respectively.

**NOTE 4 TAX STATUS**

The trust funding the Plan has not received an exemption letter from the Internal Revenue Service (IRS) stating that the trust is tax-exempt under Section 501(a) of the Code as a Voluntary Employee Beneficiary Association; therefore, the trust is a taxable trust. As an employee welfare benefit plan, the Plan and trust are required to operate in conformity with the Code and ERISA. The Plan administrator believes the Plan and the trust are operating in conformity with the Code and ERISA. Income tax obligations, if any, are paid by the Company and there were none for the years ended December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**NOTE 6 RISKS AND UNCERTAINTIES**

The liability for claims payable and claims incurred but not reported was estimated using plan provisions, the number of eligible participants, and the historical lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
