### 1. Description of the Plan

The following description of the Pettit Kohn Ingrassia Lutz & Dolin PC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan Administrator.

#### *General*

The Plan was established effective November 1, 2006 to enable eligible employees to make contributions to the Plan, thereby providing employees with an opportunity to accumulate funds for retirement. The Plan is a defined contribution plan established, sponsored and administered by Pettit Kohn Ingrassia Lutz & Dolin PC (the “Company” or “Plan Administrator”) for the benefit of substantially all employees of the Company. The Plan’s trustee, Matrix Trust Company (the “Trustee”), has the authority and responsibility for the management and investment of the Plan’s assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### *Eligibility*

The Plan covers substantially all employees of the Company, excluding leased employees, once they have attained 18 years of age and have completed three months of service. An employee’s entry date into the Plan will be the first day of the month coinciding with or next following the date he or she satisfies the eligibility requirements. Newly eligible employees are automatically enrolled at 6% of the employees’ compensation, unless the employee affirmatively elects otherwise.

#### *Contributions*

Participants may contribute 1% to 100% of their annual compensation as pre-tax or Roth contributions, as defined in the Plan, subject to an annual limitation imposed by Internal Revenue Service (“IRS”) regulations. Participants may also make rollover contributions into the Plan representing distributions from other tax-qualified employer-sponsored retirement plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Plan provides that the Company may elect to make matching contributions. For 2024, the Company elected to contribute 20% of the first 6% of base compensation that a participant contributed to the Plan. The Company may also elect to make discretionary profit sharing contributions each year. In order to share in the profit sharing contribution for a plan year, participants must be employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year. Contributions are subject to certain limitations. There were no discretionary contributions made by the Company for the year ended December 31, 2024.

### *Participant investment account options*

Participants direct the investment of all contributions into various investment options offered by the Plan. For participants who do not direct the investment of their contributions, accounts will be invested in accordance with default investment alternatives established under the Plan. The Plan currently offers several mutual funds, two common collective trust funds and an insurance investment contract as investment options for participants.

### *Allocations*

Each participant's account is credited with investment earnings and an allocation of certain Plan administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### *Vesting*

The portions of the participant's account attributable to elective deferral contributions, catch-up contributions and rollover contributions are 100% vested and non-forfeitable.

The portions of the participant's account attributable to matching contributions and profit sharing contributions are subject to the following vesting schedule:

To earn a year of service, participants complete at least 1,000 hours of service during a plan year. Participants are 100% vested upon retirement, death, disability or termination of the Plan.

### *Forfeitures*

Non-vested amounts forfeited by terminated participants may be used to pay Plan administrative expenses or applied to reduce the Company's contributions. In 2024, forfeited funds of \$17,226 were used to pay administrative expenses of the Plan. At December 31, 2024 and 2023, there were \$5,305 and \$3,121 non-vested forfeited accounts, respectively.

### *Notes receivable from participants*

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with the rate charged by other lenders for notes made under similar circumstances.

### *Notes receivable from participants, cont'd*

Note repayment periods may not exceed five years except for notes used to acquire a principal residence. Principal and interest are paid through payroll deductions. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

### *Benefit payments*

Upon termination of service due to death, disability or retirement, a participant may elect to receive a single lump-sum payment equal to the value of participant's vested interest in his or her account if the participant's account does not exceed \$5,000. If a terminated participant's vested interest in his or her account exceeds \$5,000, a participant may elect to receive a single lump-sum payment or installments over a period of time of not more than his or her life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may withdraw any or all of their elective deferral account balances at any time during the Plan year upon attainment of age 59 ½ or upon incurring a financial hardship, as defined in the Plan document, if certain have been met. Benefits are recorded when paid.

### *Administrative expenses*

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### *Plan termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, the Plan document provides that participants would become fully vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### *Basis of accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### *Use of estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of income and expenses during the reporting period. Actual results could differ from estimates.

#### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### **3. Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### *Investment valuation and earnings*

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consisted of the realized gains or losses on sales of investments and the unrealized appreciation or depreciation of those investments.

### 4. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 5. Tax Status

The IRS has determined that the Prototype Non-Standardized 401(k) Profit Sharing Plan, sponsored by OneAmerica Financial Partners, Inc., is designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and informed the Trustee of such in a letter dated August 19, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### 5. Tax Status, Cont'd

GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The tax positions taken by the Plan have been analyzed and, as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 6. Party-In-Interest Transactions

Certain assets in the Plan are invested in Trustee accounts. Certain officers of the Company are current participants in the Plan. The Plan has notes receivable from certain of its participants. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

#### 7. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with American United Life ("AUL") Insurance Company. AUL Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on an annual basis for resetting. The contract does not have a maturity date. However, the issuer may terminate the contract without the application of any otherwise required market value adjustment or contract liquidation charge.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for the guaranteed investment contract. Contract value, as reported to the Plan by AUL Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

### **8. Risks, Uncertainties and Concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 22% and 21% of the Plan's investments were invested in TIAA-CREF Lifecycle Index 2030 Retirement Class Fund, respectively.

### **9. Reconciliation of Financial Statements to Schedule H of Form 5500**

Net assets available for benefits at December 2024 and 2023 and the net increase in net assets available for benefits for the year ended December 31, 2024, as reported in the accompanying financial statements, are consistent with amounts reported in Schedule H of the Form 5500.

### **10. Subsequent Events**

Effective July 25, 2025, the Plan changed its trustee and custodian to Fidelity Management Trust Company and changed its recordkeeper to Fidelity Workplace Services LLC.

The Plan has evaluated subsequent events through September 16, 2025, which is the date the financial statements were available to be issued. No other significant matters were identified for disclosure during this evaluation.
