INDEPENDENT AUDITORS' REPORT

To the Retirement Committee and Management
MeatEater, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MeatEater, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements ("Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of MeatEater, Inc. 401(K) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

1. Description of the Plan

The following descriptions of the MeatEater, Inc., (“the Company”) 401(K) Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan was established on January 1, 2018 to comply with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a defined contribution plan covering all eligible employees of MeatEater, Inc., MCL, LLC, MeatEater Retail, LLC, First Lite, LLC, FHF Gear, Inc., MeatEater Holding Company, LLC, and Cochran and Smith Guide Service, LLC. Plan participants’ accounts are administered and managed by Ascensus Trust Company, (“Trustee”). Recordkeeping services are performed by Ascensus through an agreement with The Vanguard Group, Inc (“Vanguard”). As an authorized representative of the Trustee, Ascensus, LLC receives contributions and executes transactions under the direction of MeatEater, Inc., the Plan Sponsor. The Retirement Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investments offerings and monitors investment performance. The Plan is a single employer plan.

Eligibility

Employees are eligible to participate in salary deferral contributions and the safe harbor match upon hiring. The employee must have attained the age of 21 and entry into the Plan is on a monthly basis. Union employees are excluded from the Plan.

Contributions

Each year, participants in the Plan are allowed to contribute a specific percentage or dollar amount of pretax annual compensation. Participants who are 50 years of age or older at the end of the plan year are eligible to make catch-up contributions. Participants may also contribute distributions from other qualified defined benefit or defined contribution plans rollover. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may elect Roth 401(K) deferrals. These deferrals are subject to federal income taxes in the year of deferral.

Participant contributions qualify for Company ADP safe harbor matching contributions equal to a specified percentage of the amount of the salary reduction participants have deferred. The Company matches the employee contribution equal to 100% of salary deferrals that do not exceed 4% of the participant’s compensation. For the years ended December 31, 2024 and 2023, the Company made ADP safe harbor matching contributions of \$387,763 and \$466,341 to the Plan, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Contributions (continued)

The Company may also elect to make an ACP safe harbor contribution to the Plan. The participant must be actively employed on the last day of the Plan year. The Company did not make any ACP safe harbor contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of (a) the Company's contributions, (b) account earnings or losses, and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the participant's vested account balance.

Investment Options

Participants may direct contributions, including Company matching and retirement account contributions, in whole percentage increments to any of the investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions and the Company's ADP safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's ACP safe harbor contributions, and earnings thereon, is based on years of service beginning on the participant's first day of employment. Participants vest in the Company's ACP safe harbor contributions based on the following schedule:

Payment of Benefits

The Plan is designed to provide benefits at the time of retirement. However, if employment is terminated because of death, disability or retirement, the participant may elect to receive a lump-sum amount equal to the vested value of the participant's account, may transfer the vested value of their account to another retirement investment vehicle, or may choose to leave the vested value of their account in the Plan until April 1 of the year succeeding the year in which age 70 ½ is attained, subject to the mandatory cash out provisions.

The Plan also allows for in-service distributions upon reaching age 59 ½. Hardship distributions are available to participants. Terminated participants with vested account balances less than \$5,000 are subject to the mandatory cash out provisions. Participants with account balances exceeding \$1,000, but less than \$5,000 will have their distributions rolled to an IRA in their name absent an election to take a lump sum distribution or roll to another plan or IRA.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to the maximum amount of the lesser of 50 percent of the participant's vested account balance or \$50,000, reduced by the highest outstanding loan balance in his or her account balance during the prior 12-month period. Any loan will require that repayment be amortized in level payments, not less frequently than quarterly, over a period not extending beyond five years from the date of the loan, unless such loan is used to acquire a dwelling unit which, within a reasonable time, will be used as the principal residence of the participant. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the current month's prime rate plus one percentage point. Principal and interest are paid ratably through payroll deductions.

Benefit Obligations

As of December 31, 2024 and 2023, no benefit obligations existed for individuals who withdrew from the Plan.

2. Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America. Investment contracts held by the Plan are required to be reported at fair value. Participant loans are valued at amortized cost, which represents fair value.

Administrative Expenses

Certain expenses incurred by the Plan, not including those expenses covered by the participants, are paid by the Plan Sponsor. For the years ending December 31, 2024 and 2023, \$4,889 and \$1,760 was paid by the Plan, respectively.

2. Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments. Shares of mutual funds are valued daily at the net asset value of shares held by the plan. The Retirement committee determines the Plan's valuation policies. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

3. Tax Status

The IRS has determined and informed the company by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan administrator is of the opinion that the Plan continues to fulfill the requirements of a qualified plan under Section 401(a) of the Internal Revenue Code and that the Plan is not subject to tax. Accordingly, no provision for federal or state income taxes has been provided.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

4. Fair Value Measurements (continued)

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued and reported at fair value using the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan's investment in the Stable Value Fund, holds investment contracts that are deemed to be fully benefit responsive investment contracts ("FBRIC"), however, this is considered to be an indirect FBRIC investment and it is reflected at NAV as a practical expedient which is considered fair value. The NAV is equal to contract value of the underlying investment and is equal to the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals or transfers. The Stable Value Fund is not available for sale or transfer on any securities exchange. The contract value is a relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Stable Value Fund's one-year total return was 2.92% for 2024 and 2.86% for 2023. The thirty-day effective yield, also known as the crediting interest rate, was 2.82% and 2.73% for the Stable Value Fund at December 31, 2024 and 2023, respectively. The one-year total return and the thirty-day effective yield are net of the annual investment management fee of 0.51% and 0.58% for the Stable Value Fund in 2024 and 2023, respectively. The crediting interest rate is calculated on a daily basis. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The existence of certain conditions can limit the Stable Value Fund's ability to transact at contract value. Specifically, any event outside the normal operation of the Stable Value Fund that causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, partial or complete legal termination of the Stable Value Fund or a unitholder, tax disqualification of the Stable Value Fund or a unitholder, and certain Stable Value Fund amendments if issuers' consent is not obtained. As of December 31, 2024 and 2023, the occurrence of an event outside the normal operation of the Stable Value Fund that would cause a withdrawal from an investment contract is not considered to be probable. To the extent a unitholder suffers a tax disqualification or legal termination event, under normal circumstances it is anticipated that liquid assets would be available to satisfy the redemption of such unitholder's interest in the Stable Value Fund without the need to access investment contracts.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974.

6. Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplementary schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustee, Ascensus, LLC, which holds the assets of the Plan.

7. Related-Party Transactions

Certain Plan assets are shares of mutual funds managed by Vanguard. Fees incurred and paid by the Plan for the administration services provided by Vanguard were \$4,889 and \$1,760 for the years ended December 31, 2024 and 2023, respectively. Ascensus, LLC is the Plan's custodian and their investment management service fees incurred by the Plan are included in net appreciation in the fair value of the investment.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
