### Note 1—Description of the Plan

The following description of Design Communications, Ltd. 401(k) Plan (the "Plan") provides only general information. A more complete description of the Plan's provisions is in the Plan document.

*General* – The Plan is a qualified defined contribution plan with a cash deferral arrangement covering all eligible employees ("participants") of Design Communications, Ltd. (the "Company" or "Plan Sponsor"). The Plan was established on January 1, 1991 and is administered on the basis of the Plan year, which is the twelve month period commencing each January 1 and ending on December 31. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants are offered a selection of investments for the placement of their contributions ("participant-directed funds"). The determination of the participant-directed funds made available to participants is made by the Plan administrator.

In October 2024, the Plan was retroactively amended to allow participants to elect a 30 year loan repayment period for a principal residence. The amendment was effective as of January 1, 2023.

*Eligibility* – Employees of the Company, as defined in the Plan, are eligible to participate in the Plan upon attaining age 21 and thirty days of service. Participants may begin salary deferrals the first day of the month following the date they satisfy the eligibility requirements. Participants are eligible for discretionary employer matching contributions after completing 1,000 hours of service during the Plan year and is employed on the last day of the Plan year. Participants are eligible for profit sharing contributions after completing one year of service with at least 1,000 hours of service and is employed on the last day of the Plan year.

*Contributions* – Participants may elect to defer up to one hundred percent of their annual compensation as defined in the Plan, subject to maximum limits set by the Internal Revenue Code ("IRC"). Participants that have met requirements of age 50 may elect to defer additional amounts as catch-up contributions, subject to limits set by the IRC. Participants may also elect to defer a percentage of their after-tax compensation designated as Roth contributions, subject to maximum limits set by the IRC. Participants can make in-plan Roth conversions from all available contribution sources. Participants may also contribute distributions from other qualified retirement plans ("rollovers"). Participants are automatically enrolled in the Plan with a 4% contribution unless elected otherwise.

The Company may make discretionary matching contributions and profit sharing contributions based upon a percentage of the participant's eligible compensation determined by the Company annually. For the year ended December 31, 2024, the Company made a discretionary matching contribution to the Plan of \$150,000.

*Vesting* – Participants are fully vested in their own contributions and related earnings. Vesting of Company matching and profit sharing contributions, and related earnings, is achieved through a four year graded vesting schedule based on continuous service. Notwithstanding the foregoing, a participant shall be 100% vested in and have a non-forfeitable right to his or her account upon death, disability, termination of the Plan or the attainment of normal retirement age.

### Note 1—Description of the Plan (continued)

*Forfeitures* – Contributions made by the Company which are not vested at the time employees cease to be participants in the Plan shall be used to reduce Company contributions or pay Plan expenses. As of December 31, 2024 and 2023, there was \$1,222 and \$3,006 in unallocated forfeitures, respectively. Forfeitures used to pay administrative expenses and reduce Company contributions totaled \$5,653 for the year ended December 31, 2024.

*Notes Receivable from Participants* – Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account subject to certain IRC limitations. Participants may only have one loan outstanding at any given time. Note terms range from one to five years, unless the loan is for a principal residence which term cannot exceed 30 years and are secured by the remaining vested balance in the participant's account. The notes bear interest at a rate commensurate with local prevailing rates as determined by the Plan Sponsor. Principal and interest are repaid through after-tax payroll deductions on a bi-weekly basis. Interest ranges from 4.25% to 9.50% and maturing through February 2053.

*Plan Administration* – The Company is the Plan administrator and has the authority to appoint persons or entities to carry out the operations of the Plan. Empower Trust Company, LLC is the Plan's custodian and provides recordkeeping services for the Plan under Empower Retirement Brand. HUB Retirement & Wealth Management provides financial advising and other Plan administrative services for the Plan. Global Retirement Partners, LLC provides investment advisor services to the Plan.

*Payment of Benefits* – Upon termination of service, retirement, or disability, a participant may elect to receive either a single lump sum amount or substantially equal installments. The Plan also allows for hardship withdrawals and in-service withdrawals of all or a portion of a participant's account upon the participant reaching age 59 ½ or normal retirement age, becomes disabled, when on active military duty and qualified distribution for birth or adoption of a child of up to \$5,000.

*Participant Accounts* – Each participant's account is credited with the participant's contributions, the Company's discretionary match and profit sharing contributions, and an allocation of Plan net investment earnings. Participant accounts are charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant compensation or account balances, or specific participant transactions as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

*Plan Termination* – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participant's accrued benefits become fully vested and non-forfeitable.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Such estimates relate primarily to unsettled transactions and events as the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

### Note 2—Summary of significant accounting policies (continued)

*Investment Valuation And Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*Benefits Paid* – Benefit payments are recorded when paid.

*Administrative Expenses* – Certain administrative expenses incurred in maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses, recordkeeping, financial advising and other Plan administrative expenses are paid by the Plan and are recorded in the net appreciation in fair value of investments and in administrative expenses.

The Plan receives a revenue share from its third-party administrator. Revenue share funds received are reported as other income in the statement of changes in net assets available for benefits which are used to pay Plan expenses. There were no unallocated revenue share funds as of December 31, 2024 and 2023. During 2024, revenue share credits of \$5,195 were used to pay Plan expenses.

### Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company (the "qualified institution"), has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the certified information, except for comparing such information with the related information in the financial statements and supplemental schedule.

**Note 4—Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted market prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

*Level 3* – Inputs that are unobservable inputs for the asset or liability

The following are descriptions of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Common Collective Trust Fund* – The stable value common collective trust fund is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of the units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. The net asset value is typically based on the fair value of the underlying investments held by the fund.

**Note 5—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

#### **Note 6—Related party and exempt party-in-interest transactions**

Certain employees and officers of the Company, who may also be participants in the Plan, perform administrative services at no cost to the Plan. Notes receivable from participants are included in the statement of net assets available for benefits and interest income related to notes receivable from participants is included in the statement of changes in net assets available for benefits. Certain administrative expenses incurred in maintaining the Plan are paid directly by the Company and excluded from these financial statements.

#### **Note 7—Tax status**

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **Note 8—Delinquent contributions**

As required by ERISA Section 2510.3-102, the Company is required to segregate and remit employee contributions to the Plan from its general assets as soon as the funds can be reasonably segregated. For the year ended December 31, 2022, there was a pay period in which contributions were not remitted on a timely basis. Contributions for this pay period are considered a prohibited transaction. During 2024, the Company corrected and funded the Plan for remaining late contributions and related lost earnings from the 2022 delay in remitting.

#### **Note 9—Subsequent events**

The Plan has evaluated all subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined that no additional subsequent events had occurred that would require recognition or disclosure in these financial statements.
