Value Drug, Ltd. dba Pharmacare 401(k) Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A – DESCRIPTION OF PLAN

The Value Drug, Ltd. dba Pharmacare 401(k) Profit Sharing Plan (Plan) became effective on August 1, 1988. The following is a description of the Plan, which provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions. The Plan was amended and restated effective January 1, 2022.

General

The Plan is a profit sharing and salary deferral plan, also known as a 401(k) plan, covering substantially all employees of Value Drug, Ltd. dba Pharmacare (Company) who have worked 1,000 hours or more in a 12-month period (year of service), are at least 21 years old, and are not part of a collective bargaining agreement. Employees who work at least 20 hours per week are also eligible to make employee salary deferrals and participate in the elective employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was amended to adopt certain interim provisions relating to the SECURE Act of 2019 and the CARES Act, and for certain interim provisions relating to the SECURE 2.0 Act of 2022.

Contributions

The Plan follows Internal Revenue Service (IRS) guidelines which allow participants to make employee salary deferral contributions to the Plan up to the lesser of their eligible compensation or \$23,000 and \$22,500 in 2024 and 2023, respectively, adjusted annually for the cost of living. Participants who have attained the age of 50 may make additional annual contributions of \$7,500 in 2024 and 2023. Each year, the Company makes safe harbor nonelective employer contributions on behalf of each eligible participant, as defined in the plan agreement, in an amount equal to 3% of the participant's compensation earned during the plan year while an active participant. The Company may also elect on a year-to-year basis to make a discretionary employer contribution and a discretionary matching contribution as determined by the Board of Directors. To be eligible for the discretionary employer contribution, a participant must have completed 1,000 hours of service during the plan year and be an employee on the last day of the plan year. Employees may make rollover and transfer contributions. The Company did not make employer discretionary and matching contributions in the years ended December 31, 2024 and 2023. Total contributions to each participant's account may not exceed the lesser of \$69,000 (\$76,500 with catch-up contribution) in 2024 and \$66,000 (\$73,500 with catch-up contributions) in 2023, or 100% of compensation, as defined.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor contribution, and the Company's discretionary matching contribution, plus an allocation based on participant earnings or account balances of the Company's discretionary employer contribution, and the Plan's net earnings; less an allocation of the Plan's administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are 20% vested in discretionary employer and discretionary matching contributions after two years of service and an additional 20% per year, for each year with at least 1,000 hours of service, until 100% vested after six years of vesting service. Participant voluntary, rollover, Roth, and Company safe harbor nonelective employer contributions and earnings thereon are always 100% vested.

Payment of Benefits

The vested amount in each participant's account is payable upon normal retirement, disability, death, or termination of employment. Participants receive the entire value of their accounts in a single lump-sum payment. Effective November 1, 2019, participant account balances less than or equal to \$5,000 (\$7,000 effective January 1, 2024) will be rolled over to an individual retirement account unless elected to be received as a lump-sum payment.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of the vested portion of their account balance. The minimum notes receivable amount is \$1,000. The maximum number of loans a participant may have at any one time is two. The notes receivable, including interest, must be repaid within five years unless the notes are used to acquire a principal residence in which case the maximum term of the loan is 15 years. The notes are collateralized by the participants' account balances and bear interest at prevailing rates. Interest rates ranged from 4.25% to 9.50% at December 31, 2024 and 2023. The notes mature at various dates through September 2029. Loan payments are made through payroll for each pay period.

Withdrawals

Active participants may withdraw all or a portion of their vested account balances as in-service distributions after attaining age 60, or as hardship withdrawals, by submitting a written application that is approved by the plan administrator. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS.

Forfeitures

Termination of employment for reasons other than retirement, disability, or death results in a forfeiture of the nonvested portion of the participant's account balance. Forfeitures may be applied to administrative expenses of the Plan and any remaining amounts applied to reduce employer contributions. There were no forfeitures to be applied at December 31, 2024 and 2023, and no forfeitures were used for administrative expenses and employer contributions during the years ended December 31, 2024 and 2023.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonably possible that such estimates may change within the near term, and such differences could be material to the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net earnings on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note D for discussion of fair value measurements.

Employer Contributions Receivable

Contributions receivable are recognized for amounts due from the employer that were remitted to the Plan after year-end. Contributions from the participants and the employer are recorded in the year in which the employee contributions are withheld from compensation. The receivables are typically short term in nature and are expected to be collected in full.

Management has evaluated the collectability of employer contributions receivable in accordance with Accounting Standards Update No. 2016-13, *Financial Instruments – Credit Losses (Topic 326)*, and determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023. The Plan considers the Company's historical payment experience, current and future financial condition, and the legally binding nature of the contribution obligation in making this assessment.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Expenses are recognized when the related liability is incurred. Investment related expenses are included in net appreciation in fair value of registered investments companies.

NOTE C – CERTIFICATION BY QUALIFIED INSTITUTION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, dividends, and other income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, the qualified institution of the Plan as of December 31, 2024 and 2023 and for the years then ended.

NOTE D – FAIR VALUE MEASUREMENTS

U.S. GAAP provides a hierarchy that prioritizes the inputs to the valuation methodologies used to measure fair value. There are three levels of the fair value hierarchy. Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs are unobservable and significant to the fair value measurement. The fair value measurement level of an asset or liability within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation methodologies used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in registered investment companies are valued using quoted market prices, which is a Level 1 input. There were no investments valued using Level 2 or Level 3 inputs. The valuation methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

NOTE E – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan’s assets are administered by and in the custody of John Hancock Retirement Plan Services, the recordkeeper of the Plan for the years ended December 31, 2024 and 2023. Therefore, these transactions qualify as party in interest transactions. The determination of the amount, timing, and type of employer contributions made to the trust fund is made by the plan sponsor, who also determines the amount and method of benefits paid to participants from the trust fund. Certain administrative functions are performed by officers or employees of the Company, who receive no compensation from the Plan. Other administrative expenses are paid either by the Plan or by the Company, as provided in the Plan document. Expenses that are paid by the Company are not included in these financial statements.

NOTE F – TAX STATUS

The plan sponsor adopted a pre-approved plan, which received a favorable IRS Opinion Letter dated June 30, 2020 because the Plan met the qualification requirements established by Section 401(a) of the Internal Revenue Code. The Plan has been amended since the favorable IRS Opinion Letter. The plan administrator is aware of certain operational errors that, if not properly corrected, could affect the tax qualified status of the Plan and the related custodial accounts. The plan administrator believes that the Plan is eligible to self-correct and is in the process of correcting those errors in a timely manner. Accordingly, the Plan believes it will maintain its tax-qualified status and the related accounts are tax exempt.

**NOTE F – TAX STATUS (Continued)**

U.S. GAAP requires uncertain tax positions to be recognized in the financial statements if they are more likely than not to fail upon regulatory examination. The plan administrator evaluated the Plan's tax positions as of December 31, 2024 and 2023 and for the years then ended and determined that the Plan had no uncertain tax positions required to be reported. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any open tax periods.

**NOTE G – TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants become 100% vested in their accounts.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan and Company operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan were to account for future losses or asset impairments, as the effect on the financial statements of the Plan from such changes in economic conditions are not presently determinable.

**NOTE I – SUBSEQUENT EVENTS**

The plan administrator has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued, and determined that the Plan did not have any subsequent events requiring adjustment to the financial statements or disclosure in the notes to the financial statements.
