Opinion

We have audited the accompanying financial statements of Intermountain Claims, Inc. Employee Saving Trust Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



NOTE 1 - Description of Plan

The following description of the Intermountain Claims, Inc. Employees Saving Trust ("the Plan") is provided for general information purposes only. The Plan was renewed effective July 7, 2014. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan Administrator is responsible for oversight of the Plan. The Board determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan uses Principal Trust Company (Principal) an American Funds Services Company (AFS) "Custodian" to serve as custodian and to provide records keeping services for the Plan.

Eligibility and Contributions - The Plan provided for the Intermountain Claims, Inc. ("Sponsor") to contribute or not contribute a matching contribution to the Plan in an amount which is decided by the Board each Plan Year for all eligible employees who have completed at least six months of service and attained age 21. During the 2024 and 2023 year, the matching contribution was 4%.

Each year, participants may contribute up to 85% of pretax annual compensation, as defined in the Plan up to the IRS maximum deferral limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Trustee and Investment Manager - Ronda Robbins, Craig Stone, and Cindy Weigel serve as trustees.

Participant Loans - Participant loans are not permitted under the current Plan.

Investments - Participants direct the investment of their account balances to any one or more of the funds offered by the plan.

Payment of Benefits - Upon termination of service due to death, disability, or retirement, a participant may elect either to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or an installment distribution solely to the extent necessary to satisfy the required minimum distribution rules.

Participant Accounts - Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution and allocations of Company discretionary contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting - Participant account balances are fully vested and nonforfeitable for the portion attributable to employee and the employer discretionary non-matching and matching contributions.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

NOTE 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared using the contract value basis for fully benefit-responsive investment contracts

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Administrative and Participant Loan Administration - Administrative expenses of the Plan are paid by the Sponsor.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were \$0, and \$0 excess contribution for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Sponsor are excluded from these financial statements. Fees related to the administration of the plan are included in administrative expenses. Investment related expenses including transactions fees are included in net appreciation of fair value of investments.

NOTE 3 - Federal Income Tax Status

The plan received a determination letter dated July 7, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not been amended since the latest determination letter. The plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statement.

NOTE 4 - Tax Status and Open Tax Years

Intermountain Claims - Employee Savings Trust is an defined contribution Plan (Plan) which is not subject to income taxes.

The Plan adopted ASC Topic 740-10, Accounting for Uncertainty in Income Taxes, which prescribe a recognition threshold and measurement attribute for financial statement recognition and measurement of a tax position taken in a tax return. For those benefits to be recognized, a tax position must-be-more-likely-than-not to be sustained upon examination by taxing authorities. For the years ended December 31, 2024 and 2023, the Plan had no material uncertain tax positions to be accounted for in the financial statements under the rules. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits in interest expense.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - Related-Party Transactions and Party in Interest Transactions

Plan investments are managed by Principal as the asset custodian and record-keeper for the Plan. These services qualify Principal as party in interest. Principal also provided a guaranteed investment contract that is considered a related party transaction. Other parties in interest would be Deaton & Company, as they audit the financial statements and Pension Plan Specialists, PC as they are consultants for the Plan.

NOTE 6 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at year end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment contract: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchased and sales) may occur daily. Where the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. As the NAV is available to current investors and is the basis for current transactions, the collective trust funds are reported as a level 1 input.

NOTE 7 - Guaranteed Investment Contract With Principal Company

Guaranteed investment contract balances totaled \$386,344, for 2024 and \$352,099 for 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer. The credit rate is reviewed on a quarterly basis for setting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The average yields earned by the guaranteed investment contract as of December 31, 2024, were 4.65% (first and second quarter), and 5.05% (third and fourth quarter), and 4.05% (first and second quarter) and 4.35% (third and fourth quarter) for December 31, 2023.

NOTE 8 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - Rollover Contributions

An aggregate of \$16,346 and \$287,190 was rolled into the Plan during the years ended December 31, 2024 and December 31, 2023, respectively, and is included in rollovers on the statement of changes in net assets available for benefits.

NOTE 10 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants are fully vested in both employer and employee contributions.

NOTE 11 - Subsequent Events

The Plan has evaluated subsequent events up to October 13, 2025, the date the financial statements were available to be issued.

NOTE 12 - Reconciliation of Financial Statements to form 5500

The plan had no reconciliation differences between the plan and the form 5500 for the years ended 2024 and 2023.
