1. DESCRIPTION OF THE PLAN

The following description of The Allied Systems Company (“the Company”) 401(k) Cash or Deferred Savings Plan (“the Plan”) provides only general information. Reference should be made to the Plan document for a more complete description of its provisions.

GENERAL. The Plan is a defined contribution 401(k) plan, covering principally all employees of The Allied Systems Company starting on the first of the month following the employee's date of hire. The Plan’s Administrator controls and manages the operation and administration of the Plan. Empower Trust Company, LLC serves as the trustee, custodian and agent of the Plan with Prime Pensions Northwest acting as third party administrator. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS. Contributions to the Plan are in the form of pretax or after-tax salary reductions, which participants have elected to defer in lieu of current compensation, and discretionary employer matching contributions. The Company has the discretion to establish the rate of matching contributions and to determine the amount of participant's compensation upon which the determined rate of match will be based up to and not to exceed 6%. The Company may make contributions to non-highly compensated employees in order to meet discrimination test requirements. For the years ended December 31, 2024 and 2023, the Company has elected to make discretionary matching contributions of \$222,070 and \$160,682, respectively.

PARTICIPANT ACCOUNTS. Each participant’s account is credited with an allocation of (a) employee elective deferrals, (b) employer's contributions, (c) Plan earnings, and (d) administrative expenses paid by the plan. Item (a) is allocated based on participants' elective contributions. Items (b), (c), and (d) are allocated based on participants' elective deferrals, annual compensation, or account balances, as defined and specified in the Plan agreement. The benefit to which a participant is entitled is based on the benefit that can be provided from the participant's vested account.

INVESTMENT OPTIONS. Upon enrollment, a participant may direct contributions to certain investment accounts selected by the Trustee and Administrator. Participants may change their investment options daily.

VESTING. Participants are fully vested in their rollover and elective contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested in employer matching contributions after six years of credited service, and also upon death, disability or upon reaching normal retirement age.

NOTES RECEIVABLE FROM PARTICIPANTS. Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to certain restrictions. As these loans are repaid by the participant, the proceeds, including interest, are returned to the participant’s account. Loans are repayable through payroll deductions. The loans are secured by the remaining balance in the participant’s account and bear interest at 1% above the prime rate at the time of the loan's interception with the interest rate being fixed over the life of the loan.

PAYMENT OF BENEFITS. On termination of service, a participant may elect to receive a lump sum amount equal to the participant's vested account balance or a direct rollover. Partial and installment withdrawals are only allowed for participants who are required to receive annual minimum distributions due to their age and are terminated or are a greater than 5% owner.

HARDSHIP WITHDRAWALS. Pre-retirement distributions of elective deferrals are available on a hardship basis. These distributions are limited to the specific financial need. They must be approved by the trustee and custodian on a nondiscriminatory basis.

1. DESCRIPTION OF THE PLAN - Continued

FORFEITED ACCOUNTS. Forfeited accounts may be used to pay Plan administration expenses or to reduce amounts otherwise required to be contributed to the Plan. Forfeited accounts amounted to \$15,961 and \$4,079 at December 31, 2024 and 2023, respectively and are held in the Vanguard Federal Money Market Fund.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan employs accounting policies generally accepted in the United States of America. The Financial Accounting Standards Board ("FASB") has issued guidance which establishes the FASB Accounting Standards Codification (the "Codification" or "FASB ASC") as the source of authoritative accounting principles recognized by the FASB to be applied to nongovernmental entities in the preparation of financial statements in conformity with accounting principles generally accepted in the United States of America.

BASIS OF ACCOUNTING. The accompanying financial statements have been prepared on the accrual basis of accounting.

USE OF ESTIMATES. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

VALUATION OF INVESTMENTS - MONEY MARKET FUNDS. Money market funds are valued at cost which approximates market.

VALUATION OF INVESTMENTS - MUTUAL FUNDS. Investments in mutual funds are carried at fair value, which is the net asset value per unit of each mutual fund multiplied by the number of units owned. The value of each unit is computed by the mutual fund company on the last business day of the plan year, based on quoted market prices of the underlying securities, bonds and other financial instruments owned by each fund.

NOTES RECEIVABLE FROM PARTICIPANTS. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan documents.

PAYMENT OF BENEFITS. Benefits are recorded when paid.

EXPENSES. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

RISKS AND UNCERTAINTIES. The Plan provides for investment options in money market and mutual funds. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

From time to time, investments may include securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan has implemented the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC 740, *Income Taxes*. Using that guidance, the Plan does not believe it has any uncertain tax positions that qualify for either recognition or disclosure in the financial statements as of December 31, 2024 and 2023.

SUBSEQUENT EVENTS. The Plan has evaluated subsequent events through October 10, 2025, the date that the financial statements were available for issue.

3. FAIR VALUE MEASUREMENTS AND DISCLOSURES

FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 for financial assets and financial liabilities are described below:

Level 1	Values are based on quoted prices in active markets for identical assets or liabilities.
Level 2	Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

Prices and inputs are used that are current as of the measurement date, including during periods of market disruption. In periods of market disruption, the ability to observe prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become fully vested in all their accounts.
