Independent Auditor's Report

To the Plan Trustees  
Técnico Corporation 401(k) Plan:

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Técnico Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Técnico Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan

The following description of the Técnico Corporation 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan covering all eligible employees of Técnico Corporation and participating companies (“Company”). The Plan is subject to the provisions of ERISA. The Plan trustees are responsible for oversight of the Plan. The 401(k) Administrative Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

*Contributions:* Each year, participants may contribute up to the maximum allowed by of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at six percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Plan also includes an automatic increase provision whereby a participant’s deferral rate is increased by one percent each year subject to certain conditions. The Company makes a prevailing wage contribution for employees who perform services subject to the Service Contract Act, Davis-Bacon Act or similar Federal, State, or Municipal Prevailing Wage statutes. Prevailing wage contributions are not subject to age or service requirements. The Company may make matching contributions to eligible participants. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

*Participant accounts:* Each participant's account is credited with the participant’s contributions and Company prevailing wage and matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting:* Participants are vested immediately in their contributions and Company prevailing wage contributions, plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

*Notes receivable from participants:* Participants may not borrow from their fund accounts however; the Plan accepted the transfer of notes receivable from the PCE 401(k) Plan that were issued prior to the merger into this Plan. The loans are secured by the balance in the participant’s account. The loan interest rate is set by the Plan administrator at a reasonable rate of interest, which is comparable to the rates being charged by lending institutions in the

same geographic locale. Principal and interest is paid ratably through payroll deductions.

*Payment of benefits:* On termination of service, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments over a period not to exceed life expectancy, or a partial withdrawal no less than \$1,000. In-service withdrawals are permitted for participants who have attained age 59 1/2 or for a qualified financial hardship.

*Forfeited accounts:* As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,808 and \$15,067, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. In 2024, \$14,144 from forfeited nonvested accounts was used to pay Plan administrative expenses.

## **2. Summary of Accounting Policies**

*Basis of accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment valuation and income recognition:* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and Empower Trust Company, LLC ("Empower Trust"). See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Contributions:* Contributions from Plan participants and the Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

*Notes receivable from participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Payment of benefits:* Benefits are recorded when paid.

*Expenses:* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping and benefits paid are charged directly to the participant's account and are included in administrative expenses. Fees paid directly by the Plan for investment advisory services are included in investment expenses. Investment related expenses paid indirectly through revenue sharing arrangements are included in net appreciation of fair value of investments.

*Subsequent events:* The Plan has evaluated subsequent events through October 11, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate account:* Valued by Empower Annuity Insurance Company of America (“EAICA”), the sponsor of the pooled separate account, at net asset value (“NAV”). The NAV is based on the fair value of the underlying investments held by each account less its liabilities. The NAV is published daily and available to plan participants and is the basis for current transactions. EAICA reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Collective trusts:* Valued at the net asset value (“NAV”) of the units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the trust will sell the underlying investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the trust’s investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **4. Related Party Transactions and Party in Interest Transactions**

Certain investments are sponsored by EAICA, the parent company of Empower Trust. EAICA is the recordkeeper for the Plan and Empower Trust is the custodian for the Plan. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity. These transactions qualify as exempt party in interest transactions.

EAICA provides a revenue credit to participants based on the fees received from certain investment funds which is allocated monthly to the Plan participants invested in the Fund. The revenue credit for the year ended December 31, 2024 was \$6,986. The credit is netted with administrative expenses in the statement of changes in net assets available for benefits.

#### **5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer matching contributions.

#### **6. Tax Status**

The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan has been amended since receiving the opinion letter, the Plan administrator and the pre-approved plan sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

## 8. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust.

## 9. Transfer from Técnico Corporation Employee Stock Ownership Plan

The Plan permits plan-to-plan transfers from other qualified plans subject to certain requirements. The Plan accepts transfers from Técnico Corporation Employee Stock Ownership Plan representing diversification and stock conversion payments issued to active employees of the Company.

## 11. Nonexempt Transactions

Title I of ERISA requires that all employee contributions be remitted to the Plan as soon as administratively possible but no later than the 15th business day of the month following the month of being withheld from compensation. Failure to remit employee contributions to the Plan on a timely basis is considered a nonexempt prohibited transaction with a party-in-

interest. Participant contributions and loan repayments of \$39,768 were withheld from participants' pay during 2022 but were not remitted to the Plan's trust within the time frame required by the Department of Labor. The contributions and loan repayments were remitted to the Plan. Lost earnings were corrected through procedures prescribed by the Department of Labor during 2024.

## **12. Operational Errors**

Vesting for certain employees was incorrectly calculated, resulting in incorrect benefit payments to participants for distributions during 2022 and 2024. In addition, certain employees were not timely auto enrolled in the Plan during 2022, 2023, and 2024. In 2024, the Company discovered that certain plan compensation was erroneously included in Plan compensation used to calculate employee Roth contributions. The Plan Sponsor has not finalized the employer contributions required to correct participant accounts. Plan management does not believe additional contributions will be material to the Plan's net assets available for benefits.
