INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Urban Manufacturing Co., Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Urban Manufacturing Co., Inc. 401(k) Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Nationwide Trust Company, FSB and Nationwide Life Insurance Company as of and for the year ended December 31, 2024 and for the period from September 22, 2023 to December 31, 2023, and John Hancock Life Insurance Company (U.S.A.) for the period from January 1, 2024 to September 20, 2024 and as of and for the year ended December 31, 2023 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section,

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Urban Manufacturing Co., Inc. 401(k) Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through August 21, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Urban Manufacturing Co., Inc. is the plan sponsor, employer and the plan administrator. Oliver Manufacturing, Inc. is a participating employer. John Hancock Life Insurance Company (U.S.A.) was the investment agent that maintained investment and participant records and held custody of the plan's investments through September 21, 2023 with the exception of the John Hancock Stable Value fund, which was not transferred until September 2024, since that investment was under a twelve month put option. Pension Consultants, Co. Inc. was the third party administrator and tax counsel that performed various compliance tests. Effective September 22, 2023, Nationwide Trust Company, FSB ("NTC") assumed the responsibilities as the investment agent that maintains investment and participant records, performs various compliance tests as tax counsel and holds custody of the plan's mutual funds and common/collective trust investments. Nationwide Life Insurance Company ("NLIC") is the investment agent that holds custody of the plan's guaranteed investment contract. Raymond James Financial, Inc. is the plan's investment advisor. An officer of the plan sponsor is the plan trustee.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the prospectuses and annual reports of the investments for more information. Earnings, including the net appreciation (depreciation) of investments bought, sold and held during the years, are reflected in the accompanying statements of changes in net assets available for benefits.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - The mutual funds are held by NTC and are offered outside of an annuity contract. NTC uses unit values to perform daily account valuations. The unit value is NTC's method for valuing accounts and is not the same as the net asset value ("NAV") reported by the mutual funds, although the financial trend should be the same. After the close of the stock market, NTC receives a daily price from each mutual fund. This figure includes the NAV and any dividends and capital gains declared and is adjusted by NTC with the addition of a daily administration charge to arrive at the unit value available daily to plan participants on the plan website.

Common/collective trusts - Valued at the NAV based on the units of the common/collective trusts. The common/collective trust investments are direct filing entities. The NAV, as certified by NTC, is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trusts less their liabilities. This practical expedient would not be used if it is determined to be probable that the common/collective trusts will sell the investment for an amount different from the reported NAV.

John Hancock sub-account - The sub-account was valued at the net asset value ("NAV") as provided by John Hancock, which was generally based on the fair value of the underlying investments held by the sub-account less its liabilities. The NAV was used as a practical expedient to estimate fair value. This practical expedient would not have been used if it is determined to be probable that the sub-account would sell the investment for an amount different than the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

Investment at contract value - The plan has a fully benefit-responsive guaranteed investment contract with NLIC. NLIC maintains the contributions in a general account. NLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The interest crediting rate is reset quarterly. The average yield earned by the fund was 2.06% and 2.42% during 2024 and 2023.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by NLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of the investment at contract value at any time. Amounts may be transferred from the participant's account balance in the fund at any time.

The NLIC contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor can request a lump sum distribution with a market value adjustment or an installment payout, at contract value, over a period of years. The NLIC contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on NLIC's ability to meet their financial obligations. NLIC's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with NLIC. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with NLIC or that would limit the ability of the plan to transact at contract value with the participants.

Reclassifications - Certain reclassification have been made to the 2023 financial statements in order to confirm to the 2024 presentation.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The plan was established on May 1, 1987 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible once they have completed three months of employment. An employee can enter the plan immediately upon attaining the eligibility requirements.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Newly eligible employees are automatically enrolled in the plan and have 5% of compensation withheld as deferral contributions. Such participants have the option to increase, decrease or stop the deferral at any time by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. The current employer matching program is made in conjunction with each pay period and is equal to 50% of the first 5% of compensation contributed to the plan as elective deferral contributions for 2024 and 2023.
- d. Nonelective employer contributions can be made at the employer's discretion. No such contributions were made in 2024. Total nonelective employer contributions relating to 2023 were \$60,000. These contributions are funded annually subsequent to year-end.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions and rollover contributions and an allocation of employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral, rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon two years of service at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Upon death, disability or attainment or early retirement age (defined as 55 with six years of service) or normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions are generally required to be in the form of a single lump sum. Partial withdrawals and installments are only permitted for participants who must receive required minimum distributions. In-service withdrawals can commence upon attaining the age of 59 1/2. In addition, hardship withdrawals are also permitted under certain circumstances.

Forfeitures - Forfeited nonvested accounts can be used to pay plan administrative expenses or reduce employer contributions. Forfeitures used were insignificant in 2024 and 2023. Unapplied forfeitures were \$19,000 and \$5,000 as of December 31, 2024 and 2023.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative expenses are paid by the plan from plan assets and are recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan and distribution fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed fees are allocated to participants on an account value basis.

Notes receivable from participants - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Each participant may only have two loans outstanding at any time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had repayment schedules through November 2029 with interest rates ranging from 4.25% to 10.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by the plan's current investment agent (or affiliates of the investment agent). The investment agent also provides certain administrative services to the plan pursuant to a service agreement between the plan sponsor and the investment agent. The investment agent receives indirect compensation from mutual fund service providers for services the investment agent provides to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan to the investment agent for its administrative services to the plan. Transactions between the plan and the investment agent qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants' employer contributions and related earnings would become 100% vested.

5. INCOME TAX STATUS

The plan is operating under a DST Retirement Solutions LLC non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The letter provided by the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As a result, the plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. The plan administrator and tax counsel believe that the plan currently is designed and operated in compliance with the applicable requirements of the IRC, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY THE INVESTMENT AGENTS

Management has obtained certifications from the investment agents (as defined in Note 1), qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held by the agents for the plan and the fair values and contract values of such as of December 31, 2024 and 2023;
- b. Dividends from investments and net appreciation (depreciation) in fair values of investments during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases, sales and transfers between investment accounts during 2024 and 2023.
