Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Monarch Litho, Inc. Profit Sharing 401(k) Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Monarch Litho, Inc. Profit Sharing 401(k) Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan covering all eligible employees of Monarch Litho, Inc. (the “Company” and “Plan Sponsor”) who have completed one month of service, as defined in the Plan document, and are at least eighteen years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”).

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act (“Secure 2.0 Act”) was passed by Congress. The Secure 2.0 Act contains numerous provisions that impact employee benefit plans. Generally, the deadline for formally adopting any required plan amendments made pursuant to the Secure 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective dates of each new provision. The Plan has administratively complied with and adopted all applicable provisions of the Secure 2.0 Act for the years ending December 31, 2024, and 2023. The Plan Sponsor expects the Plan to be formally amended prior to the Secure Act 2.0 deadlines.

Partial Plan Termination

During the plan year ended December 31, 2024, the Plan experienced a significant reduction in participating employees as a result of involuntary terminations due to the Company’s restructuring. Based on an analysis of the number of participating employees terminated during the year, and in accordance with applicable Internal Revenue Service (“IRS”) guidance, it was determined that a partial plan termination occurred.

As required by the IRS, all affected participants who were terminated during the period of the partial plan termination became 100% vested in their account balances, regardless of the Plan’s vesting schedule. Management has reviewed the vesting of impacted participants and confirmed that all applicable account balances have been fully vested.

Contributions

The Plan is a contributory plan whereby participants may contribute up to a maximum of 100% of pre-tax annual compensation not to exceed the dollar limit set by law of \$23,000 for 2024. Participants age 50 or older may elect to defer an additional \$7,500 of “catch up” contributions to the Plan. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor may make discretionary matching contributions to the Plan. Participants must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year in order to be eligible for Company discretionary contributions. For the 2024 Plan year, the Plan Sponsor elected to make no discretionary matching or profit sharing contributions.

Participant Accounts

Each participant's individual account is credited with participant contributions, the Plan Sponsor's contributions, if any, Plan investment earnings, and is reduced by Plan fees. Participants may choose to have their account balance deposited in various investment programs. Allocation of Plan investment earnings is based on the participant's account balance, as defined.

Vesting

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the Plan Sponsor's matching contributions is based on years of continuous service as follows:

While still employed by the Company, if a participant becomes disabled, dies, or reaches normal retirement age, the participant becomes fully vested.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in various investment options offered by the investment contract with America United Life Insurance Company ("AUL"), the Custodian. The investment options include a Guaranteed Return Account and various Pooled Separate Accounts. The Pooled Separate Accounts are managed by AUL. Participants may change their investment options at any time.

Payment of Benefits

Participants may withdraw their vested interest in their accounts upon termination of employment, death, disability, retirement, or for financial hardship as defined in the Plan.

Forfeitures

Forfeitures may first be used to pay any administrative expenses or to reduce discretionary Company. Any remaining forfeitures may be used to reduce Plan Sponsor contributions. As of December 31, 2024 and 2023, forfeiture balance was \$201 and \$197, respectively. For the year ended December 31, 2024, the Plan did not use forfeitures to pay for Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. The Plan Sponsor believes that the estimates utilized in preparing its financial statements are reasonable and prudent. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments consists of realized gains and losses and the change in unrealized gains and losses in the Plan's investments. Realized gains and losses from the sale of investments are computed using the participant's cost basis in the investment aggregated at the Plan level. Net changes in unrealized appreciation/depreciation in investments represent the difference between the fair value of investments held at year-end and the cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as excess contributions owed to participants. As of December 31, 2024 and 2023, there were no excess contributions payable.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administrative expenses are paid by either the Plan Sponsor or the Plan, as provided in the Plan agreement. Fees paid by the Plan for certain administrative expenses amounted to \$36,807 for the year ended December 31, 2024.

Subsequent Events

The Plan evaluated the impact of subsequent events through October 9, 2025, the date these financial statements were issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Pooled Separate Accounts: Pooled separate accounts are valued at the net asset value ("NAV") or equivalent based on units of the pooled separate accounts. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. These investment options are proprietary to American United Life Insurance Company and many invest exclusively in one underlying mutual fund traded on an established market. Such investment choices are valued daily using publicly available quoted market prices. Those accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers that may use alternative observable pricing inputs for certain securities.

4. Fully Benefit-Responsive Investment Contracts

The Plan holds fully benefit-responsive investment contracts with AUL. The investment contracts are an allocated retirement account group annuity contract with AUL. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses not paid by the Plan Sponsor. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rates were approximately 2.67% and 2.53% for 2024 and 2023, respectively. The crediting interest rates are based on a formula agreed upon with the issuer and are reviewed on a quarterly basis for resetting.

Certain events, such as the premature termination of the contract by the Plan or other termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan Sponsor believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

5. Party-in-interest Transactions

Plan investments are held and managed by the Custodian. Transactions with the Custodian qualify as party-in-interest transactions for which exemptions exist. The Custodian received indirect compensation of \$36,601 and received indirect compensation from certain investments based on a formula. In addition, the Plan's broker received indirect compensation of \$26,112.

6. Information Certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, the Custodian, a qualified institution, has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate: investments in the statements of net assets available for benefits as of December 31, 2024 and 2023; net appreciation in value of investments and interest and dividends in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and the investment information included in the supplemental Schedule H, Part IV, Line 4i — Schedule of Assets (Held at End of Year) as of December 31, 2024.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their Company contributions.

10. Prohibited Transactions

There were no prohibited party-in-interest transactions during the year ended December 31, 2024.

11. Tax Status

The prototype, defined contribution plan is a volume submitter profit sharing plan which received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service which stated the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan's management and Custodian believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan's management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
