Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Good Samaritan Hospice, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Good Samaritan Hospice, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Plan Description

The following description of the Good Samaritan Hospice, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Good Samaritan Hospice, Inc. (the “Company”) who are at least 21 years of age and who have at least three months of service for employee contributions and employer safe harbor contributions, and one year of service for discretionary employer matching and profit sharing contributions. The Plan does not cover union employees or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute from 1% to 90% of annual compensation as pretax or Roth, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants are automatically enrolled after obtaining age and service requirements at 3% of compensation. Participants will also receive an automatic deferral increase of 1% each year, not to exceed 6% of compensation. The Company matches 100% of the participant’s first 3% of compensation and 50% of the next 1% of compensation. The Company has the discretion to provide additional matching and profit sharing contributions, determined by the Company. There were no additional matching or profit sharing contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and an allocation of Plan earnings and charged with an allocation of administrative fees. Allocations are based on compensation for participants and Company contributions and account investment balances for earnings and fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after two years of credited service. Participants will become 100% vested upon normal retirement, death, or disability while employed by the Company.

Payment of Benefits

Upon retirement, death, disability, or termination, a participant can elect to receive a lump-sum, installments, or partial withdrawal equal to the vested value of his or her account. In service distributions are allowed, as defined by the Plan document.

Administrative Costs

Plan fees and administrative expenses are paid by the Company and the Plan on a discretionary basis.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,463 and \$10,282, respectively. These accounts may be used to pay Plan expenses or to reduce employer contributions. For the year ended December 31, 2024, forfeitures of \$5,681 and \$23,813 were used to pay Plan expenses and to reduce employer contributions, respectively.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum of \$50,000 or 50% of their vested account balance, whichever is less. Note terms range from one year to five years. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus one percent determined at the time the note is consummated. Interest rates on outstanding notes range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid through payroll deductions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

The following table sets forth by Level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair values of the fixed account are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The fixed account invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are publicly quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 4 – Investment Contract

The Plan holds investments in the Empower Investments Fixed Account. Included in this fund are certain guaranteed investment contracts. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for the fixed account was approximately 1.45% and 1.55% for 2024 and 2023, respectively. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants was 1.45% and 1.53% for 2024 and 2023, respectively. The percentage of contributions allocated to this fund is determined by the participants.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds held and managed by the Plan's Trustee. Investments in funds issued and managed by the Trustees are considered related party transactions. Fees paid by the Plan to the Trustee for investment management and record-keeping services were \$3,092 and \$1,885 for the years ended December 31, 2024 and 2023, respectively.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. Participants will receive a lump-sum distribution as soon as practical after the date of Plan termination.

Note 7 – Tax Status

The Plan is a non-standardized pre-approved profit sharing plan sponsored by Empower Trust Company, LLC. The Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Company has obtained the most recent favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Company believes the Plan is currently being operated in compliance with the applicable requirements of the *IRC*. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
