The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1. Plan Description

The following description of the Islands Hospice, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan was formed on July 1, 2021, and is a defined contribution plan covering all employees of Islands Hospice, Inc. and certain affiliates thereof (collectively, the Company) who have attained the age of 21 years. Employees who are excluded from participating are those who are covered by a collective bargaining agreement, are leased employees, or are nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the Company, whereby employees of the Company serve as the Administrative Committee of the Plan. Capital Bank and Trust Company (Trust Company) serves as the trustee of the Plan.

**Eligibility:** Eligible employees may begin participation on the first day of the month following their hire date. Employees are eligible for the Company safe harbor matching contributions and discretionary Company contributions, which are nonelective contributions, upon their hire date.

**Contributions:** Each year, participants may contribute a percentage of pre-tax and post-tax annual compensation, as defined in the Plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investments of their contributions into various investment options offered by the Plan in a manner that is consistent with participant contributions. Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

For the year ended December 31, 2024, the Company made a safe harbor matching contribution equal to a calculation based on the employee's deferral percentage up to 4% of eligible compensation, as defined in the Plan agreement. Additional amounts may be contributed at the discretion of the Company. No additional discretionary matching contribution was made for the year ended December 31, 2024. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, and an allocation of (a) the Company's matching and discretionary contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are immediately vested in the Company's safe harbor matching contributions. Vesting in any additional Company discretionary matching contributions is based upon years of service. Participants vest at the rate of 25% per year of service, beginning with the first year, until fully vested after four years.

#### Note 1. Plan Description (Continued)

**Forfeitures:** Forfeitures of the employer's contributions, if any, due to participant withdrawals prior to being 100% vested may be used to reduce future Company contributions or offset Plan expenses. In 2024, no forfeitures were used to reduce Company contributions or offset Plan expenses. At December 31, 2024 and 2023, there were no unused forfeited nonvested accounts held by the Plan.

**Payment of benefits:** Upon termination of service, attainment of age 62, death, disability, or retirement, a participant may elect to receive either a lump sum or rollover distribution amount equal to the vested interest in his or her account. In-service withdrawals are permitted for hardship, early retirement age of 59½, normal retirement age of 62, rollover, or qualified military service. Benefits are recorded when paid.

**Administrative expenses:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Company and therefore are not reflected in the Plan's financial statements.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Contributions:** Contributions from participants and the matching contributions from the employer are recorded in the year in which the participant's contributions are withheld from compensation.

**Use of estimates:** The preparation of the financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and certain changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Company has evaluated subsequent events for potential recognition and/or disclosure through October 7, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under accounting standards are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used during the year ended December 31, 2024.

**Shares of registered investment companies:** Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels:** To assess the appropriate classifications of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Party-in-Interest Transactions

Certain plan investments and shares of registered investment companies are managed by USI Consulting Group. performs services for the Plan; therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guideline. Fees paid by the Plan to USI Consulting Group were approximately \$7,600 for the year ended December 31, 2024.

#### **Note 6. Income Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service dated November 3, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

#### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 8. Delinquent Contributions**

During the year ended December 31, 2024, the Company inadvertently failed to deposit \$22,371 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Company intends to reimburse the Plan for lost earnings. Additionally, the Company intends to complete the Form 5330 and pay the applicable excise tax, which will be paid from plan sponsor assets and not assets of the Plan.
