Professional standards require that we provide you with the following information related to our audit.

Our Responsibility Under U.S. Generally Accepted Auditing Standards

As stated in our engagement letter dated May 27, 2025, our responsibility, as described by professional standards, is to express an opinion about whether the financial statements prepared by management with your oversight are fairly presented, in all material respects, in conformity with U.S. generally accepted accounting principles. Our audit of the financial statements does not relieve you or management of your responsibilities. Our responsibility is to plan and perform the audit to obtain reasonable, but not absolute, assurance that the financial statements are free of material misstatement. As part of our audit, we considered the internal controls of the Plan. Such considerations were solely for the purpose of determining our audit procedures and not to provide any assurance concerning such internal control.

We are responsible for communicating significant matters related to the audit that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures specifically to identify such matters.

Planned Scope and Timing of the Audit

We performed the audit according to the planned scope and timing previously communicated to you in our meeting about planning matters on July 16, 2025.

Significant Audit Findings

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. In accordance with the terms of our engagement letter, we will advise management about the appropriateness of accounting policies and their application. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No significant new accounting policies were adopted, and the application of existing policies was not changed during 2024.

We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus.

We noted no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was the Plan's valuation of investments.

Management has informed us that, in determining the appropriateness of the estimate of investment values, they have recorded the fair values based on market values provided by the investment custodian, plus any applicable valuation adjustments. We have performed tests of the estimate to satisfy ourselves as to its reasonableness in relation to the financial statements taken as a whole.

The disclosures in the financial statements are neutral, consistent, and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Disagreements with Management

For the purpose of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report.

We are pleased to report that no such disagreements arose during the course of our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. We did not detect any misstatements as a result of audit procedures.

Significant Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards and plans and strategies that may affect the risks of material misstatement, with management each year prior to our retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship, and our responses were not a condition of our retention.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 9, 2025.

Form 5500 - Annual Return/Report of Employee Benefit Plan

Our responsibility for Form 5500 does not extend beyond the financial statements, and we do not express an opinion or any form of assurance on Form 5500. However, we read the Plan's Form 5500 filing, and nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information or manner of its presentation appearing in the financial statements.

This information is intended solely for the use of the administrative committee and management of the Plan and is not intended to be and should not be used by anyone other than these specified parties.

Independent Auditor's Report

Opinion

Note 1 - Plan Description

The following description of Jones Day Supplemental Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Jones Day (the "Firm") who are not active in the Jones Day Retirement Plan and employees of the Jones Day Limited Partnership who have met the eligibility requirements, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 50 percent of annual compensation subject to maximum tax-deferral limitations established by the Internal Revenue Code (IRC). The Plan allows participants to contribute on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer contributions (Retirement Contributions) to an eligible participant's account of 7.5 percent of the participant's compensation, not to exceed the Internal Revenue Service (IRS) maximums.

The Firm may also make annual discretionary matching contributions. For the year ended December 31, 2024, the Firm made discretionary matching contributions for nonlawyer participants in the Plan limited to the lesser of (1) 20 percent of the elective deferrals made by each participant or (2) 20 percent of the first 4 percent of compensation deferred by participants.

Participant Notes Receivable

Participants may borrow from their accounts subject to a minimum of \$5,000 up to a maximum equal generally to the lesser of \$50,000 or 50 percent of their vested account balances. Notes receivable are secured by the participant's account balance and bear interest at a market rate.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Firm's contributions and plan earnings. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. In addition, participants are immediately 100 percent vested in employer discretionary matching contributions and any income or loss thereon.

Vesting in the Firm's contributions portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Firm 100 percent after three years of service. Prior to reaching three years of service, the participant is 0 percent vested in Retirement Contributions. If a participant with less than three years of service dies while they are an employee, they will become 100 percent vested in their Retirement Contributions.

Note 1 - Plan Description (Continued)

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of age 59½ (in-service withdrawal) in the form of a lump-sum amount or installment payments equal to the vested balance of the participant's account. A participant who terminates employment with the Firm and whose plan account does not exceed \$1,000 will automatically receive a lump-sum payout of the participant's entire account balance. Lastly, hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined in the plan agreement.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future firm contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. However, they are exempt from the prohibited transaction rules under ERISA.

Termination

While it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan generally distributes the excess contributions to the applicable participants prior to March 15 of the following year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs can be paid by the Firm. These transactions qualify as party-in-interest transactions.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 - Interest in Jones Day Defined Contribution Master Trust

The Plan's investments are held in the Jones Day Defined Contribution Master Trust (the "DC Master Trust"), which was established for the investment of assets of the Plan and one other Jones Day-sponsored benefit plan. Each participating plan's interest in the DC Master Trust is based on account balances of the participants and their elected investment options. The assets of the DC Master Trust are held by Fidelity. Investment income and administrative expenses relating to the DC Master Trust are allocated to the individual plans based upon average monthly balances invested by each plan.

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the DC Master Trust has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

Note 3 - Interest in Jones Day Defined Contribution Master Trust (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The DC Master Trust's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the DC Master Trust's investments:

Cash

Cash is valued at quoted prices reported in active markets.

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

Common/collective trust funds (CCT) are valued at net asset value (NAV) per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. The common/collective trust funds valued at NAV have no unfunded commitments.

Real Estate Fund

The real estate fund is valued at NAV of shares held by the DC Master Trust at year end determined by the fund manager. The real estate fund valued at NAV has no unfunded commitments.

Corporate Obligations and U.S. Government Obligations

The U.S. government obligations and corporate obligations are valued using quoted market prices and/or other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models. These models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded securities, which are valued at the quoted prices reported in active markets.

- (1) The various common/collective trust funds are as follows:

Acadian Emerging Markets Equity CIT Fund - The investment objective is to seek long-term capital appreciation by investing primarily in common stocks of emerging markets issuers. The fund will look to outperform the MSCI Emerging Markets Free Index over multiple-year time periods. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 5-business-day notice for employer-initiated withdrawals over 20 percent of total market value in the fund. The balance of this fund was \$28,249,747 and \$26,847,696 at December 31, 2024 and 2023, respectively.

MFS International Equity CIT - The investment objective is to outperform the MSCI EAFE Index over full market cycles. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 30-day notice for employer-initiated withdrawals. The balance of this fund was \$112,709,959 and \$106,579,267 at December 31, 2024 and 2023, respectively.

Invesco Emerging Markets Equity Trust 1 CTF - The investment objective is to outperform the MSCI Emerging Markets Index on an absolute and risk-adjusted basis over a three- to five-year period on a cumulative basis. Participant-directed redemptions have no restrictions; however, the DC Master Trust is required to provide a 60-day notice for employer-initiated withdrawals. The balance of this fund was \$40,767,882 and \$39,727,324 at December 31, 2024 and 2023, respectively.

Invesco Stable Value Trust Class B1 - The investment objective is to outperform the BBGB 3M T-Bill Bellwether Index through preservation of principal and providing interest income reasonably obtained under prevailing market conditions and rates while seeking to maintain liquidity. Participant-directed redemptions have no restrictions; however, the DC Master Trust is required to provide a 12-month notice for employer-initiated withdrawals. The balance of this fund was \$66,999,243 and \$71,299,764 at December 31, 2024 and 2023, respectively.

FIAM Small Cap Core Fund - The investment objective is to outperform the Russell 2000 Index through active stock selection while maintaining similar portfolio risk characteristics. Participant-directed redemptions have no restrictions; however, the DC Master Trust is required to provide a 30-day notice for employer-initiated withdrawals. The balance of this fund was \$54,434,002 and \$51,186,030 at December 31, 2024 and 2023, respectively.

Vanguard Institutional 500 Index Trust - The investment objective is to replicate the performance of the S&P 500 Index by investing all of its assets in the stocks that make up the index, holding each stock in approximately the same proportion as weighting in the index. Participant-directed redemptions have no restrictions; however, the DC Master Trust is required to provide a 30-day notice for employer-initiated withdrawals. The balance of this fund was \$523,943,074 and \$382,768,907 at December 31, 2024 and 2023, respectively.

Vanguard Institutional Extended Market Index Trust - The investment objective is to track the performance of a benchmark index that measures the investment return of small- and mid-capitalization stocks. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 30-day notice for employer-initiated withdrawals. This was a new fund added to the Plan in 2024. The balance of this fund was \$29,397,689 at December 31, 2024.

Vanguard Institutional Total International Stock Market Index Trust - The investment objective seeks to track the performance of a benchmark index that measures the investment return of stocks issued by companies located in developed and emerging markets, excluding the United States. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 30-day notice for employer-initiated withdrawals. This was a new fund added to the Plan in 2024. The balance of this fund was \$23,799,363 at December 31, 2024.

Vanguard Institutional Total Bond Market Index Trust - The investment objective seeks to track the performance of a broad, market-weighted bond index. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 30-day notice for employer-initiated withdrawals. This was a new fund in 2024. The balance of this fund was \$16,600,511 at December 31, 2024.

BlackRock Institutional U.S. Treasury Inflation Protected Securities Fund M - The investment objective is to closely approximate the total rate of return for all outstanding U.S. Treasury Inflation Protected Securities with a maturity of one year or greater, as defined by the Bloomberg Barclays U.S. TIPS Index.

Participant-directed redemptions have no restrictions; however, the DC Master Trust is required to provide a 30-day notice for employer-initiated withdrawals. The balance of this fund was \$6,615,699 and \$4,620,807 at December 31, 2024 and 2023, respectively.

Loomis Sayles Global CIT - The investment objective is high total investment return through a combination of current income and capital appreciation. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 30-day notice for employer-initiated withdrawals. The balance of this fund was \$3,618,862 and \$4,255,657 at December 31, 2024 and 2023, respectively.

Government Short-Term Investment Fund - The investment objective is to provide safety of principal, a high level of liquidity, and a competitive yield. Participant-directed redemptions have no restrictions; however, the DC Master Trust is required to provide a 30-day notice for employer-initiated withdrawals. The balance of this fund was \$20,452,477 and \$23,837,222 at December 31, 2024 and 2023, respectively.

- (2) This category includes a separate pooled account that seeks to achieve superior returns over a full market cycle versus the NCREIF Property Index. For liquidity purposes, the fund holds a 2 percent cash position and reserves the right to hold redemptions for up to three years. Effective July 1, 2022, the fund implemented a withdrawal limitation to protect the best interest of all contract holders. The withdrawal limitation expired on June 30, 2025.
