## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wolverine Fuels Holding, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

December 31, 2024

### 1. Description of the Plan

The following description of Wolverine Fuels Holding, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan available to eligible employees of Wolverine Fuels, LLC and Canyon Fuel Company, LLC (collectively referred to as the “Plan Sponsor”). Employees are excluded from the Plan if they are residents of Puerto Rico, covered by a collective bargaining agreement (unless the agreement requires the employees to be included under the Plan), leased employees, and temporary, seasonal, or interim employees. Effective October 11, 2024, the Plan was amended to exclude part-time employees. Participation in the Plan is strictly voluntary, and employees are eligible to participate on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute, on a pre-tax or Roth basis, up to 60% of their eligible compensation, and up to 100% of their after-tax eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at a 6% of eligible compensation, as defined by the Plan Document.

The Plan Sponsor, at its discretion, may make discretionary matching contributions, qualified matching, discretionary nonelective contributions, and qualified nonelective contributions to the Plan. No such Plan Sponsor discretionary contributions were made during 2024. During 2024, the Plan Sponsor made safe harbor matching contributions to the Plan equal to 100% of participant deferrals up to 6% of compensation. Participants are eligible to receive these safe harbor matching contributions at the same time they are eligible for participation in the Plan.

Cash contributions receivables, if any, are unsecured.

**1. Description of the Plan (continued)**

**Participant Accounts**

Individual accounts are maintained for each participant to reflect the participant’s contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary and rollover contributions, Plan Sponsor safe harbor matching contributions, qualified matching, and qualified nonelective contributions, if any, plus actual earnings thereon. Vesting of the Plan Sponsor’s discretionary matching and discretionary nonelective contributions portion of their accounts plus related earnings is based on years of vesting service, as follows:

<u>Years of Service</u>	<u>Percentage</u>
Less than 3	0%
3	100%

Upon retirement, death, or disability, participants become 100% vesting in their entire account balance.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account. One loan can be outstanding at a time per participant, and the loans bear interest at a rate established by the Plan Administrator in a nondiscriminatory manner. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over an increased reasonable period of time as determined at the time the loan was made. Principal and interest are paid ratably through payroll deductions.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the Internal Revenue Code (IRC), has occurred, the note receivable will be foreclosed on and be offset against the participant’s account balance. If a participant’s note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Payment of Benefits

On termination of service due to death or disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age may choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permits in-service and hardship withdrawals under certain conditions.

##### Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures totaled \$139,543 in 2024. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,498 and \$42, respectively. Forfeitures may be used to pay administrative expenses or to reduce future Plan Sponsor contributions. During 2024, Plan Sponsor contributions were reduced by \$133,356 from forfeited non-vested accounts, and administrative expenses were reduced by \$3,101 from forfeited non-vested accounts.

##### Other Unallocated Assets

As of December 31, 2024 and 2023, other unallocated assets totaled \$223,602 and \$124,805, respectively, which may also be used to pay administrative expenses.

##### Termination of the Plan

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Plan Sponsor contributions.

#### 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as are the annual returns filed under applicable provisions of ERISA and IRC.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are held by Fidelity Management Trust Company (Fidelity). The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments. The investments are stated at fair value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

The Plan participates in an expense offset arrangement whereby certain third-party expenses are paid with rebates received by the Plan from investment managers. During 2024, the Plan received investment manager rebates of approximately \$146,000, which were offset against administrative expenses of approximately \$141,000 paid to parties-in-interest. The net rebates are included in other income in the accompanying statement of changes in net assets available for benefits.

**2. Summary of Significant Accounting Policies (continued)**

**Subsequent Events**

In preparation of the accompanying financial statements, the Plan's management has evaluated subsequent events that have occurred since December 31, 2024 through October 7, 2025, the date the financial statements were available for issuance.

**3. Income Tax Status**

The Plan Sponsor adopted a prototype plan sponsored by FMR, LLC that received a favorable opinion letter from the IRS dated June 30, 2020 which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

**4. Certified Information (Unaudited)**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, interest income on notes receivable from participants, dividend and interest income, and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, as agent for Fidelity.

**5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

#### 5. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level for the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Common collective trust (Fidelity Managed Income Portfolio Fund):* Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Valued based on the underlying NAV's of the investments in the account. The Plan accounts consist of a money market mutual fund, common stocks and unit investment trusts that are registered with the SEC. The underlying investments held by the Plan are deemed to be actively traded.

## Notes to Financial Statements

December 31, 2024

### 1. Description of the Plan

The following description of Wolverine Fuels Holding, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan available to eligible employees of Wolverine Fuels, LLC and Canyon Fuel Company, LLC (collectively referred to as the “Plan Sponsor”). Employees are excluded from the Plan if they are residents of Puerto Rico, covered by a collective bargaining agreement (unless the agreement requires the employees to be included under the Plan), leased employees, and temporary, seasonal, or interim employees. Effective October 11, 2024, the Plan was amended to exclude part-time employees. Participation in the Plan is strictly voluntary, and employees are eligible to participate on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute, on a pre-tax or Roth basis, up to 60% of their eligible compensation, and up to 100% of their after-tax eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at a 6% of eligible compensation, as defined by the Plan Document.

The Plan Sponsor, at its discretion, may make discretionary matching contributions, qualified matching, discretionary nonelective contributions, and qualified nonelective contributions to the Plan. No such Plan Sponsor discretionary contributions were made during 2024. During 2024, the Plan Sponsor made safe harbor matching contributions to the Plan equal to 100% of participant deferrals up to 6% of compensation. Participants are eligible to receive these safe harbor matching contributions at the same time they are eligible for participation in the Plan.

Cash contributions receivables, if any, are unsecured.

**1. Description of the Plan (continued)**

**Participant Accounts**

Individual accounts are maintained for each participant to reflect the participant’s contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary and rollover contributions, Plan Sponsor safe harbor matching contributions, qualified matching, and qualified nonelective contributions, if any, plus actual earnings thereon. Vesting of the Plan Sponsor’s discretionary matching and discretionary nonelective contributions portion of their accounts plus related earnings is based on years of vesting service, as follows:

<u>Years of Service</u>	<u>Percentage</u>
Less than 3	0%
3	100%

Upon retirement, death, or disability, participants become 100% vesting in their entire account balance.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account. One loan can be outstanding at a time per participant, and the loans bear interest at a rate established by the Plan Administrator in a nondiscriminatory manner. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over an increased reasonable period of time as determined at the time the loan was made. Principal and interest are paid ratably through payroll deductions.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the Internal Revenue Code (IRC), has occurred, the note receivable will be foreclosed on and be offset against the participant’s account balance. If a participant’s note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Payment of Benefits

On termination of service due to death or disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age may choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permits in-service and hardship withdrawals under certain conditions.

##### Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures totaled \$139,543 in 2024. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,498 and \$42, respectively. Forfeitures may be used to pay administrative expenses or to reduce future Plan Sponsor contributions. During 2024, Plan Sponsor contributions were reduced by \$133,356 from forfeited non-vested accounts, and administrative expenses were reduced by \$3,101 from forfeited non-vested accounts.

##### Other Unallocated Assets

As of December 31, 2024 and 2023, other unallocated assets totaled \$223,602 and \$124,805, respectively, which may also be used to pay administrative expenses.

##### Termination of the Plan

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Plan Sponsor contributions.

#### 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP), as are the annual returns filed under applicable provisions of ERISA and IRC.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are held by Fidelity Management Trust Company (Fidelity). The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments. The investments are stated at fair value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

The Plan participates in an expense offset arrangement whereby certain third-party expenses are paid with rebates received by the Plan from investment managers. During 2024, the Plan received investment manager rebates of approximately \$146,000, which were offset against administrative expenses of approximately \$141,000 paid to parties-in-interest. The net rebates are included in other income in the accompanying statement of changes in net assets available for benefits.

**2. Summary of Significant Accounting Policies (continued)**

**Subsequent Events**

In preparation of the accompanying financial statements, the Plan's management has evaluated subsequent events that have occurred since December 31, 2024 through October 7, 2025, the date the financial statements were available for issuance.

**3. Income Tax Status**

The Plan Sponsor adopted a prototype plan sponsored by FMR, LLC that received a favorable opinion letter from the IRS dated June 30, 2020 which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

**4. Certified Information (Unaudited)**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, interest income on notes receivable from participants, dividend and interest income, and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, as agent for Fidelity.

**5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

### Notes to Financial Statements (continued)

#### 5. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level for the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Common collective trust (Fidelity Managed Income Portfolio Fund):* Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Valued based on the underlying NAV's of the investments in the account. The Plan accounts consist of a money market mutual fund, common stocks and unit investment trusts that are registered with the SEC. The underlying investments held by the Plan are deemed to be actively traded.
