NOTE 1 – DESCRIPTION OF PLAN

The following description of the Community Integrated Work Program, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan has been adopted by Community Integrated Work Program, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a defined contribution plan. The primary purpose of the Plan is to provide employees of the Company with the opportunity to accumulate funds for their retirement. The Trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan has been restated for final Cycle 3 regulations effective January 1, 2022.

Eligibility

The Plan is a defined contribution plan covering all employees of the Company who have completed at least one year of service, have attained the age of 21, and are not covered by a collective bargaining agreement. A year of service is defined as any plan year in which the employee has worked 1,000 hours. The participant must be employed on the last day of the plan year to be allocated employer discretionary contributions.

Employee contributions

Participants may contribute a percentage of their annual compensation to the Plan through salary deferrals up to the maximum dollar amount determined by the Internal Revenue Service each year. If the participant is age 50 or older, the participant may elect to defer additional amounts as defined by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer contributions

Upon fulfillment of the eligibility requirements, participants will receive a safe harbor match of 100% of employee deferrals up to 4% of eligible compensation. The Company is permitted to change the safe harbor formula annually. The Company match is allocated to participant accounts that have received deferrals during the year. For the years ended December 31, 2024 and 2023, the Company contributed a safe harbor match of \$286,910 and \$213,027, respectively.

Each year the Company may determine a discretionary contribution to the Plan. Discretionary contributions will be allocated to participants determined as a percentage of compensation or a dollar amount per participant. The amount of discretionary contribution may not obligate the Company to contribute, for any year, any sums which are estimated to be in excess of the amount which the Company would be permitted to deduct on its federal income tax return for such year. There were no discretionary contributions for the years ended December 31, 2024 and 2023.

These amounts are limited to the maximum dollar amount determined by the Internal Revenue Service each year.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants are allowed to direct their contributions and the employer discretionary and safe harbor matching contributions into any of the various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Discretionary contributions by the Company vest on a pro rata basis over six years and safe harbor matching contributions are immediately vested.

Notes receivable from participants

Participants in the Plan may borrow a minimum amount of \$1,000 and a maximum of 50% of their vested balance up to \$50,000. Loan terms range from one to five years, unless the loan is being used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator and defined by plan policy. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Upon termination of service, retirement, or permanent disability, the participant shall receive their portion of the Company contribution account by payment in a lump sum.

A participant may receive a distribution of salary deferral amounts in the event of certain financial hardships. In addition, upon attaining age 59 1/2, if a participant is still employed, they may request an in-service distribution.

Forfeitures

Forfeitures may be applied to reduce administrative expenses of the Plan, restore forfeited account balances of rehires who are eligible for a restoration of forfeitures, and reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,605 and \$3,685, respectively. During the years ended December 31, 2024 and 2023, no forfeitures were utilized.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent events

Plan management has evaluated subsequent events through October 5, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The life insurance policies are valued at the net cash surrender values as calculated by the issuing life insurance company. The net cash surrender value approximates fair value.

The pooled separate accounts invest in mutual funds, domestic equity securities, or fixed maturity securities. More than one source may be used to generate unit prices. The market price of the fund and the unitized pricing model are both used.

NOTE 5 - ALLOCATION OF ASSETS

Net assets available in the amount of \$1,215,280 and \$756,088, for the years ended December 31, 2024 and 2023, respectively, have been allocated to the accounts of employees who have separated service with the Company. At December 31, 2024 and 2023, no accounts included nonvested amounts to be forfeited in later years.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer discretionary contributions.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED PARTY TRANSACTIONS

The Plan's assets are held by John Hancock Life Insurance Company, Massachusetts Mutual Life Insurance Co. and Metropolitan Life Insurance Company. John Hancock Life Insurance Company also provides recordkeeping and investment services to the Plan which qualify as party-in-interest transactions. Fees associated with each managed fund are built into the expense ratio for that fund. Third party administrative fees and compensation paid by the Plan were \$8,123 and \$9,124, for the years ended December 31, 2024, and 2023, respectively. Broker commissions paid by John Hancock related to the Plan totaled \$18,970 and \$15,598, for the years ended December 31, 2024 and 2023, respectively. Recordkeeper services paid to John Hancock were \$2,042 and \$2,729, for the years ended December 31, 2024 and 2023, respectively.

Administrative functions are jointly performed by a third party administrator and by officers or employees of the Company. No officer or employee receives compensation from the Plan. John Hancock Life Insurance Company administrative expenses are absorbed by the Plan and allocated among the participants' accounts. The independent auditor's fees are paid directly by the Company and may be reimbursed by plan forfeitures.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.


