Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Orthopedic Health of Kansas City P.C. Profit Sharing 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and June 30, 2024, and the related statement of changes in net assets available for benefits for the six-month period ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and June 30, 2024, and for the six-month period ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS DECEMBER 3, 2024 AND JUNE 30, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Orthopedic Health of Kansas City P.C. Profit Sharing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was originally established January 1, 2004, and was amended and restated to adopt the Third Cycle Restatement effective January 1, 2021.

General – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of Orthopedic Health of Kansas City P.C. (the “Company”).

Newport Trust Company (“Newport”) served as the Plan’s investment custodian and recordkeeper through April 17, 2024. Newport was acquired by Ascensus Trust Company (“Ascensus”), and Ascensus assumed custodial and recordkeeping duties on April 18, 2024. Owners of the Company serve as trustees to the Plan.

Plan Amendment – Effective December 18, 2024, the Plan Sponsor adopted a resolution to change the year end of the Plan to a calendar year end.

Eligibility – An individual is eligible to participate in the Plan upon working for one year and attaining the age of 21. This applies to both employee and employer contributions. Once those requirements have been met, an employee may enter the Plan on the first day of July or January. The Plan excludes union and leased employees.

Contributions – Participants may contribute amounts up to certain Internal Revenue Code (“IRC”) limitations. Participants may contribute pre-tax amounts (401(k) contributions) or after-tax amounts (Roth contributions). A participant who is at least 50 years old may also make catchup contributions to the Plan.

The Company makes a safe harbor contribution, which is 3% of an employee’s eligible wages. The safe harbor contribution is paid into the Plan after the Plan’s year end.

The Employer may make a discretionary profit-sharing contribution. A participant must work 1,000 hours in the Plan year if not employed on the last day of the Plan year in order to receive a profit-sharing contribution. The profit-sharing contribution is calculated for eligible participants using the allocation gateway method and is paid into the Plan after the Plan’s year end.

The Employer may also make a discretionary matching contribution. No such contribution was declared for the Plan six-month period ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s and Company’s contributions, investment earnings (losses), and is charged with the participant’s withdrawals and distributions, and an allocation of expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – The Plan offers a variety of mutual funds and a money market fund as investment options for participants. Participants may also opt to use a self-directed brokerage account.

Vesting – Participants’ contributions and safe harbor contributions are fully vested at all times. Discretionary profit-sharing contributions and matching contributions vest in 20% increments, with 20% vested after 2 years of service and becoming fully vested after 6 years.

In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested. An employee must work 1,000 hours in a year to earn one year of service.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. For the six-month period ended December 31, 2024, forfeitures of \$2,269 were used to offset the employer contributions declared for the year ended June 30, 2024. As of December 31, 2024 and June 30, 2024, there were \$10,030 and \$10,002 in forfeitures, respectively.

Payment of Benefits – Distributions of a participant's vested balance may occur upon normal retirement, termination of employment, death, or permanent and total disability in the form of a total lump sum or installment payments. Participant balances under \$1,000 may be automatically distributed. If a participant's account balance is between \$1,000 and \$7,000, the balance will be automatically rolled over to an IRA, unless a different election is made.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment.

- Hardship withdrawals are limited to the participant's employee contributions.
- Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.
- Participants may withdraw amounts that are designated as rollover contributions at any time.

Notes Receivable from Participants – Participants are permitted to borrow against their individual account balances (salary deferral portion, only) a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the participant's vested account balance. Interest rates on the loans are set at the prime rate. Loan terms are in accordance with limitations set forth by the Internal Revenue Service, and may not exceed 5 years, unless the loan is to purchase a primary residence, at which times loan may be amortized over 15 years. Loan repayments are made ratably through payroll deductions.

Administrative Expenses – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. For the six-month period ended December 31, 2024, the Plan paid administrative expenses of \$22,802.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants shall become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits – Benefit payments are reported in the year paid.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Date of Management’s Review – Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued, and there were no events requiring additional accrual or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and June 30, 2024:

Mutual Funds and Money Market Fund – Valued at the net asset value (NAV) of shares held by the plan at year end.

Self- Directed Brokerage Accounts – Balances consist of mutual funds, exchange traded funds, money market funds and common stocks. Mutual funds and money market funds are valued as stated above. Exchange traded funds and common stocks are valued at the closing share price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY CUSTODIANS

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Ascensus Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule noted below is complete and accurate with respect to investments as of December 31, 2024 and June 30, 2024, and for the six-month period ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants, and related interest income
- Net appreciation in fair value of investments
- Interest and dividend income
- Earnings on self-directed brokerage accounts
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan pays certain fees to Ascensus to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants also qualify as party-in-interest.

7. TAX STATUS

The Plan has adopted a prototype non-standardized profit-sharing plan with CODA, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
