## 1. Description of the Plan

The following brief description of Tradewind Group, Inc. Profit Sharing 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

### a. General

The Plan is a defined contribution plan which covers substantially all employees of Tradewind Group, Inc. (the Company). On March 1, 2023, the Plan changed its name to Tradewind Group, Inc. Profit Sharing 401(k). For the employer's profit sharing contributions, salaried employees of the Company are eligible to participate in the Plan upon completion of three calendar months of service and hourly employees are eligible to participate in the Plan upon completion of one year of service, as defined. For the 401(k) contributions and safe harbor match contributions, all salaried and hourly employees are eligible to participate in the Plan upon completion of six calendar months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants pay any transaction fees related to their individual account withdrawals or loans.

### b. Administration of Plan Assets

The administration of the Plan is the responsibility of a special Administrative Committee (Committee) appointed by the Board of Directors of the Company. Plan assets are held by and investment transactions are executed by the Vanguard Fiduciary Trust Company (Vanguard), the trustee of the Plan.

### c. Contributions

#### *Profit Sharing*

The Company voluntarily contributes to the Plan as determined by the Company's Board of Directors, subject to the limitation that the contribution does not exceed the maximum amount deductible under applicable provisions of the Internal Revenue Code (IRC).

## 1. Description of the Plan (continued)

### c. Contributions (continued)

*401(k)*

Eligible participants may make voluntary contributions to the Plan up to their annual wages and may not exceed amounts allowable under the IRC. Such contributions are nonforfeitable and are credited to the individual account of the participant. The Company contributes safe harbor matching contributions to the Plan based on the following:

- a) 100% of participant contributions which comprise the first 3% of compensation deferred, plus
- b) 50% of participant contributions which comprise the next 2% of compensation deferred.

### d. Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings or losses and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or contributions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### e. Vesting

Vesting under the Plan occurs as follows:

*Profit Sharing:* Vesting in the Company's contribution portion plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of continuous service.

*401(k):* Participants are immediately vested in their 401(k) contributions and employer safe harbor match contributions plus actual earnings thereon.

### f. Investment Options

Plan assets are held by Vanguard and are invested in mutual funds and a common collective trust. Participants may direct their contributions, employer contributions and any related earnings in their account. Participants may change their investment elections daily.

### g. Notes Receivable from Participants

The Plan has made loans to its participants pursuant to the Plan provision whereby any participant may apply for a loan which will be approved by the Committee in a uniform and non-discriminatory manner. Each participant may request a loan for necessary personal expenses, including medical expenses, the purchase of the participants' principal residence, educational expenses, or an unusual financial emergency, in an amount that does not exceed the lesser of \$50,000 (reduced by the highest outstanding loan balance of loans from the Plan to the participant on the date on which such loan is made) or 50% of the participant's vested account.

The total of any such loan made to a participant must be adequately secured by the participants' vested account, and must have a maturity date not in excess of five years unless such loan is used to acquire the principal residence of the participant. Interest on loans is charged at a reasonable rate as determined by the Committee. The outstanding loans at December 31, 2024, bear interest rates that range from 4.25% to 9.50% and mature on various dates through June 2037.

### h. Payment of Benefits

Upon termination of service, a participant may elect to maintain the vested portion of their account in any of the available funds. Upon termination from the Plan, the payment of benefits is made in a lump-sum payment.

### i. Expenses

Administrative expenses of the Plan are paid by either the Plan or the Plan's sponsor, as provided in the Plan document.

### j. Forfeitures

Forfeitures applicable to the nonvested account balances of terminated employees who incurred five consecutive one-year breaks in service are first used to pay administrative expenses. Excess forfeitures are then used to reduce employer contributions or allocated to the participants on the same basis as the allocation of the Company's contribution for the current plan year. As of December 31, 2024 and 2023, approximately \$8,000 and \$1,700, respectively, were available to offset Plan expenses or allocate to remaining eligible participant account balances. During 2024, there were approximately \$28,800 of forfeitures and approximately \$23,200 was used to pay plan expenses. Forfeited accounts were also credited with approximately \$700 of net investment income during 2024.

### k. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of termination of the Plan, the rights of all employees to benefits accrued to the date of such termination are fully vested and nonforfeitable.

## 2. Summary of Significant Accounting Policies

### a. Basis of Accounting

As permitted by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan maintains its records on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). This basis differs from U.S. GAAP in that participant and employer contributions are recognized when received instead of when earned, and administrative expenses are recognized as paid instead of when the obligation is incurred. Accordingly, the accompanying financial statements and supplemental schedule are not intended to be presented in conformity with U.S. GAAP.

#### **b. Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **c. Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### **d. Payments of Benefits**

Benefits are recorded when paid.

#### **e. Use of Estimates**

The preparation of financial statements on the modified cash basis requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

#### **f. Subsequent Events**

The Plan's management has considered subsequent events through September 23, 2025, the financial statements were available to be issued and it was determined that all subsequent events had been properly accounted for.

The trustee also certified to the completeness and accuracy of the Plan's net investment income and interest on notes receivable from participants of \$14,758,164 and \$58,216, respectively, related to the aforementioned assets for the year ended December 31, 2024.

### 4. Fair Value Measurements

The modified cash basis of accounting establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - inputs consist of unadjusted quoted prices in active markets such as stock exchanges for identical assets or liabilities and have the highest priority.

Level 2 - inputs consist of significant other observable inputs such as quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the assets and liabilities, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3 - inputs consist of significant unobservable inputs and include situations where there is little, if any, market activity for the investment. The inputs require significant judgment or estimates.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds – based on quoted market prices of each fund, which represents the net asset value (NAV) of shares held by the Plan at year-end.

Common collective trust – A common collective trust that is composed of fully benefit responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value.

This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Vanguard is a trustee as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.

## 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

## 7. Tax Status

The Plan has adopted a non-standardized pre-approved plan that received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the non-standardized pre-approved plan's qualified status. The non-standardized pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the non-standardized pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. Plan years from December 31, 2021 are open for examination for federal tax purposes.
