1. Description of Plan

The following description of the Federal Management 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution profit sharing plan with a cash deferral arrangement covering all full time employees of Federal Management Co., Inc. and Schocket Associates, Inc. (collectively the "Company") who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan became effective on January 1, 1988 and the plan year is January 1 through December 31.

b. Custodian

The Plan established a trust with Standard Retirement Services, Inc. and its sub-custodian Charles Schwab Bank (collectively, the "Custodians"), which consists of such sums of money and other property acceptable to the Custodians that, from time to time, will be paid or delivered to the Custodians, including investments and proceeds thereof and earnings thereon, less the payments made by the Custodians, as authorized. The Custodians have agreed to invest and reinvest the funds of the Plan as directed by the plan administrator in accordance with the trust agreement.

c. Participant Contributions

Each eligible employee may elect to become a participant in the Plan by allowing the Company to reduce his or her pretax annual compensation by an amount that does not exceed applicable Internal Revenue Service regulatory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

d. Employer Contributions

The Company may make matching contributions and discretionary profit sharing contributions to the Plan. The Company made matching contributions of \$408,867 to the Plan for the year ended December 31, 2024. The contributions were based on a percentage of current compensation subject to certain limitations.

e. Participant Accounts

Each participant account is credited with the participant's elective contributions and allocations of employer contributions, if any, as well as Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

f. Vesting

Participants are immediately fully vested in their voluntary elective contributions, matching contributions and actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in profit sharing after five years of credited service.

g. Forfeitures

Participants who terminate their employment prior to becoming fully vested in their share of employer profit sharing contributions forfeit the unvested contributions. Such forfeited amounts are considered unallocated and may be applied to reduce future employer contributions or administrative fees.

h. Investment Options

The Plan offers participants a choice of investing in eighteen different mutual funds offered by the Custodians, each with a specific investment objective during the year. Participants may change investment option specifications daily with respect to contributions to be made in the future and with respect to their individual accounts.

1. Description of Plan - Continued

i. Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of one-half their vested account balance or \$50,000. Principal and interest are paid ratably through regular payroll deductions.

Loan defaults deemed to be uncollectible by the Plan during a plan year are to be recorded as taxable distributions to the defaulting Plan participants.

j. Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum distribution equal to the vested value of his or her account. The Plan also allows for hardship withdrawals from participants' elective accounts only. Participants must have first obtained all loans currently available through the plan before being eligible for a hardship withdrawal.

k. Administrative Expenses

Plan expenses are paid directly by the Company, whereas participant account administrative expenses are paid by the participants and deducted from their accounts annually.

l. Plan Administration

The Company is the Plan Administrator.

2. Summary of Accounting Policies

a. Basis of Accounting

The financial statements and supplemental schedule of the Plan are prepared using the accrual method of accounting, consistent with accounting principles generally accepted in the United States of America.

b. Payment of Benefits

The Plan records benefit payments to withdrawing participants when paid.

c. Investment Valuation and Income Recognition

Investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses during the year and the unrealized appreciation of investments at year-end.

Notes receivable from participants are valued at their outstanding amortized balances, which approximates fair value. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account.

d. Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

e. Subsequent Events

Subsequent events are events or transactions that occur after the balance sheet date but that could affect the amounts or disclosures in the financial statements. Management has evaluated subsequent events through the date that the financial statements are available to be issued, which is the date noted at the bottom of the auditor's report.

3. Related Party and Party In Interest Transactions

The Plan's investments are managed by Standard Retirement Services, Inc. Standard Retirement Services, Inc. is the custodian as defined by the Plan and therefore these transactions qualify as a party in interest.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Certification of Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodians, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule. The plan administrator has obtained certification from the Custodians stating that the information provided to the plan administrator by the Custodians for 2024 and 2023 is complete and accurate. Such information includes investments, investment income, realized gains and losses on sales of investments and unrealized appreciation or depreciation in market value of investments.

7. Tax Status

The Plan is a Prototype Non-Standardized Profit Sharing 401(k) Plan. The third-party administrator has obtained an Internal Revenue Service determination letter dated June 30, 2020 stating that the Plan, as designed, complies with the requirements under Section 401 of the Internal Revenue Code (the "Code"). The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. No provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates all significant tax positions and believes that it has not taken any tax positions that require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would increase or decrease within the next year. The Plan's income tax returns are subject to examination by applicable tax authorities generally for three years after filing.

8. Fair Value Measurements

The Plan follows generally accepted accounting principles, which establishes a framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan values mutual funds at the net asset value of shares held by the plan at year end. This method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes to the methodology used as of December 31, 2024 and 2023.

9. Fully Benefit-Responsive Investment Contracts

The Plan holds a traditional fully benefit-responsive guaranteed investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring Custodians, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% . The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

9. Fully Benefit-Responsive Investment Contracts - Continued

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.
