Notes to Financial Statements

Note 1: Description of Plan

The following description of the Hutchinson Regional Healthcare System Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Hutchinson Regional Medical Center, Inc. and its related employers Horizons Mental Health Center, Hospice of Reno County, Hutchinson Health Care Services, Inc., and Mainline, Inc. (collectively, the "Company"). Eligible employees can participate in the Plan as soon as administratively feasible following employment, provided they are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with regulations and guidance, and the Plan will be amended, as required.

Contributions

Each year, participants may contribute pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows for Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants with a deferral rate will have that deferral rate automatically increased by 1% annually on October 1 until a deferral rate of 15% is reached.

The Company may contribute a discretionary matching contribution to eligible participants, as defined by the Plan. For 2024, the Company matched 100% of up to 6% of compensation that a participant contributed to the Plan, which is credited to the participant each payroll period (paid annually prior to January 1, 2024). The Company made matching contributions of \$4,440,893, net of forfeitures applied, for the year ended December 31, 2024.

The Company may also contribute a discretionary profit sharing contribution to eligible participants, as defined by the Plan and determined annually by the Company. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Contributions (Continued)

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and allocations of the Company's discretionary profit sharing contribution and plan earnings (losses), and charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and rollover contributions, plus actual earnings (losses) thereon. Vesting in the Company's discretionary matching and discretionary profit sharing contribution portion of their accounts, plus actual earnings (losses) thereon, is based on years of credited service. Effective January 1, 2024, participants vest according to the following schedule:

Less than 2 years	- %
2 Years but less than 3 years	25 %

4 Years but less than 5 years	75 %
5 or more years	100 %

Participants who reach normal retirement age of 62, death, or permanent disability become 100% vested in the Company's discretionary contributions.

Payment of Benefits

On severance of service due to death, disability, retirement, termination, or for any other reason, a participant may elect to receive a lump sum amount or qualified joint and 50% survivor annuity payments (not less than 50% and not more than 100%) equal to the value of the participant's vested interest in his or her account, or installment distributions in an amount that meets or exceeds required minimum distribution amounts each year. If a participant's account balance is less than \$5,000, it can only be distributed in a lump-sum amount and may be involuntarily cashed-out to the participant by the plan administrator if less than \$1,000 or rolled into an individual retirement annuity account designated by the plan administrator if greater than \$1,000 and less than \$5,000.

Payment of Benefits (Continued)

In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon disability or attaining age 59 1/2 and permits qualified birth or adoption distributions up to an aggregate amount of \$5,000.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$128,730 and \$118,258, respectively. These accounts may be used to reduce Company discretionary matching or discretionary profit sharing contributions, or to pay reasonable plan expenses. Forfeitures in the amount of \$202,064 and \$6,166 were used to reduce Company discretionary matching contributions and to pay plan expenses, respectively, during the year ended December 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract (FBRIC)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participants' account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been a change in the methodology used to value mutual funds held in pooled separate accounts as of December 31, 2024, due to a change in judgment. There has been no change in the methodology used as of December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds held in pooled separate accounts: Valued daily at the quoted price of the underlying mutual funds, adjusted to apply the expense factor disclosed in the annuity contract. The calculated unit value is then compared to an account-driven unit value the following morning. The unit value is determined in a manner similar to a mutual fund NAV calculation by dividing the net assets by the number of units outstanding.

Note 4: Guaranteed Income Fund

The Plan maintains a fully benefit responsive investment in a Guaranteed Income Fund (GIF) with Empower Annuity Insurance Company (EAIC). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administration expenses. EAIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIF is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 4: Guaranteed Income Fund (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with EAIC, including plan termination and other events as specified in the GIF. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring.

Note 5: Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC ("Empower") and EAIC, collectively the Trustee of the Plan.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all Company discretionary contributions.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS opinion letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Party-in-Interest Transactions

Certain investments are managed by EAIC, the Trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. The Plan pays investment advisory fees and recordkeeping fees to Commonwealth Equity Services LLC DB and EAIC, respectively, which also qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
