Independent Auditor's Report

Opinion

We have audited the financial statements of Walgreens Co. and Local 648 Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Walgreens Co. and Local 648 Welfare Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Walgreens Co. and Local 648 Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Walgreens Co. and Local 648 Welfare Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note 1 - Description of the Plan

The following brief description of the Walgreens Co. and Local 648 Welfare Plan (the Plan) is provided for general information purposes only. Employees should refer to the summary plan description for more complete information.

General

The Plan was established on February 1, 1989, for the purpose of providing health and welfare benefits to eligible participants covered by the collective bargaining agreement between Walgreen Co. (the Company) and Local 648 of the United Food and Commercial Workers International Union (UFCW). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of the Plan is the responsibility of the Board of Trustees (the Trustees) and is governed by a joint board consisting of equal representation from the Walgreen Co. and the Local 648 of the United Food and Commercial Workers International Union.

Benefits

Under the Plan, active employees and their dependents are eligible for benefits in accordance with the medical, dental, vision, and prescription drug component plans. Retirees who have met criteria outlined in the summary plan description are eligible for benefits under the medical, dental, vision, and prescription drug component plans.

Plan benefits for dental, vision, and prescription drug claims are self-insured. The claims are processed by third-party administrators under Administrative Services Only (ASO) arrangements. The administrators pay claims directly to or on behalf of employees and are then reimbursed by the general assets of the Plan. Despite the use of third-party administrators, ultimate responsibility for payments to providers and employees is retained by the Plan.

The Plan fully insures the medical benefits. The Plan purchases annual insurance contracts for these insured benefits. Premiums for all insured benefits are paid from contributions received from employees and the Walgreens Co.

The Plan uses a Pharmacy Benefits Manager (PBM) which periodically makes refunds to the Plan based on the utilization pattern of specific drugs.

Contributions and Eligibility

In addition to deductibles, copayments and coinsurance, employees may be required to contribute to premium costs for the health care (medical). The required employee contribution is equal to 25% of the cost of benefit coverage.

The cost of the post-retirement benefit plan is shared by the Walgreens Co. and retirees. For 2024 and 2023 the contributions made by retirees for medical benefits were 25% of the cost of the benefit coverage.

The Company makes contributions to the Plan as needed to fund claims in excess of employees' contributions. The Plan's unfunded benefit obligations at December 31, 2024 and 2023, relate primarily to the portion of postretirement benefit obligations not covered by employee contributions. Any deficiency of the Plan's net assets over the benefit obligations is funded by the Company on a pay-as-you-go basis.

Only employees who were in covered employment as of January 1, 2015 are eligible to participate in the Plan.

Employees maintain their eligibility by working at least ninety-six (96) hours of covered employment in each calendar month. There is a two-month lag in coverage. This means that the ninety-six (96) hours the employee works in January gives them coverage for benefits in March, and so on for each month.

All employees hired on or after October 1, 2010 shall not be entitled to retiree benefits.

Plan Termination

Although it has not expressed any intention to do so, the Trustees have the right under the trust agreement to modify the benefits provided to, and contributions required of, employees to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in the ERISA. Upon termination of the Trust, all obligations shall first be satisfied. The Board shall thereupon use the remaining Trust assets to provide benefits in such manner as the Plan may provide, or in the absence of such provision, to continue to provide benefits in a manner permitted by ERISA for so long as Trust assets permit. No assets of the Plan may revert Walgreens, Co. or be used for purposes other than for the exclusive benefit of the Plan's employees.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Employer Contributions, Contributions Receivable, and Allowance for Credit Losses

The Plan's policy is to recognize contributions based on the contributions needed to fund claims in excess of employees' contributions. Contributions paid by the employer after year end to fund claims paid based on eligibility earned as of December 31, 2024 and 2023 are recorded as contributions receivable. Management of the Plan evaluates participating employers' contributions receivable periodically for potential credit losses based on historical experience as well as current and reasonable and supportable forecasted economic conditions. As of December 31, 2024 and 2023 there was no allowance taken.

Payment of Benefits

Claims and premiums are recorded when paid. Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claims payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Refunds and Rebates

Prescription refunds from the Plan's PBM are recorded when earned. Refunds due at year-end are recorded as are receivable on the statements of net assets available for benefits, with the offset being netted against claims paid. Pharmacy rebates for the years ended December 31, 2024 and 2023 totaling \$541,944 and \$463,943, respectively, are netted against claims paid in self-funded benefits in the accompanying statements of changes in net assets available for benefits.

Expenses

The Plan's expenses are paid by the Plan as specified in the plan provisions. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Current Benefit Obligations

As a result of the eligibility provisions of the Plan, hours worked by participants through December 31, 2024 and 2023, produced eligibility through February 2025 and 2024, respectively, for active participants. Accordingly, group insurance premiums and claims incurred are accrued on the basis of hours worked through December 31, 2024 and 2023, and eligibility through February 2025 and 2024, respectively. These amounts are recorded as amounts currently payable on the statements of benefit obligations.

The liabilities for future payment of claims incurred but not reported at December 31, 2024 and 2023, have been estimated based upon claims data provided by the Plan's third-party administrators and historical lag information. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Postretirement Benefit Obligations

Postretirement benefit obligations have been recognized for retiree medical, dental, vision, and prescription drug benefits for eligible employees and their dependents. The amount reported as the postretirement benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed to by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from Walgreens, Co. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) eligible active employees and the beneficiaries and dependents after retirement from service with Walgreens, Co.

The actuarial present value of the expected postretirement benefit obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per employee and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a weighted average of 7.0% and 12% of medical and prescription drugs, respectively, for pre-65 coverage, and 6.0% and 12% of medical and prescription drugs, respectively, for post-65 coverage as the annual rates of increase in the average per capita cost of covered health care benefits were assumed for 2024; the rates were assumed to decrease gradually to 5.0% for both pre and post 65 coverage by 2033 and to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligations at December 31, 2024.

The weighted-average health care cost-trend rate assumption has a significant effect on the postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$11,637,597 and \$9,465,262, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Changes in assumptions for the year ended December 31, 2024 include the change in the discount rate from 5.44% to 5.19%, updates to assumed retirement age, updates to termination, and trend rates.

Changes in assumptions for the year ended December 31, 2023 include the change in the discount rate from 4.73% to 5.44%, updates to assumed retirement age, updates to termination, and trend rates.

The Plan's excess of benefit obligations over net assets at December 31, 2024 and 2023, relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current collective bargaining agreements. However, the postretirement benefit obligation is contingent upon a variety of assumptions about future events. Actual experience is likely to vary from these assumptions. The calculation of an accounting obligation does not, in and of itself, imply that there is any legal liability to provide the benefits valued, nor is there any implication that the welfare plan is required to implement a funding policy to satisfy the projected expense.

Concentration of Credit Risk

The Plan maintains its cash in bank deposit accounts which may exceed federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At December 31, 2024 and 2023, the Plan did not have cash in excess of FDIC-insured limits.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

Claims and premiums that have been processed and approved for payment at year-end, but not paid, and claims incurred but not reported are not considered liabilities under generally accepted accounting principles and, therefore, are not presented as liabilities in the accompanying financial statements but are recorded on the Form 5500 as a liability.

Note 4 - Related Party and Party-in-Interest Transactions

As described in Note 2, the Plan pays fees for several arrangements with service providers and affiliated entities. These transactions are considered exempt party-in-interest transactions under ERISA.

Note 5 - Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care trends and employee demographics, all of which are subject to change. The benefit obligation for claims incurred but not reported was calculated using claims data through a point in time as a basis for the estimate. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Note 6 - Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated May 30, 1990, stating that the trust is tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the related trust is tax-exempt. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


