Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplementary information listed in the table of contents is presented for purposes of additional analysis and are not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. In our opinion, the information in the accompanying supplementary information is fairly stated, in all material respects, in relation to the financial statements as a whole.

Note 1. Description of the Plan

The following is a brief description of the LVMH Moët Hennessy Louis Vuitton, Inc. and Affiliates Medical and Dental Benefit Plan (the Plan). Participants should refer to the Plan documents, including administrative contracts, available from the plan administrator, for a complete description of the Plan's provisions.

Plan assets are held in a Voluntary Employees' Beneficiary Association (VEBA) trust.

The Plan is a single employer benefit plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

The Plan is a contributory medical and dental plan offered to eligible employees (and their dependents) of LVMH Moët Hennessy Louis Vuitton, Inc. (LVMH) and its affiliates. LVMH and its affiliates make contributions to the Plan based on the recommendations of the Plan's consulting actuary.

Benefits

The Plan provides hospital, surgical, medical, major medical, dental, optical and prescription drug benefits for eligible employees and their dependents. These benefits are provided on a self-insured and on an insured basis. Employees are eligible to participate in the Plan on the first day of the month following their date of hire. Employees hired on the first day of the month are eligible to participate on their date of hire. The Plan also provides supplemental benefits to certain eligible retirees for whom Medicare is the primary carrier. The Plan provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

The Plan is administered by LVMH Moët Hennessy Louis Vuitton, Inc. (the Sponsor), via its Trustee. United HealthCare has been contracted by the Plan to act as the medical claims administrator. In addition, MetLife has been contracted as the dental claims administrator. Covered claims for self-insured benefits are processed by the Plan's claims administrators under administrative services only (ASO) arrangements. The claims administrators review, verify, and pay claims submitted by participants in accordance with the administrative service contracts entered into by LVMH with the claims administrators. The claims administrators pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claims administrators, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, benefit claims incurred but not reported (IBNR), claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Claim payments are recorded when paid by the Plan's third-party medical claims administrators. Amounts due to medical claims administrators that have yet to be reimbursed by the Plan are recorded as payable in the accompanying statements of net assets available for benefits and plan benefit obligations. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits and plan benefit obligations.

Allocations

Amounts reported as administrative expenses in the statements of changes in net assets available for benefits and plan benefit obligations are derived from allocations of expenses, which are applicable to this plan and the LVMH Moët Hennessy Louis Vuitton, Inc. and Affiliates Flexible Spending Plan.

Benefit Obligations/Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits for certain eligible retirees. Postretirement benefits include future benefits expected to be paid to or for the grandfathered group of currently retired or terminated employees and their beneficiaries and dependents that had coverage prior to the elimination of the benefit.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Other Plan Benefits

Plan benefit obligations at December 31 for benefit claims incurred but not yet reported are estimated by the Plan's actuary, Aon Hewitt, in accordance with accepted actuarial principles. These estimates are based on a combination of the historical runoff of claims and the claim patterns for the experience under the Plan. Such estimated amounts are reported in the accompanying statements of net assets available for benefits and plan benefit obligations. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

Management's Review of Subsequent Events

Management has evaluated subsequent events for the Plan through October 13, 2025, the date that the financial statements were available to be issued.

Note 4. Party-in-Interest Transactions

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 5. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 6. Tax Status

The Plan was established May 1, 1994. The VEBA trust funding the plan received a favorable ruling from the Internal Revenue Service, dated December 27, 1995, stating that the Trust is qualified under Internal Revenue Code (IRC) Section 501(c)(9), and is not subject to tax under IRC Section 501(a). The Plan sponsor believes that the Plan, as amended, continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan's management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Employee benefit plans are subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan. The Plan's management believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Procedures on Termination of the Plan

While it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan, at any time, subject to the provisions set forth in the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In the event of termination of the Plan, the Sponsor shall pay or provide for the payment of any and all obligations of the Plan, and shall distribute and apply any remaining surplus in such a manner as will, in its opinion, best effectuate the purpose of the Plan.


