NOTE A – DESCRIPTION OF PLAN

The following description of the Collaborative Industries, Inc. 401(k) Profit Sharing Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which is a defined contribution plan covering certain groups of employees of Collaborative Industries, Inc., Quality First Insurance LLC, The Community Supports Network, Inc., and Collaborative Ventures, LLC (collectively, the Company). Employees of Collaborative Industries, Inc. and Quality First Insurance LLC are eligible to participate in elective deferrals on their date of hire. Employees of The Community Supports Network, Inc. and Collaborative Ventures, LLC must complete one year of service with at least 1,000 hours in the Plan year to be eligible to make elective deferrals. Entry is available every day of the Plan year for Collaborative Industries, Inc. and Quality First Insurance LLC. Entry is available first day of the Plan year and the first day of the seventh month of the Plan year for The Community Supports Network, Inc. and Collaborative Ventures, LLC. Effective March 30, 2023, Quality First Insurance, LLC was sold and participation in the Plan was revoked. All participants of Quality First Insurance, LLC became fully vested. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In September 2025, the Plan moved to a recordkeeper and service Provider, Union Bank and Trust Company. Upon the transition, age and service eligibility requirements were removed and entry dates were changed to monthly for all contribution types.

Contributions

Each year, eligible employees may make pre-tax salary and Roth reduction contributions to the Plan not to exceed Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their pre-tax contributions are invested in a designated target date fund that matches their retirement date based on their birthday until changed by the participant.

Contributions (Continued)

The Company may make a discretionary matching contribution of the participant's elective deferrals or a discretionary profit-sharing contribution. The Plan also allows for a safe harbor contribution, if notice is given through the annual election. Discretionary contributions are determined on a per pay period basis. In 2024 and 2023, the Company made a matching contribution of an amount equal to 50% of each participant's elective deferral up to 6% of the participants compensation.

There were no profit-sharing contributions for the years ended December 31, 2024 and 2023.

Participants' Accounts

Each participant's account is credited with the participant's contributions, and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts is based on years of continuous service, as set forth in the following table:

Participants are also vested if they are an employee and reach normal retirement age, upon death, or total permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Interest rates on loans outstanding at December 31, 2024 and 2023 were between 4.25% and 9.50%. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On separation of service due to death, disability, retirement, or termination, a participant may elect to receive the vested portion of his or her account. The plan also allows for in-service distributions upon attainment of age 59 ½ and before age 59 ½ due to financial hardship, as defined in the plan document.

Forfeitures

Forfeitures, if any, are used to restore account balances where restoration contributions have been made pursuant to the Plan, and then to pay Plan expenses or employer contributions, if applicable. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,407 and \$6,533, respectively. During the year ended December 31, 2024, \$8,256 of the forfeiture balance was used as employer contributions to the Plan.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded for the years ended December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for the administration of the Plan are the responsibility of the Plan. If incurred directly by the Plan, these expenses are included in administrative expenses on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation of fair value of investments.

Income Taxes

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 1, 2025, the date at which the financial statements were available to be issued.

For institutional funds, NAVs are received daily from fund managers, and the managers stand ready to transact at these quoted amounts.

Were the plan to initiate a full redemption of the trust, the insurance company custodian reserves the right to temporarily delay payment from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – TAX STATUS

The Plan is based on the MandMarblestone PC Non-Standardized Pre-Approved Profit Sharing Plan With CODA Plan, which received a determination letter from the IRS dated June 30, 2020, stating that the Pre-Approved Plan was designed in accordance with provisions of the Internal Revenue Code (IRC). The plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods prior to December 31, 2021.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan receives custodial services from John Hancock Life Insurance Company, the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also receives recordkeeping services from John Hancock U.S.A, investment advisory services from Hightower Advisors, LLC, and contract administration services from the MandMarblestone Group LLC. These transactions qualify as party-in-interest transactions.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I – PROHIBITED TRANSACTIONS

The Plan deposited associated earnings on the delinquent contributions in 2024.
