Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules (modified cash basis), other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules (modified cash basis) that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following brief description of IES Retail LLC 401(k) Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan was established on November 1, 2016 coinciding with the commencement of operations of Island Energy Services, LLC (IES) the parent of IES Retail, LLC (the Company or Plan Sponsor). IES and the Company were formed to acquire the Hawaii based assets and operations of Chevron Corporation (Chevron).

The Plan is a defined contribution retirement plan, which covers substantially all employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The administration of the Plan is the responsibility of a special administrative committee (the Committee) appointed by the Board of Directors of the Company. Plan assets are held by and investment transactions are executed by Vanguard Fiduciary Trust Company (Vanguard), the Plan's trustee.

b. Eligibility

Non-exempt employees are eligible to participate in the Plan upon completion of a 12-month period of service. Exempt employees are eligible to participate in the Plan upon hire.

c. Contributions

Pre-Tax Elective Deferrals - Participants may designate a percentage (up to 75 percent) of their eligible compensation to contribute on a pre-tax basis to the deferred account. Under Plan provisions, the participant's contribution may not exceed the maximum permitted by the Internal Revenue Code (IRC).

Roth Elective Deferrals - In lieu of making deferred cash contributions and catch-up contributions on a pre-tax basis, a participant may elect to have some or all of the deferred cash contributions and/or catch-up contributions that otherwise would be contributed to the Plan on a pre-tax basis designated as Roth contributions or Roth catch-up contributions, as applicable.

1. Description of Plan (continued)

c. Contributions (continued)

Catch-Up Deferrals - In accordance with the IRC, participants who are over age 50 or reach age 50 during the Plan year may make additional catch-up contributions. The maximum annual catch-up contribution is \$7,500 for 2024.

Nondeductible Contributions – Participants may designate a percentage of their eligible compensation to contribute on a post-tax basis to the deferred account. Under Plan provisions, the participant’s contribution may not exceed the maximum permitted by the IRC.

Matching Contributions – Participants who contribute up to 1 percent of their compensation, excluding catch-up deferrals, receive a 2.5 percent matching contribution. Participants who contribute in excess of 1 percent up to 2 percent of their compensation receive a 5 percent match.

Safe Harbor Contributions – Participants are eligible to receive a 3 percent safe harbor employer contribution.

Discretionary Employer Contributions - Profit sharing contributions to the Plan are determined at the discretion of the Committee and are allocated to participants on a pro-rata basis. To be eligible for discretionary employer contributions, a participant must complete a 12-month period of service.

d. Participant Accounts

Each participant’s account is credited with the participant’s contributions, matching and profit sharing contributions from the Company, and allocations of net earnings and losses from the Plan’s investments in proportion to individual participant balances in such investments on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account balance.

e. Vesting

Participants are 100% vested after 3 years of service in their employer and matching contributions. Prior to the third year of service, the vesting percentage is zero. Participants are vested immediately in their employee and safe harbor contributions.

1. Description of Plan (continued)

f. Forfeitures

Participants' nonvested account balances are considered forfeitures upon distribution and are used to reduce employer contributions or reduce the Plan's administrative expenses.

g. Payment of Benefits

On termination of service due to death, disability, retirement, or termination for other reasons, a participant may elect to receive distributions in the form of a lump-sum amount equal to the value of the participant's vested interest in his or her account.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan document. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document, and in accordance with the IRC.

h. Notes Receivable from Participants

Promissory notes receivable from Plan participants are carried at their unpaid principal balances. Participants may borrow from their accounts up to a maximum of the lesser of: (a) \$50,000 reduced by the excess of the highest outstanding balance of the notes from the Plan to the participant during the one-year period ending on the day before the date on which such note is issued, over the outstanding balance of notes from the Plan to the participant on the date on which such note was issued, or (b) 50 percent of the present value of the non-forfeitable accrued benefit of the employee under the Plan. The notes are secured by the balance in the respective participant's account, bear interest at rates from 1.00 to 15.75 percent at December 31, 2024 and mature on various dates through October 2029. Principal and interest are paid ratably through bi-weekly and semi-monthly payroll deductions.

i. Expenses of the Plan

Administrative expenses are recorded when paid by the Plan to the extent permitted under ERISA. To the extent any expenses of the Plan are not paid from Plan assets, the Plan Sponsor pays such expenses. Investment-related expenses are included in net appreciation of fair value of investments. For the year ended December 31, 2024, \$4,875 of administrative expenses were paid by the Plan participants for whom the fees relate to.

j. Rollovers

Rollovers consist of contributions from employees' previous retirement plans. For the year ended December 31, 2024, there were approximately \$182,000 of rollover contributions.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

As permitted by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan maintains its records on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). This basis differs from U.S. GAAP in that participant and employer contributions are recognized when received instead of when earned, and administrative expenses are recognized as paid instead of when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to be presented in conformity with U.S. GAAP.

b. Management's Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts and disclosure. Accordingly, actual results may differ from these estimates.

c. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of Benefits

Benefits paid to participants are recorded when paid.

e. Risks and Uncertainties

The Plan invests in various mutual funds. Mutual funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with mutual funds, it is at least reasonably possible that changes in the values of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

f. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, and it was determined that all subsequent events had been properly accounted for.

3. Information Certified by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard, a qualified institution. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

4. Fair Value Measurements

The modified cash basis of accounting utilizes a framework established by U.S. GAAP for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodology used as of December 31, 2024 and 2023.

Mutual Funds – Valued at the quoted net asset value of the shares held by the Plan at the reporting date.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, the Plan classifies its mutual funds carried at fair value in the amounts of \$2,455,629 and \$1,537,042, respectively, as level 1 investments.

5. Tax Status

Effective January 1, 2022, the Plan was restated and adopted under Vanguard's non-standardized pre-approved plan, which received a favorable Internal Revenue Service (IRS) opinion letter dated June 30, 2020.

Since the date of the opinion letter, the Plan has been amended; however, the plan administrator believes the Plan is designed and operated in compliance with the applicable provisions of the IRC and continues to qualify as tax-exempt. Hawaii income tax law conforms to the IRC; therefore, no provision for federal or state income taxes has been included in the Plan's financial statements.

The modified cash basis of accounting applies the framework established by U.S. GAAP, which requires plan management to evaluate tax positions taken by the Plan and recognize a liability for any tax position that is more likely than not to be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, the Plan has maintained its tax exempt status and, in light of the planned correction of any operational defect, had no uncertain positions that require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits in progress. Plan years ended December 31, 2021, and forward remain open for examination for federal tax purposes.

5. Tax Status (continued)

To determine whether the Plan is operating in accordance with the requirements of the Plan document and the IRC, compliance tests are required to be performed at least annually. The Plan Sponsor is in the process of completing these tests. Any failure may require correction through additional contributions to the Plan or the refund of excess contributions to participants. The Plan Sponsor expects to complete the testing by December 31, 2025, and does not believe the results will have a material impact on the Plan's financial statements or tax-qualified status.

6. Exempt Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Vanguard. Vanguard is the trustee, and, therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.

7. Plan Termination

Although it has not been expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participations would become fully vested in their employer contributions.

8. Nonexempt Transactions

During 2024, the Company deposited participant deferrals subsequent to the timeframe required by the Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Plan Sponsor intends to remit lost earnings related to \$3,169 of late contributions and loan repayments for the 2024 Plan year in 2025.
