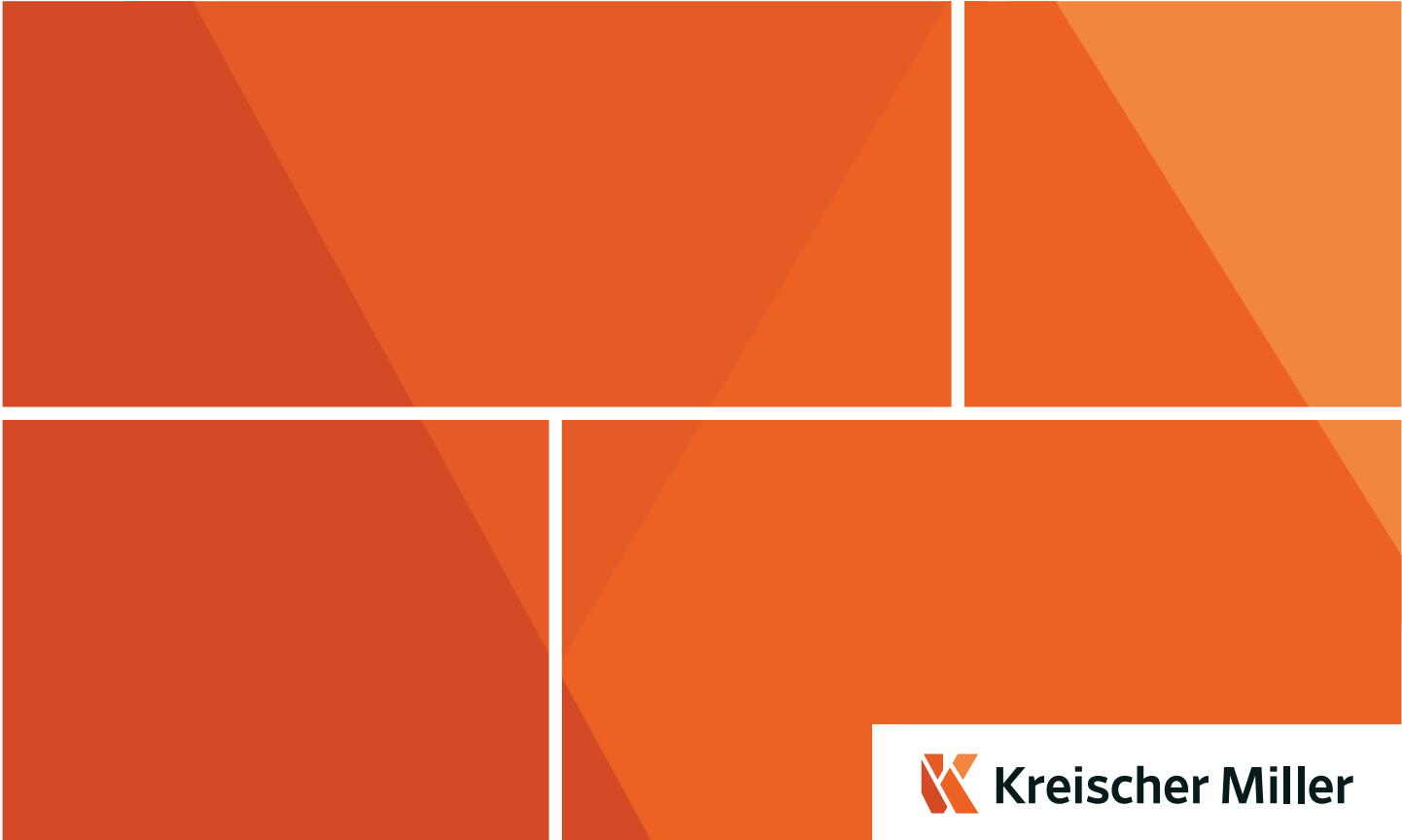

## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of NWL, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedules Required by ERISA***

The supplemental Schedule H, Line 4a – Schedule of Delinquent Participant Contributions and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of or for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### (1) Description of Plan

The following summary description of the NWL, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan covering substantially all employees of NWL, Inc. (Company), with the exception of union employees, non-resident aliens and leased employees, who have two consecutive months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### *Contributions*

Each year, participants may make salary deferral contributions as a percentage of annual compensation, as defined in the Plan, up to the maximum allowable amounts per the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants are also permitted to make Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2015, the Plan implemented an automatic enrollment provision whereby newly hired employees are enrolled at 2% unless they elect otherwise.

The Company may elect to make discretionary matching contributions to the Plan at a fixed percentage determined by the Company. The Company may also elect to make a discretionary profit sharing contribution to those employees that have met the one year of service requirement and are employed at the end of the plan year. The contribution will be allocated among eligible participants in the same proportion that each participant's compensation bears to the total compensation of all participants within the group. Participants must be 21 years of age to receive a Company contribution.

Effective January 1, 2023, the Plan was amended to include Safe Harbor Non-elective contribution provision of 3% of plan compensation. Safe harbor eligibility conditions follow the conditions established for elective deferrals. Pay earned before participation is included in the definition of plan compensation for purposes of safe harbor contributions. The Company submitted these contributions on a quarterly basis during 2024 with contributions for the last quarter funded in 2025, which is presented as employer contributions receivable on the accompanying statements of net assets available for benefits.

#### (1) Description of Plan, Continued

##### *Participant Accounts*

Each participant's account is credited with the participants' contribution and allocation of the Company's contribution and plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service on a six year graded vesting schedule. A participant is 100% vested after six years of credited service. A participant becomes fully vested upon death or total and permanent disability.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. Loan transactions are treated as a transfer from the investment fund to the participants' note fund. The maximum loan term is five years, unless the loan is obtained for the purchase of the participant's primary residence. The loans are secured by the balance in the participants' accounts and bear interest at the prime lending rate plus 1.5% at the time the loan is made and range from 4.75% to 10% at December 31, 2024, which is commensurate with the local prevailing rates as determined by the plan administrator.

##### *Payment of Benefits*

Upon retirement (or death), a participant may elect to receive a lump-sum amount equal to the value of his or her account.

##### *Forfeitures*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$55,771 and \$17,422, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. During 2024, no forfeitures were used to pay administrative expenses or reduce employer contributions.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Contributions*

Contributions from plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

#### (3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), a qualified institution.

In addition to the assets held at John Hancock, the following investments and related transactions were held and transacted by Bank of New York Mellon are excluded from the certification.

- Cash and cash equivalents, common stock, U.S. treasury securities, warrants and real estate investment trusts totaling \$11,951,133 and \$10,590,030, respectively.
- Net appreciation of investments held totaling \$1,953,653 for the year ended December 31, 2024.

#### (4) Non-Participant Directed Investments

Profit sharing contributions are invested by the plan trustees. The plan administrator is J. David Seitz. The trustees of the Plan are J. David Seitz and Robert Seitz from January 1, 2024 to July 31, 2024. Effective August 1, 2024, John Hancock Trust Company LLC was appointed trustee of the Plan. Hutner Capital Management acts as investment advisor for the non-participant directed investment portion of the Plan. On an annual basis, participants have the option to transfer their entire profit sharing balance out of non-participant directed investments and into participant-directed investments.

#### (5) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Common stock, warrants and real estate investment trusts:* Valued at the closing price reported on the active market on which the individual securities are traded.

*U.S. treasury securities:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing the value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks or a broker quote if available.

*Pooled separate accounts:* Valued at the net asset value (NAV) of units held by the Plan at year end based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market. In accordance with the FASB issued Accounting Standards Update (ASU) 2015-07 (ASU 2015-07), *Fair Value Measurement (Topic 820): Disclosure for Investments in Certain Entities That Calculate NAV per Share (or Its Equivalent)*, certain investments that are measured at NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

#### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### (7) Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by John Hancock. John Hancock is the custodian as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

#### (8) Prohibited Transactions

During 2023, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling approximately \$15,598 within the period prescribed by DOL regulations. During 2022, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling approximately \$7,094 within the period prescribed by DOL regulations.

#### (9) Tax Status

The Plan uses a volume submitter plan document sponsored by Delaware Valley Retirement Inc. Delaware Valley Retirement Inc. obtained an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in accordance with the applicable requirements of the IRS.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
