REPORT OF INDEPENDENT ACCOUNTANTS

The Trustees

Legal Aid Services of Oregon Retirement Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Legal Aid Services of Oregon Retirement Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Legal Aid Services of Oregon Retirement Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Legal Aid Services of Oregon Retirement Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Legal Aid Services of Oregon Retirement Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Legal Aid Services of Oregon Retirement Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Legal Aid Services of Oregon Retirement Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS

YEAR ENDED DECEMBER 31, 2024

1. Description of the Plan

The following is a brief description of the Legal Aid Services of Oregon Retirement Profit Sharing Plan (the “Plan”), and is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan established for the exclusive benefit of employees of Legal Aid Services of Oregon (“LASO”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), and covers all employees of Legal Aid Services of Oregon who have completed six months of service and are age 18 or older. Participation commences on the first day of the calendar quarter following fulfillment of eligibility requirements. Ascensus Trust Company is the Plan’s trustee and, as such, has responsibility for managing the Plan’s assets, subject to the direction of the direction of LASO, the plan sponsor and plan administrator.

Plan Contributions – Participants may contribute a portion of their compensation by means of payroll deductions, either as a pre-tax salary deferral contribution or a Roth salary deferral contribution, subject to certain discrimination tests and the limits prescribed by the Internal Revenue Code. LASO may make discretionary contributions to the Plan. Employer contributions are allocated among all eligible employees based upon an employee’s qualifying compensation as a percent of qualifying compensation for all eligible employees.

Participants’ Accounts – Each participant’s account is credited with the participant’s contributions and allocation of (a) LASO’s contributions, and (b) Plan earnings; and charged with an allocation of investment expenses. Plan earning and investment expense allocations are based on the

participant’s investment types and account balance, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are 100% vested in their salary deferral contributions and their rollover contributions upon entry into the Plan. A participant is 100% vested in LASO’s contributions after one year of credited service.

Notes Receivable from Participants – Loans are permitted with the approval of the Plan administrator. Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Any loan by its terms requires that repayment (both principal and interest) be amortized in equal payments, over a period not to exceed five years, except if the loan is for the purchase of a primary residence. The outstanding loans are secured by the balance of the participant’s account and bear interest at rates ranging from 5.25% to 8.50%, which are commensurate with commercially reasonable rates determined by the trustee at the time of the loan.

Payment of Benefits – On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in his or her account. The participant may elect to remain invested in the Plan if the participant’s account exceeds \$5,000. The participant may be subject to minimum distribution requirements, which would result in regular distributions to the participant or the joint lives of the participant and a designated beneficiary over a period not to exceed the life expectancy of the participant or last surviving beneficiary.

Forfeiture Disposition – Participants are always fully vested in their deferral and rollover contributions to the Plan and the income thereon. If a participant terminates service prior to becoming fully vested in employer contributions, any account balance that is not vested is subject to forfeiture and will be used to reduce future employer contributions or reallocated in accordance with the provisions of the Plan. There were \$1,776 in forfeitures for the year ended December 31, 2024. During the year ended December 31, 2024 no forfeitures were used to reduce employer contributions, pay plan expenses or reallocated. At December 31, 2024, unallocated funds totaling \$22,906 were available in the forfeiture accounts.

Eligibility Requirements – All employees of Legal Aid Services of Oregon are eligible to participate in the Plan after attainment of 18 years of age and a minimum service requirement of six months. Employees may enter the Plan on January 1st, April 1st, July 1st, or October 1st, after or coincident to the fulfillment of the service requirements. All eligible participants are qualified to receive employer contributions.

Hardship Provisions – Upon approval of the plan administrator and in accordance with the plan document, participants may make taxable withdrawals for reasons of immediate and heavy financial need, as defined by the Internal Revenue Code.

Plan Termination – Although it has not expressed any intent to do so, Legal Aid Services of Oregon has the right to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants become 100% vested.

Administrative Expenses – The Plan's assets may be used to pay certain administrative expenses. Certain fees related to investment transactions are deducted directly from participant accounts. Fees charged by other parties, including audit fees, are paid by the sponsor.

Party-in-Interest Transactions – During the year ended December 31, 2024, employees of Legal Aid Services of Oregon, the Plan's sponsor, were participants in the Plan. Certain plan investments are managed by the sponsor of the Plan; therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, fees paid by the Plan for administrative expenses totaled \$28,602 of which \$16,102 represented fees paid to The Vanguard Group, Inc., the third-party administrator, and \$12,500 paid to Morgan Stanley Global, investment advisors to the Plan. These qualify as party-in-interest transactions. Additional fees incurred by the Plan for investment management services are included in the net appreciation (decline) in fair value of the investments.

Tax Status – The Plan has adopted a prototype plan document, and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the prototype plan has been amended since receiving the opinion letter, the Plan's administration believes that the Plan is designed and currently is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

2. Summary of Accounting Policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates – The preparation of the Plan’s financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. In the opinion of management, such differences, if any, would not be significant.

Investments – Investments in mutual funds and self-directed brokerage accounts are carried at fair value. Common collective trust funds are reported at fair value, using the net asset value (NAV) practical expedient. NAV represents the plan’s fair value since this is the value at which the plan transacts with the common collective trusts. Investment contracts are carried at contract value. Net appreciation (decline) in the fair value of investments consists of the realized gains or losses and the unrealized appreciation (decline) of those investments. Security transactions are recorded on a trade date basis.

Risk and Uncertainties – Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances, plus any accrued unpaid interest. Delinquent participant loans are reclassified as disbursements based on the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Concentration of Credit Risk – A significant portion of the Plan’s assets are invested in mutual funds and a collective trust. Self-directed accounts are invested in mutual funds, common stocks and cash equivalents.

Subsequent Events – Subsequent events have been evaluated by management through October 6, 2025, which is the date the financial statements were available to be issued.

Other Significant Accounting Policies – Other significant accounting policies are set forth in the financial statements and the following notes.

3. Information Prepared and Certified by the Trustee

The Plan has obtained certifications from Ascensus, LLC, as an agent of Ascensus Trust Company, that the information provided by them is complete and accurate. The information certified by them includes:

- Details and summaries of investments at fair value and other assets as of December 31, 2024 and 2023;
- Details and summaries of net appreciation in the fair value of Plan investments during the year ended December 31, 2024; and
- Details and summaries of interest during the year ended December 31, 2024.

5. Fair Value Measurements

The accompanying financial statements report certain investments of the Plan at fair value. These assets have been classified, for disclosure purposes, based on a hierarchy that gives the highest ranking to fair values determined using unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest ranking to fair values determined using methodologies and models with unobservable inputs (Level 3). Investments valued using the NAV practical expedient are excluded from the fair value hierarchy.

At December 31, 2024 and 2023, the Plan's financial assets that are included in the fair value hierarchy consist of investments which are measured at fair value on a recurring basis using quoted prices for identical assets (i.e., Level 1).
