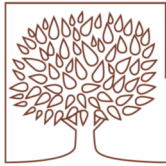

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of VERBIO North America Corporation 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

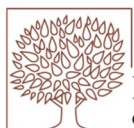

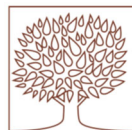

Note 1: DESCRIPTION OF PLAN

The following description of the VERBIO North America Corporation 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes. Participants should refer to the Plan document for more complete information.

General — The Plan is a defined contribution plan covering all eligible employees of VERBIO North America, LLC (the "Employer" or the "Company"). Transamerica Financial Life Insurance Company, Inc. serves as the trustee of the Plan and Future Plan provides third party administrator services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility — Employees are eligible to make salary deferral contributions upon completion of three months of service. Eligible employees begin participating in the Plan on the first day of the month following the satisfaction of the eligibility requirements. Participants are eligible to receive profit sharing contributions and non elective safe harbor contributions upon completion of three months of service.

Contributions — Each year, participants may contribute up to 100% of pre-tax annual compensation, not to exceed Internal Revenue Code limitations, as defined in the Plan document. Eligible employees may also elect to contribute an additional portion of their after-tax compensation, as permitted by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts as investment options for participants.

The Company provides a non elective safe harbor contribution of 3% of plan compensation. The Company may also elect to make a discretionary profit sharing contribution in any plan year. A discretionary profit sharing contribution of 2% of plan compensation was made during the year ending December 31, 2024. The safe harbor and profit sharing contribution made by the Company during the year ended December 31, 2024 was \$581,858 and \$391,264, respectively.

Participant Accounts — Individual accounts are maintained for each participant and are credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of plan losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting — Participants are vested immediately in their contributions, non elective safe harbor contributions, and profit sharing contributions plus actual earnings thereon.

Payment of Benefits — Upon termination of service for any reason, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Participants with a vested account balance greater than \$5,000 may defer payment until a later time.

Withdrawals from a participant's salary deferral and rollover accounts may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants who are at least 59 1/2 years of age may withdraw all or a portion of the balance in their vested account balances prior to termination for any reason.

Note 1: DESCRIPTION OF PLAN (continued)

Forfeited Accounts — Forfeitures of nonvested employer contributions are used to offset administrative expenses or to reduce future employer contributions. During the year ended December 31, 2024 no forfeitures were used. There were \$1,623 of forfeitures available as of December 31, 2024.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value for each type of investment held by the Plan, which includes gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates — The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make certain estimates and assumptions that affect the reported amount of net assets available for benefits and contingent assets and liabilities at the date of the financial statements, and the stated amount of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risk and Uncertainties — The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Excess Contributions Payable — The Plan is required to return contributions received during the Plan year in excess of IRC limits. As of December 31, 2024, there were no excess contributions payable on the accompanying statement of net assets available for benefits. Excess contributions payable are reported as a reduction to employee contributions.

Benefit Payments — Benefit payments to participants are recorded upon distribution. There are no amounts allocated to accounts of persons who have elected to withdraw from the Plan but had not yet been paid as of December 31, 2024.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Expenses — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment management expenses are paid directly by the Plan and are also included in administrative expenses, while other investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events — The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 3: FAIR VALUE MEASUREMENTS

The Plan values its assets and liabilities based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels as follows:

Level 1- Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.

Level 2- Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in inactive markets or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data.

Level 3- Unobservable inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

In determining fair value, the Plan utilizes valuation techniques that maximize the use of quoted and observable inputs and minimize the use of unobservable inputs to the extent possible as well as considers counterparty credit risk in its assessment of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled Separate Accounts — Valued at the net asset value (NAV) per unit or shares held by the Plan at year end. Pooled separate accounts are excluded from the three level fair value hierarchy defined above. On a participant level, issuances and redemptions of units or shares in pooled separate accounts can be made on each business day without limitation or penalties. The pooled separate accounts have no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds the type of fully benefit-responsive investment contract known as a group variable annuity contract. The Plan is required to report these investment contracts held by a defined contribution plan at contract value. Contract value is the relevant measurement attributed for full benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of net assets available for benefits presents the contract value of the group variable annuity contract.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: removal of a group of participants from plan coverage as a result of temporary absence; change in position or other occurrence qualifying as a temporary break in service under the Plan; transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business; removal from the Plan of one or more groups or classifications of participants; partial or complete plan termination; plan disqualification.

Note 5: INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan management has elected the method of compliance permitted by 29 CFS 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Financial Life Insurance Company, Inc., the trustee of the Plan, has certified to the completeness and accuracy of all investments on the accompanying statement of net assets available for benefits as of December 31, 2024, and the supplemental schedule Form 5500, Schedule H, Part IV, Line 4i — Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 6: RELATED PARTY TRANSACTIONS

Certain plan investments are managed by Transamerica Financial Life Insurance Company, Inc. Transamerica Financial Life Insurance Company, Inc. is the Plan's trustee, as defined by the Plan, therefore, these transactions qualify as party-in-interest transactions.

Note 7: DELINQUENT PARTICIPANT CONTRIBUTIONS

During the Plan year ended December 31, 2023, participant contributions totaling \$22,072 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The lost earnings will be remitted to the Plan during 2025.

Note 8: PLAN TERMINATION

Although the Employer has not expressed the intent to terminate the Plan, it expressly reserves the right to amend or terminate the Plan at any time subject to provisions set forth by ERISA. In the event the Plan is terminated, participants are entitled to the entire net asset value of their account.

Note 9: FEDERAL INCOME TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
