INDEPENDENT AUDITORS' REPORT

To the Participants and Insurance Committee of the
Vorys, Sater, Seymour and Pease LLP Health and Welfare Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Vorys, Sater, Seymour and Pease LLP Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Vorys, Sater, Seymour and Pease LLP Health and Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of these financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Vorys, Sater, Seymour and Pease LLP Health and Welfare Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Vorys, Sater, Seymour and Pease LLP Health and Welfare Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedule of reportable transactions – modified cash basis for the year ended December 31, 2024 and the schedule of assets (held at end of year) – modified cash basis as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used

to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN:

The following description of the Vorys, Sater, Seymour and Pease LLP Health and Welfare Plan (previously the Vorys, Sater, Seymour and Pease LLP Health Plan) (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a health and welfare plan covering eligible employees, retirees and partners, as defined in the Plan, of Vorys, Sater, Seymour and Pease LLP (the Employer or Company). A non-qualified trust (the Trust) is utilized by the Plan for funding Plan activity. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Insurance Committee is responsible for oversight of the Plan.

Effective June 1, 2023, the Employer merged the Vorys, Sater, Seymour and Pease LLP Welfare Benefit Plan (the Welfare Plan) into the Plan and the Plan was renamed to the Vorys, Sater, Seymour and Pease LLP Health and Welfare Plan. Insured benefits previously offered under the Welfare Plan including long-term disability, long-term care, accidental death & dismemberment and life insurance began being offered under the Plan.

Benefits

The Plan provides medical, prescription drug, and dental benefits on a self-insured basis. The claims for self-insured benefits are processed by the Plan's third party claims processors and administrative services only arrangements. Vision, long-term disability, long-term care, accidental death & dismemberment and life insurance benefits are provided on an insured basis.

Eligibility

Employees credited with at least 30 hours of work per week are eligible for plan benefits, with certain exceptions, as defined in the Plan.

Contributions

The Employer makes contributions as necessary to pay claims, insurance premiums and administrative expenses to the extent they are not paid by employee contributions. Employees make contributions to the Plan based on the level of elected coverages.

Stop loss coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits for claims in excess of \$175,000 per year per subscriber. The amount of stop-loss reimbursements netted against health and other benefit claims paid for the year ended December 31, 2024 totaled approximately \$1,053,000, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

These financial statements are prepared on the modified cash basis of accounting. The primary difference between the modified cash basis of accounting and accounting policies generally accepted in the United States of America is that contributions, rebate income and investment income are reported when received and benefit payments, insurance premiums and administrative expenses are recognized when paid. Accordingly, no amounts are reported for liabilities for accrued expenses or health claims incurred but not reported or contributions or rebates receivable.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Insurance Committee determines the Plan's valuation policies utilizing information provided by the benefit broker/consultant, custodians and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

The Plan pays administrative expenses that consist of administrative fees paid to third party claims administrators or other service providers. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. Certain other expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements.

Subsequent events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, PNC Bank, NA, the custodian, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023 and the supplemental schedule of assets (held at end of year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024 and the information reflected on the supplemental schedule of reportable transactions for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Money market fund: The carrying value approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. BENEFIT OBLIGATIONS:

Benefit obligations consist of claims incurred but unpaid is calculated by the third-party administrators based on historical claims data. At December 31, 2024 and 2023, claims incurred but unpaid approximated \$1,275,000 and \$1,019,000, respectively. The estimated amount is based on certain assumptions which are subject to change. Due to uncertainties in the estimations and assumptions process, it is at least reasonably possible that changes in the estimates and assumptions may occur.

6. TAX STATUS:

The Trust is a taxable trust and investment income, less attributable deductions, is subject to federal tax. The Plan Administrator may authorize the Trustee to pay any federal, state or local taxes which may be properly imposed on or levied against the Trust Fund. For the year ended December 31, 2024, income taxes were immaterial and are including within the administrative and other expenses in the accompanying financial statements. The Trust's management has analyzed the tax positions taken by the Trust and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements.

7. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

As noted in Note 1, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
