1. Description of Plan

Apps Associates LLC (the "Employer") established the Apps Associates LLC 401(k) Plan (the "Plan") on January 1, 2005, as restated on September 8, 2021. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Employer, who have attained 21 years of age ("Participants"), except for employees covered by a collective bargaining agreement and nonresident aliens who do not receive any earned income from the Employer which constitutes United States sourced income, as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). All investments are participant-directed. The investment committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Fidelity Management Trust Company ("FMTC" or the "Custodian") provides asset custodian services. Fidelity Workplace Services, LLC ("FWS" or the "Recordkeeper"), an affiliate of FMTC, provides recordkeeping services and executes investment transactions. Fidelity Investments, an affiliate of FMTC, manages the investments in the Plan.

Plan Administration

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged directly for administrative expenses, if not paid by the Employer. Individual participant accounts are charged directly for loan recordkeeping, if applicable.

Contributions

Each year, Participants may contribute pre-tax or Roth amounts up to 75 percent of their eligible compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may contribute after-tax contributions to their account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollover").

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled Participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in the Default Model Portfolio based on the Participants' expected retirement date until changed by the Participant.

1. Description of Plan (continued)

Contributions (continued)

The Employer may contribute a discretionary match of 100 percent of each Participant's elective deferral not exceeding 3 percent of the Participant's eligible compensation, plus an additional 50 percent of the Participant's elective deferrals in excess of 3 percent but not in excess of 5 percent of the Participant's eligible compensation. Contributions are subject to certain IRC limitations. For the year ended December 31, 2024, the Employer made employer matching contributions of \$1,975,987 net of forfeitures of \$81,199.

Participant accounts

Each Participant's account is credited with the Participant's contributions, Employer matching contributions and an allocation of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Vesting

Participants are vested immediately in their participant and rollover contributions, and any safe harbor matching contributions previously received plus actual earnings thereon. Upon termination due to death, disability, or attainment of retirement age, a Participant is fully vested in all of their accounts. Employer contributions are subject to the following vesting schedules.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may only borrow from their pre-tax deferral or Roth 401(k) deferral accounts. A Participant may only have one loan outstanding at a time. The loans are secured by the balance in the Participant's account. The loan interest rate, determined daily, is set at 1 percent above the Wall Street Journal prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence. Loans to Participants are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Interest rates for outstanding loans range from 4.25% to 9.50% at December 31, 2024 and 2023 and mature at various dates through November 2038.

Payment of benefits

On termination of service due to death, disability, termination, retirement, or other reasons, a Participant may elect to receive a lump sum amount equal to the full or partial value of the Participant's vested interest in his or her account. The payment can either be a cash distribution to the Participant or a tax free rollover to an individual retirement account or another qualified plan. If a Participant's vested account is more than \$1,000 but less than \$7,000, the plan administrator, after notification, may distribute the benefit into an individual retirement account. If the vested account balance is less than \$1,000, the plan administrator, after notification, may distribute the account balance to the Participant.

In-service withdrawals from a Participant's account are permitted from Participant contributions, rollover accounts, due to financial hardship or upon reaching 59 1/2. In-service withdrawals upon reaching 59 1/2 are allowed from all Participant's vested accounts. Hardship withdrawals may be taken from the Participant's elective deferral account, and the vested portion of the employer matching contribution account.

Forfeited accounts

A Participant who leaves the employment of the Employer forfeits any non-vested balance. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$209,042 and \$17,179, respectively. Forfeited balances of terminated Participants' accounts are used first to pay administrative expenses and then to reduce all Employer contributions in the year of forfeiture. During 2024, employer contributions were reduced by \$19,256 and plan administrative expenses were reduced by \$770, from forfeited nonvested accounts, in accordance with the Plan's provisions.

Revenue Sharing Agreement

The Employer has a revenue sharing arrangement with FMTC that provides for a quarterly allocation to eligible Participants, as defined in the service agreement. For the year ending December 31, 2024, the Plan received \$30,966 of revenue credits which were utilized to fund Participant fees. These revenue credits are fully allocated to Participants at December 31, 2024.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Related fees are recorded as administrative fees and expensed when incurred. If a Participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded as soon as a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from Participants are charged directly to the Participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which is September 19, 2025.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

3. Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

Collective investment fund: Valued at the net asset value ("NAV") of units in the collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units which are valued daily. The fund earns dividends and interest therein represented by units which are valued daily. The fund earns dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants' accounts are charged or credited with the number of units properly attributable to each Participant.

The collective investment fund has no unfunded commitments at December 31, 2024 and 2023. Pursuant to U.S. GAAP guidance, alternate investments where fair value is measured using NAV per share as a practical expedient is not categorized within the fair value hierarchy.

4. Information Certified by Custodian (Unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

5. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Custodian, and therefore, these transactions qualify as party in interest transactions. Plan investments include funds that are managed by an affiliate of FMTC. Therefore, these transaction qualify as exempt party-in-interest transactions. Administrative fees of \$28,412 were paid to FMTC during 2024. Administrative fees of \$119,441 were paid to iCapital, LLC, the Employer's investment advisor, during 2024. Additionally, the Plan issues loans to Participants, which are secured by the Participant's account balances. These transactions qualify as party in interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

7. Tax Status

The underlying volume submitter profit sharing plan has received its latest opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the plan is qualified under section 401(a) of the IRC and that the plan, as then designed, was in compliance with the applicable requirements of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the date of this report.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of the Plan is considered to be a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Global and domestic economic uncertainty has resulted in substantial volatility in the financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
