Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Serta Simmons Bedding 401(k) Retirement Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Serta Simmons Bedding, LLC (the Company) who have completed three months of service and are age 18 or older except those who become a member of a collective bargaining unit whose members are excluded from participation in the Plan. Employees are eligible to participate in the Plan on the first day of the month after satisfying all eligibility requirements. Certain other related employers can also participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated on January 1, 2023.

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, generally not to exceed a maximum of \$23,000 in 2024, plus a catch-up contribution of up to \$7,500 for participants age 50 and older by the end of the Plan year. An employee is automatically enrolled in the Plan at a pre-tax contribution rate of 5%, beginning in the first payroll period following the 30th day after he or she first satisfies the Plan's eligibility requirements, unless the employee elects otherwise. The contributions will be invested in a target date fund based on the employee's date of birth and anticipated retirement at age 65, unless the participant directs otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes safe harbor matching contributions equal to the sum of 100% of an eligible participant's elective deferral contributions that does not exceed 4% of the employee's eligible compensation for the Plan year.

The Plan also provides for an additional discretionary match and profit sharing contribution, at the option of the Board of Directors of the Company. No such contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account, and is charged for certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change

their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in all contributions plus earnings thereon. Participants who previously participated in predecessor plans may be subject to different vesting schedules.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,085 and \$1,536, respectively. In 2024, forfeitures of \$0 were used to pay Plan administrative expenses and \$2,634 of forfeitures were used to offset Company contributions.

Payment of Benefits

Following a termination of service, a participant may receive payment of the vested interest in his/her account in a lump-sum distribution or, if his/her account balance is greater than \$7,000, in a series of installments over a period of up to 10 years. Following a participant's death or disability, his/her beneficiary may receive payment of the vested interest in the participant's account in a lump-sum distribution or, if the account balance is greater than \$7,000, a series of installment payments. A participant's contributions may also be withdrawn for certain hardship situations, when the participant performs certain eligible military service, and for any reason after the participant attains age 59½.

In 2025, the Plan implemented new optional withdraw provisions for eligible participants related to the SECURE 1.0 Act and SECURE 2.0 Act. Specifically, the optional withdraw provisions allow for withdrawals related to emergency expenses and federally declared disasters.

Administrative Expenses

Loan origination fees are charged directly to the respective participants' accounts. Management fees are charged directly to a participant's investment account for those participants invested in the common/collective trust funds or stable value fund at rates established by the funds. Participants also pay administrative fees through an annual charge to their account. The annual charge was \$75 per participant for 2024. The administrative fee is paid to a service provider of the Plan and qualifies for a party-in-interest transaction. Although it is not required to do so, certain other expenses incidental to the administration of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for these expenses.

The Plan has established an ERISA account where the qualified institution deposits revenue sharing payments that are used to pay Plan administrative expenses. The account had an available balance of \$1,125 and \$308 as of December 31, 2024 and 2023, respectively, which is included in the stable value fund on the statements of net assets available for benefits. During 2024, \$817 of

investment earnings was deposited into the account, and expenses totaling \$0 were paid from the account. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. Payments from this account are included in administrative expenses in the year paid. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at any time. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest as defined in the Plan document. During 2024, notes had fixed rates ranging from 4.00% to 9.50% for the term of the note, not to exceed 5 years unless the note is in connection with the participant's principal residence. Principal and interest are paid through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Discretionary match and profit sharing contributions are recognized upon authorization from the Company. Any unfunded participant or employer matching contributions are included in the participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's Accounting Standards (FASB) Codification 326, *Financial Instruments – Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no

allowance for credit losses is necessary as of December 31, 2024 and 2023, and there was no activity in the allowance for credit loss account in 2024.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on investments, and fees charged for investment management and administrative services on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding principal balance. Interest income is recognized when received, primarily monthly. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Bank of America, N.A. (Bank of America), the Plan's qualified institution.

4. Investments and Fair Value Measurements

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The FASB established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

Investments in the common/collective trust funds are valued daily based on their net asset value (NAV). The NAVs are based on the fair value of the stocks, debt instruments, mutual funds, and other securities in the accounts. The common/collective trust funds may be traded daily at their NAV (Level 1).

The Plan invests in a stable value fund held in a common/collective trust fund. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The

stable value fund trades daily at the NAV which is based on the contract value of the underlying investments (Level 1).

5. Income Tax Status

The Plan is an individually designed plan based on a volume submitter plan created by CCH INCORPORATED DBA FTWILLIAM COM (CCH). Although the Plan has not received an individual determination letter, and has been amended, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, accordingly, has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company's contributions.
