INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Mission Community Hospital's 401(k) Retirement Plan

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Mission Community Hospital's 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mission Community Hospital's 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mission Community Hospital's 401(k) Retirement Plan's ability to continue as a going concern for one year after the date financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Mission Community Hospital's 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### 1. General

The Plan is a contributory 401(k) and profit sharing plan covering substantially all employees of Deanco Healthcare, LLC dba Mission Community Hospital (the "Employer") under sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### 2. Eligibility

Employees who have attained 18 years of age are eligible to make deferral contributions immediately upon their date of hire. Participants are eligible for employer contributions on the first day of the month upon completion of one year of service with at least 1,000 hours and attainment of age 18. New participants are automatically enrolled in the Plan at a pre-tax deferral rate of 4% of plan compensation, unless a different salary deferral election is otherwise made.

#### 3. Contributions

Participants are eligible to contribute on a pre-tax basis and/or make Roth contributions, up to 100% of eligible compensation, not to exceed the maximum deferral limit per Section 402(g)(1) of the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Employer may make a discretionary non-elective contribution or a discretionary matching contribution to the Plan. Discretionary matching contributions are based on a uniform percentage of deferrals or a flat dollar amount for each eligible participant who is employed on the last day of the plan quarter. For the year ended December 31, 2024, the Employer made a matching contribution equal to 25% of deferred contributions up to 4% of a participant's compensation.

#### 4. Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer discretionary matching contribution and allocations of the Employer discretionary non-elective contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on plan compensation, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### NOTE A - DESCRIPTION OF THE PLAN (Continued)

##### 5. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions as desired, in any of a variety of investment options as chosen by the Employer and held by Fidelity Management Trust Company ("Fidelity"), the trustee. Participants may change their investment options daily.

##### 6. Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000 (reduced by the highest outstanding loan balance during the previous twelve months). Participants may have only one loan outstanding at a time. Loans are secured by the balance of the participant's account and are charged a reasonable rate of interest. Loans must be repaid within five years and loans for the purchase of principal residence may be repaid over ten years.

##### 7. Benefit Payments

Benefits become distributable upon reaching retirement age, total disability, death or termination of service. Benefit payments may be paid in the form of a lump sum amount or in installments over a specified period of time not to exceed the life expectancy of the participant. In-service distributions are permitted if certain criteria are met. Hardship distributions are not allowed by the Plan.

##### 8. Vesting

Participants are fully vested in all contributions plus actual earnings thereon at all times.

##### 9. Plan Termination

While the Employer has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and all account balances shall be distributed in such a manner prescribed by the plan terms and the IRC.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### 1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

##### 2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA.

##### 3. Payment of Benefits

Benefits are recorded when paid.

##### 4. Administrative Expenses

Certain expenses charged by the trustee in performance of its duties are paid from the assets of the Plan. Investment related expenses are included in the net appreciation/depreciation in fair value of investments. Substantially all other out-of-pocket administrative expenses of the Plan are paid by the Employer. Expenses paid by the Employer are excluded from these financial statements.

##### 5. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### 6. Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### 7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### 8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### NOTE C - INFORMATION CERTIFIED BY TRUSTEE

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity (the trustee of the Plan), a qualified institution.

#### NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund:* Valued at cost plus interest.

*Mutual Funds:* Valued at daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

*Common/collective trust funds:* NAV for the common/collective trusts (CCT) are determined by the trustee of the CCT. The fair values of the Plan's interest in the CCTs are based on the underlying unit value reported by the CCT as of the close of business on each valuation date. The NAV per unit is computed by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding. Investment income earned is reinvested in the fund and included in the determination of unit values. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Fidelity. Fidelity is also the trustee and recordkeeper for the Plan, and therefore, transactions with this entity qualify as party-in-interest transactions. Notes receivable from participants of the Plan and the related interest income are also considered party-in-interest transactions.

**NOTE F - TAX STATUS**

The Employer adopted a non-standardized pre-approved profit sharing plan with CODA ("non-standardized plan") which received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the non-standardized plan, as then designed, was in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature are handled by the administrator in accordance with applicable IRS correction policies. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

#### **NOTE F - TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **NOTE H - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
