## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the plan financial statements of Snoqualmie Casino 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The plan financial statements comprise the statements of fiduciary net position as of December 31, 2023 and 2022, the related statement of changes in fiduciary net position for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Required Supplementary Information**

Management has omitted management's discussion and analysis that U.S. GAAP requires to be presented to supplement the plan financial statements. Such missing information, although not a part of the plan financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the plan financial statements in an appropriate operational, economic, or historical context. Our report on the plan financial statements is not affected by this missing information.

#### Note 1. Plan Description

The following description of Snoqualmie Casino 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

**General:** The Plan is a safe harbor 401(k) plan covering substantially all employees of the Snoqualmie Entertainment Authority and Snoqualmie Indian Tribe (collectively, the Employer or Company), except employees covered under a collective bargaining agreement. Eligible employees can participate in the Plan on the first day of the month following three consecutive months of service and attainment of age 18. The Snoqualmie Tribe Tribal Council is responsible for oversight of the Plan. The Tribal Council has delegated the administration of the Plan to the 401(k) Plan Investment Committee. The 401(k) Plan Investment Committee has responsibility for making all discretionary determinations under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute a percentage of their annual compensation, as defined by the Plan, representing pretax or after-tax (Roth) contributions, up to the maximum allowed under the Internal Revenue Code (IRC). Unless an employee elects otherwise, newly eligible employees are automatically enrolled into the Plan, and 1% of their eligible pretax compensation, as defined in the Plan document, is automatically deferred. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Employer contributes a safe harbor basic matching contribution equal to 100% of the participant's first 3% of compensation, as defined in the Plan document, plus 50% of applicable contributions up to the next 2% of compensation.

**Participant accounts:** Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's safe-harbor matching contributions, an allocation of Plan investment results and charged with an allocation of certain administrative expenses that are paid from the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting:** Each participant is immediately 100% vested in their own elective contributions, rollovers and employer safe-harbor matching contributions, plus actual earnings thereon.

**Benefit payments:** A participant's vested account balance is distributed in a lump-sum or installment payments based on his or her election under the Plan document, upon retirement, death, permanent disability, separation or termination of employment for any reason. Upon separation from service, the Plan requires the automatic distribution of the participant's vested account balances not exceeding \$5,000. If a participant who has separated from service fails to elect to have such distribution paid directly to an eligible retirement plan or to receive the distribution directly, his or her account balance will be automatically distributed as a lump sum if it is \$1,000 or less. Unless otherwise elected, for participants with balances between \$1,000 and \$5,000, benefits will automatically be rolled over to an individual retirement account selected by the Plan Administrator on the participant's behalf.

Additionally, under certain circumstances of financial hardship, as defined, a participant is allowed to withdraw funds from the Plan. Participants over age 59½ are entitled to receive a distribution of all or any portion of their vested account balances. Retired participants have an option of delaying the receipt of benefits. The payments for retired participants, however, are required to begin no later than April 1 following the end of the year in which the participant reaches the age of 73.

#### Note 2. Summary of Accounting Policies

**Basis of accounting:** The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America as applied to governmental units, using the accrual method of accounting. The Governmental Accounting Standards Board (GASB) is the accepted standard-setting body for establishing governmental accounting and financial reporting principles. These financial statements present only the Plan and are not intended to present the financial statements of the Company.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Risks and uncertainties:** Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2023 statement of fiduciary net position.

**Investment policy:** The 401(k) Plan Investment Committee ensures the Plan offers a diversified investment portfolio of mutual funds and a collective trust fund that enables the participant to construct a portfolio with aggregate risk and return characteristics to fit their individual investment profile. An independent investment consultant monitors the investments on behalf of the 401(k) Plan Investment Committee to ensure that the investments remain in compliance with investment objectives and criteria in the near term, as well as three and five-year measurement dates.

**Interest rate risk:** This is the risk that changes in market interest rates will adversely affect the fair value of an investment. Investments with longer maturities have greater sensitivity to fair value changes based on market interest rates. Mutual funds classified as bond funds and the collective trust fund are exposed to this risk.

**Credit risk:** Credit risk exists when there is a possibility that the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. Mutual funds classified as bond funds and the collective trust fund are exposed to this risk.

#### Note 2. Summary of Accounting Policies (Continued)

**Administrative expenses:** Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Administrative expenses related to plan administration will be paid from Plan assets, except the Company may, at its discretion, pay such expenses. Administrative expenses paid by the Company are excluded from these financial statements. Administrative expenses recorded by the Plan include maintenance fees, withdrawal fees, recordkeeping fees, and managed account fees charged directly to the participant's account.

**Subsequent events:** Subsequent events have been evaluated through October 15, 2024, which is the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

To the extent available, the Plan's investments are recorded at fair value as of December 31, 2023 and 2022. GASB Statement No. 72, *Fair Value Measurements and Application*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. This statement establishes a hierarchy of valuation inputs based on the extent to which the inputs are observable in the marketplace. Inputs are used in applying the various valuation techniques and take into account the assumptions that market participants use to make valuation decisions. Inputs may include price information, credit data, interest and yield curve data, and other factors specific to the financial instrument. Observable inputs reflect market data obtained from independent sources. In contrast, unobservable inputs reflect the entity's assumptions about how market participants would value the financial instrument. Valuation techniques should maximize the use of observable inputs to the extent available.

#### Note 4. Fair Value Measurements (Continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following describes the hierarchy of inputs used to measure fair value and the primary valuation methodologies used for financial instruments measured at fair value on a recurring basis:

**Level 1:** Investments whose values are based on quoted prices (unadjusted) for identical assets in active markets that a government can access at the measurement date.

**Level 2:** Investments with inputs, other than quoted prices included in Level 1, that are observable for an asset, either directly or indirectly.

**Level 3:** Investments classified as Level 3 have unobservable inputs for an asset and may require a degree of professional judgement.

(a) This collective trust fund seeks to maintain safety of principal through investing in an actively managed and diverse portfolio of investment contracts, and the associated portfolio of underlying investments. All investment contract issuers and securities utilized by the collective trust fund must be rated investment grade at the time of purchase. There are no participation redemption restrictions for this fund, the redemption notice period is applicable only to the Plan.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

**Mutual funds:** Shares of registered investment company funds (mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective trust fund:** The fair value of the collective trust fund has been determined using the NAV per share, which is based on the fair value of the fund's underlying pool of securities. The NAV is used as a practical expedient to estimate fair value, and the NAV per share was provided to the Plan by the trustee. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### Note 5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of the collective trust fund managed by Principal Trust Company, the trustee and recordkeeper of the Plan. Fees paid by the Plan to the recordkeeper and trustee are included in administrative expenses in the statement of changes in fiduciary net position. Fees incurred by the Plan for the investment management services are included as an offset to net appreciation (depreciation) in value of investments. Principal Trust Company is the trustee and recordkeeper as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Employer may determine.

#### **Note 7. Tax Status**

The Plan adopted a pre-approved profit sharing plan, sponsored by Principal Life Insurance Company. The pre-approved plan provider has received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, as to the pre-approved plan's qualified status. The Plan has been amended since the date of the opinion letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC.
