Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

***General***

The following description of Hoj Management Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, which are available from the plan administrator.

The Plan is a defined contribution plan sponsored by Hoj Management Co., Inc. (Hoj) for the benefit of its employees who have at least 90 days of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Nationwide Trust Company serves as the plan custodian.

***Contributions***

Participants authorize Hoj to deduct a percent thereof of their annual compensation for deposit into the Plan. However, the law limits the amount that can be contributed in any tax year (\$23,000 in 2024). Pursuant to the *Economic Growth Tax Relief Reconciliation Act* (EGTRRA) amendments, participants who have attained age 50 during the plan year may make additional elective contributions (\$7,500 in 2024). The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. For 2024 and 2023, Hoj matched 50% of the first 6% of participant contributions made and satisfied the safe harbor rules. Profit sharing contributions are discretionary as determined by Hoj's Board of Directors. No profit sharing contributions were made during 2024 and 2023.

***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, Hoj's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in Hoj's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service based on the following schedule:

The nonvested balance is forfeited upon termination of service.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lumpsum amount equal to the value of the vested interest in their account or annual installments not to exceed the life expectancy of such beneficiary. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution. In service distributions are also available to participants who have reached age 59-1/2 and hardship distributions subject to plan provisions.

***Forfeited Accounts***

As of December 31, 2024 and 2023, forfeited nonvested amounts were \$20,551 and \$13,810, respectively. Forfeitures may be first used to pay any administrative expenses. The remaining forfeitures may then be used to reduce employer contributions. During 2024 and 2023, forfeitures of \$0 and \$9,557, respectively, were used to pay administrative expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The Plan's accounting policies conform to accounting practices prescribed by the *Employee Retirement Income Security Act of 1974*. The following policies are considered to be significant:

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by Hoj or the Plan, at Hoj's discretion. These generally include maintenance fees, withdrawal fees, recordkeeping fees, and managed account fees charged directly to the participant's account.

**NOTE 3 – CERTIFICATION OF PLAN CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, the custodian of the Plan, has certified the following investment information included in the accompanying financial statements and ERISA required supplemental schedule is complete and accurate to the best of their knowledge and belief:

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**NOTE 4 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Nationwide Trust Company. Nationwide Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. During 2024 and 2023, fees incurred by the Plan for the investment management services were included in net appreciation in fair value of the investment, paid through revenue sharing, rather than a direct payment.

**NOTE 5 – DISCLOSURES ABOUT FAIR VALUE OF PLAN ASSETS**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

**Level 1** Quoted prices in active markets for identical assets

**Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31 2024, and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no Level 2 or Level 3 investments.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, Hoj has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7 – PLAN TAX STATUS**

The Plan operates under a standardized adoption agreement in connection with a volume submitter profit sharing plan sponsored by National Benefit Services. This volume submitter plan document has been filed with the appropriate agency. Although the Plan has been amended since receiving a determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
