1. DESCRIPTION OF PLAN

The following description of the Hisense Photonics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted on January 1, 2004 and qualifies as a defined contribution retirement plan for Hisense Photonics, Inc.’s. (the “Company”) eligible employees. This Plan was established for the purpose of providing retirement benefits to eligible employees in accordance with the Plan. The Plan is intended to qualify under Code Section 401(a) and to satisfy the provisions of Section 401(k) of the Internal Revenue Code (“IRC”) of 1986, as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee, or equivalent, determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

Participant Eligibility

Each of the Company’s employees is eligible to participate in the 401(k) Plan if they have completed three months of service and attained age 21. To be eligible for a profit sharing contribution, a participant must be employed on the last day of the year and have completed at least a year of service and 1,000 hours. Once the eligibility requirements have been met, employees may enroll in the Plan on the first day of each quarter.

Contributions

The Company’s eligible employees may contribute any amount up to 100% of eligible compensation or the 402(g) limit. The 402(g) limit for 2024 was \$23,000. In addition, all eligible employees who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of Code Section 414(v). Participants have the option to designate all or any portion of their elective deferral contributions to be withheld on an after-tax basis as Roth elective deferral contributions.

The Company will make a safe harbor matching contribution equal to 100% of the participants’ first 4% of the deferral made during the year. Matching contributions for the period ending December 27, 2024 amounted to \$425,838. The Company may make a discretionary profit sharing contribution in an amount to be determined by the Board of Directors. The Company chose not to make a profit sharing contribution for the period ended December 27, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s allocation of (a) the Company’s matching contribution, (b) the Company’s discretionary contribution, (c) the participant’s contribution and, (d) Plan earnings.

Investment of Plan Funds

A participant may invest his or her respective share in all employee and employer contributions into any one of the investment options offered by Transamerica Life Insurance Company (“TLIC”).

Allocation of Investment Activity

The net increase or decrease in such values resulting from fund income and allocated expenses, if any, are apportioned to each participant’s account in proportion to the value of the participant’s account as compared to the investment fund as a whole.

Vesting

Participants are one hundred percent (100%) vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Participants become vested in their Company matching and profit sharing accounts and any earnings as follows:

<u>Years of Service For Vesting</u>	<u>Percent Vested</u>
After one year of service	25%
After two years of service	50%
After three years of service	75%
After four years of service	100%

Forfeitures

Amounts forfeited from terminating participants’ non-vested portion of their Company discretionary contribution account and earnings on Company contributions are used to reduce future employer contributions and plan expenses. At December 27, 2024 and December 31, 2023, forfeitures available for future use amounted to \$-0- and \$202, respectively. There were no forfeitures for the period ended December 27, 2024.

Payment of Benefits

Retired or terminated participants receive the vested portion of their Company contributions and earnings on their Company contributions and one hundred percent (100%) of their pre-tax contribution as soon as administratively possible following retirement, termination, or upon becoming disabled.

1. DESCRIPTION OF PLAN - (Continued)

Administrative Expenses

Substantially all plan expenses, with the exception of money management and recordkeeping fees, are paid by the Company.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance, \$50,000, or the limitations set by the Tax Reform Act of 1986 and Section 408(b) of the Employee Retirement Income Security Act of 1974 ("ERISA"). The interest rate is 1% over the Prime Rate published in the *Wall Street Journal*. The loans are to be repaid through payroll withholding over a period of five years or ten years if the loan is to acquire a principal residence. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

Date of Management's Review

Subsequent events were evaluated through October 13 2025, which is the date the financial statements were available to be issued.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Concentrations

Two investments accounted for 38% of the Plan's net assets as of December 31, 2023.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 7 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Non-Distributed Benefits

The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan, but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

4. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, stating that the Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated. The trustee, plan sponsor, and plan administrator are aware that incorrect compensation was used to calculate deferrals and matching contributions which could adversely affect the qualified status of the Plan. The Company plans on using the Internal Revenue Service's Employee Plans Compliance Resolution System ("EPCRS") to self-correct the potential plan qualification failures and allocate missed deferrals and matching contributions to the respective participants that now participate in the merged Pooled Employer Plan, and as a result, the Company does not believe that there are any events that may jeopardize the Plan's tax qualified status that are probable of assertion. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. TAX STATUS – (Continued)

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 27, 2024 and December 31, 2023, there are no uncertain positions taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

5. RELATED-PARTY TRANSACTIONS

Certain plan investments are units in pooled accounts managed by Transamerica Financial Life Insurance Company (“Transamerica”) as the contract provider. Transamerica is the custodian of the Plan assets and, therefore, these transactions qualify as party-in-interest transactions. For the period ended December 27, 2024, fees paid to Transamerica for recordkeeping, administrative services, and loan processing fees amounted to \$1,678.

6. INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica, the custodian of the Plan has certified to the completeness and accuracy of the pooled separate accounts, group annuity contract, and notes receivable from participants reflected in the statements of net assets available for benefits as of December 27, 2024 and December 31, 2023 and the related investment activity reflected in the statement of changes in net assets for the period ended December 27, 2024.

7. FAIR VALUE MEASUREMENT

ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1 Fair Value Measurements*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 Fair Value Measurements*

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of asset or liability.

*Level 3 Fair Value Measurements*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* - The Plan participates in contracts with Transamerica (the insurance contract issuer) whereby the assets of the Plan are pooled with those of other unrelated plans. The Plan owns units of participation in the fair value of the account's underlying assets. Transamerica does not own the underlying assets, but only hold them in trust for the participating plans. These investments are public investment securities valued using the Net Asset Value ("NAV") as a practical expedient provided by the insurance institution. The NAV is quoted on a private market that is not active, however, the unit price is based on the underlying investments. A majority of the investments held by each fund are traded on an active market.

8. INVESTMENT CONTRACT

*Stable Value Option* – The Plan held an investment in a stable value fund with Transamerica Life Insurance Company (TLIC). The Transamerica stable value fund is not a separate account investment choice – it is an investment in Transamerica’s general account. The stable value fund is considered to be a fully benefit-responsive investment contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported by Transamerica, is the beginning balance plus any deposit and credited interest, less any withdrawals, charges, or expenses, a measurement that approximates fair value. Transamerica pays the stated interest rate and backs the capital deposit where the “risk” is measured by our insurance credit rating. This is a depository liability with no formal underlying maturities, and it is considered fairly valued at contract value because of this specific distinction. Crediting interest rates for the years ended December 31, 2024 and 2023 were approximately 1.75%, respectively. Average yields were approximately 1.65% for 2024 and 2023. There are no unfunded commitments, the redemption frequency is daily, and the redemption notice period is daily.

Certain events might limit the ability of the Plan to transact at contract value with Transamerica. Such events include the following: (1) the Plan is changed as to significantly affect Transamerica's obligation to the contract, (2) the contract can no longer be treated as a pension plan contract, (2) the Plan is terminated, (4) failure to comply with the contract's requirements, (5) failure to provide information, (6) the sum of the contract account values at any time equals \$20,000 or less, or (7) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. The plan administrator is not aware of any events, which would limit the Plan's ability to transact at contract value with participants that are probable.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. PROHIBITED TRANSACTION

For the year ended December 31, 2024, the Company remitted employee contributions and loan payments of \$153,420 into the Plan after what was considered to be an unreasonable period of time. Uncorrected delinquent participant contributions prior to 2024 amounted to \$159,165. These delinquent contributions are considered prohibited transactions by the IRS and Department of Labor and therefore are subject to correction and the replacement of lost earnings. The Plan sponsor will make the corrections and deposit lost earnings into the merged plan in 2025.
