**INDEPENDENT AUDITOR’S REPORT**

To the Plan Administrator of the  
Edwards Oil Company Employees Profit Sharing & 401(k) Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Edwards Oil Company Employees Profit Sharing & 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Edwards Oil Company Employees Profit Sharing & 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Edwards Oil Company Employees Profit Sharing & 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. ### **Basis of Accounting**

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **NOTE A - DESCRIPTION OF PLAN**

The following description of the Edwards Oil Company (“Company”) Employees Profit Sharing & 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. *General.* The Plan is a defined contribution plan covering all eligible employees of Company who have attained the age of 21 and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by Edwards Oil, Inc. and the Plan’s trustee and custodian is Ascensus Trust Company.
2. *Participant Contributions.* Participants may elect to contribute a salary deferral to the Plan through a pre-tax 401(k) payroll deduction up to the maximum allowed by law of the participant’s eligible compensation, as defined by the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants may elect to direct investment options or utilize the Blackrock Lifepath Index Portfolios offered by the Plan which invests contributions and participant account balances based on a Target Date asset allocation option. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan, with a default deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced portfolio until changed by the participant. The automatic deferral escalation percentage increases by 1 percent per year to a maximum of 6 percent. The increase will be applied as of the second period that begins after the period in which the initial deferral amount was withheld and will occur as of each September 1 thereafter.
3. *Employer Contributions.* The Company contributes employer matching contributions and discretionary employer profit sharing contributions to the Plan, subject to certain Internal Revenue Code limitations as follows:
  - a. *Employer Matching Contributions.* The Company contributes 20 percent of the first 4 percent of base compensation that a participant contributes to the Plan, plus 15 percent of the next 4 percent of base compensation that a participant contributes to the Plan. The matching contribution will not exceed 8% of eligible compensation. Catch up contributions will not be matched. There are some additional limitations in order to participate in the matching contribution.
  - b. *Discretionary Employer Profit Sharing Contributions.* The Company, at its discretion, may contribute a discretionary employer profit sharing contribution. In order to share in the contribution there are conditions that must be met. The profit-sharing contribution will be allocated or divided among participants eligible based on the allocation process. Contributions are subject to certain statutory limitations.

4. *Participant Accounts.* Each participant's account is credited with the participant's contribution and the Company's contributions, plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. *Vesting.* Participants are immediately vested in their salary deferrals contributions, rollover contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.
6. *Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus one percent, ranging from 4.25 percent to 9.50 percent. Principal and interest is paid ratably through bi-weekly payroll deductions.
7. *Payment of Benefits.* Benefits are paid to the participant or beneficiary upon death, normal retirement age (age 60) or termination of employment reasons other than death, disability, or retirement. If the vested account balance exceeds \$5,000, the participant may elect to receive a lump sum payment, partial withdrawal if permitted, installments, or rollover all (or any) portion to another qualified plan. If the vested account balance is between \$1,000 and \$5,000 and there is no consent to a distribution the vested account balance will be automatically rolled over to an IRA. If the vested account balance is \$1,000 or less, involuntary cash outs are automatically distributed in a lump sum distribution without Participant's consent. In addition, in-service distributions are permitted if the participant attains the age of 60 at the time of distribution. Financial hardships are allowed if the participant satisfies certain conditions and limitations.
8. *Forfeitures.* Participant forfeitures may be used to pay plan expenses or to reduce amounts otherwise required to be contributed to the Plan or to be reallocated to participants as though they are additional employer contributions. At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$56 and \$0, respectively. During 2024 and 2023, \$3,874 and \$3,409 of forfeitures were used to pay administrative expenses, respectively.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

*Basis of Accounting*

The accompanying financial statements have been prepared on the modified cash basis of accounting. That basis differs from generally accepted accounting principles primarily because the contributions are recorded when received rather than when earned.

*Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balances plus accrued interest. Interest income is recorded on the modified cash basis of accounting. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when paid. No allowance for credit losses is recorded as management believes that all loans are collectible. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE D - FAIR VALUE MEASUREMENTS**

*Common/Collective Fund:* Valued at the net asset value (NAV) of units of a common/collective trust. The NAV is based on the contract value of the underlying investment contracts held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Current Plan Investments were managed by Ascensus, LLC who is the recordkeeper for the Plan and Merrill Lynch is the investment advisory as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable qualify as party-in-interest transactions.

Certain fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing rather than direct payment. The Plan paid fees, which are not covered by revenue sharing, for the years ended December 31, 2023 and 2024 amounted to \$36,687 and \$45,066, respectively. The Company pays directly any other fees related to the Plan's operations.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the participant's account shall become 100% vested, regardless of the Plan's current vesting schedule. The participant is entitled to a distribution of their entire vested benefit.

**NOTE G - TAX STATUS**

In 2021, the Plan had a restatement of the defined contribution pre-approved plan with Newport Group, Inc. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - RISKS AND UNCERTAINTIES**
