Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of the CORA Health Services Retirement Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan, as amended and restated, is a defined contribution plan covering all eligible employees of CORA Health Services, Inc. and affiliated employers (the Company and Plan Administrator) who have attained age 21 and completed 90 days of service (having worked 200 hours). Prior to July 1, 2023, service eligibility requirements were 1 year of service (having worked 1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of Plan earnings (losses). Allocations are based on participant wages, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account. Participants direct the investment of their account balances among the investment funds offered by the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment period shall not be more than 5 years unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Participants should refer to the Plan document for a complete description of loan provisions.

Contributions

Participants may elect to defer annual earnings up to the maximum allowed by the Internal Revenue Service (IRS), as defined by the Plan document. Unless electing otherwise, newly eligible employees will be auto enrolled at an initial pre-tax contribution rate of 3%. Highly compensated employees, as defined by the Plan, are limited in their deferrals to ensure certain tests prescribed by law are met. Participants are permitted to contribute amounts distributed from another qualified plan (rollover contributions).

The Plan provides for discretionary matching contributions, to be determined by the Company. There was no discretionary matching contribution for 2024 and 2023. The Plan also provides for a discretionary profit sharing contribution to be allocated to eligible participants as defined by the Plan document. There was no discretionary profit sharing contribution in 2024 or 2023. All Company contributions require 1 year of service to be eligible.

Payment of Benefits

The Plan generally provides that upon retirement, death, disability, or termination, participants are entitled to receive the vested value of their account in a lump sum payment. Upon meeting certain other qualifications, participants may also be eligible for in-service distributions and hardship distributions.

Vesting

The balance in each participant's account related to that participant's elective or rollover contributions are fully vested at all times. The portion of each participant's account resulting from Company contributions is vested based on years of service (as defined in the Plan document). Participants vest 20% per year of service beginning in the first year of service and are 100% vested after five years of service.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or to pay administrative expenses. Unallocated forfeitures totaled \$45 and \$3,377 at December 31, 2024 and 2023, respectively. The amount used to offset employer contributions and administrative expenses during 2024 and 2023 was \$23,205 and \$13,003, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants become fully vested in the total value of their account.

Administrative Expenses

Administrative expenses are paid by the Plan's participants on a pro-rata basis, as permitted by the Plan. The services are rendered by parties-in-interest to the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used.

The value of the units held in pooled separate accounts are fair valued at the net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

The Principal Fixed Income Guaranteed Option is a fully benefit-responsive investment contract valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan, it is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and interest and dividends for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Trust Company, the Trustee.

Note 4 – Investment in Principal Fixed Income Guaranteed Option

As of December 31, 2024 and 2023, the Plan held a fully benefit-responsive group annuity contract, the Principal Fixed Income Guaranteed Option, with Principal Trust Company. The Principal Fixed Income Guaranteed Option is a general account product of Principal Life Insurance Company. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest crediting rate is reset semi-annually. As described in Note 2, contract value is the relevant measurement attribute for this fund.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment. Certain events limit the ability of the Plan to transact at contract value. In addition, the contract terms may delay for up to one year a Plan sponsor initiated withdrawal of either a portion of, or the entire value of, the investment held. The Plan does not believe that such events are likely. There are no reserves against contract value for credit risk of Principal Life Insurance Company or otherwise.

Note 5 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 6 – Income Tax Status

The IRS ruled on June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan document (the document upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC). The Plan has been amended. The Plan Administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
