## INDEPENDENT AUDITORS' REPORT

### *Opinion*

We have audited the accompanying financial statements of Local Union 456 IBEW Joint Annuity Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of  
Local Union 456 IBEW Joint Annuity Fund  
West Trenton, New Jersey

### *Opinion*

We have audited the accompanying financial statements of Local Union 456 IBEW Joint Annuity Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Local Union 456 IBEW Joint Annuity Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Local Union 456 IBEW Joint Annuity Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Local Union 456 IBEW Joint Annuity Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### *(1) Description of the Plan*

The following brief description of the International Brotherhood of Electrical Workers Local Union No. 456 (the "Union") Joint Annuity Fund (the "Plan") provides only general information. Participants should refer to the Plan document and Declaration of Trust and the Rules and Regulations for a more complete description of the Plan's provisions.

**General** - The Plan is a multiemployer collectively bargained defined contribution plan which was established in accordance with an agreement entered into between the Middlesex Division of the Northern New Jersey Chapter, Inc. of the National Electrical Contractors Association, Inc. and the Union. The administration of the Plan is the responsibility of the Trustees, comprised of union and employer trustees. All employees employed under the collective bargaining agreement with the Union and all regular full-time employees of the Union, provided regular contributions are made for them by such employer, and any nonbargaining unit employees for whom contributions are made by each local area employer who elects to contribute for all of his employees, are eligible. The administration of the trust is the responsibility of a Board of Trustees, comprised of union and employer trustees. The investments of the Plan are managed by investment advisors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**Contributions** - Contributing employers are required to make contributions to the Plan on behalf of each participant on the basis of a rate fixed by the applicable collective bargaining agreement in effect. The contribution rates vary depending on the level of benefits negotiated. The rates of contribution vary between 17% of gross labor payroll for a journey wireman and 6.5% of gross labor payroll for small works employees. Prior to June 2023, the journey wireman rate was 18%. Plan participants are not required to contribute to the Plan.

Employers' contributions are received on a monthly basis and are deposited in a money market account that bears interest at the current prevailing rate. Periodic transfers are forwarded to Empower for investment on behalf of the participants.

**Funding Policy** - Contributions to the Plan are submitted by participating employers under a collective bargaining agreement between the Middlesex Division of the Northern New Jersey Chapter, Inc. National Electrical Contractors Association, Inc. and the Local Union 456 IBEW. Employers submit contributions for the eligible participants on a monthly basis.

**Participant Accounts and Vesting** - Each participant's account is credited with (a) employer contributions determined under the collective bargaining agreement and (b) fund earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. A participant shall always have a 100% vested right to their account.

**Investment Options** - Upon enrollment in the Plan, a participant must direct contributions made on their behalf to selected investments as made available and determined by the Trustees. Participants may change their investment options anytime throughout the year.

**Payment of Benefits** - The Plan may pay benefits to a participant if (1) the participant retires after attaining the age of 55, or (2) is totally and permanently disabled, or (3) has not worked in a job covered by an agreement requiring contributions to the Plan for at least three consecutive months, or (4) has suffered a financial hardship as defined in the Plan. If the participant dies, his accumulated share is payable to his beneficiary.

Election may be made by participants to receive either a lump sum payment, monthly installment payments for a period not to exceed 15 years, or a lifetime annuity.

### *(1) Description of the Plan (Continued)*

**Plan Amendment** - During 2023, the trustees approved an amendment related to the beginning date of required minimum distribution ("RMD"). A participant is allowed to withdraw RMDs on April 1st of the calendar year following the later of the calendar year in which the participant either turns age 72 or when the participant retires.

### *(2) Summary of Significant Accounting Policies*

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Adoption of New Accounting Standard** - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that is subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

**Use of Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Certain investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information principally provided by the Plan's custodian. Fully benefit-responsive contracts held by the Plan are recorded at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *(2) Summary of Significant Accounting Policies (Continued)*

**Employers' Contributions** - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on a percentage of the participating employers' monthly payroll for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection, including subsequent period collection activity. As of December 31, 2024 and 2023, the Plan did not record a credit loss allowance for employers' contributions receivable.

The Board of Trustees has established a program to review participating employer records in order to determine compliance with contribution provisions of the collective bargaining agreement. As a result of this program, previously unreported contributions are identified related to current and prior fiscal years. However, due to the collection efforts required by the Plan, including litigation, the ultimate realization of any additional contributions cannot be reasonably estimated until the collection process is completed. Accordingly, the Plan primarily recognizes these previously unreported contributions in the fiscal year in which the settlement proceeds are received.

**Notes Receivable - Participants** - Loans for educational expenses are available to participants who have had an account for at least 3 years. The maximum loan amount is 50% of the participant's account balance but no more than \$50,000 in total. The loans are available only to pay for tuition, room and board for the participant, his or her spouse or a dependent child, who is enrolled as a full time or part time student at an accredited elementary, secondary, college, university, or school for the physically or mentally handicapped. The notes receivable are for a period of 60 months and are at a simple interest rate of prime plus 0.5%. Total notes receivable outstanding at December 31, 2024 and 2023 were \$101,449 and \$74,058, respectively.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the notes receivable to be in default, the notes receivable balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits payments to participants are recorded upon distribution.

**Administrative Expenses** - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with related ERISA plans. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Plan in relation to the other plan. Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Leases** - Leases are categorized at their inception as either operating or financing leases. Operating right-of-use assets and liabilities are recognized at the lease commencement date based on the present value of the lease payments over the lease term. Leased assets represent the Plan's right to use an underlying asset for the lease term, and lease liabilities represent the Plan's obligation to make lease payments arising from the lease. The lease term may include options to extend or terminate the lease when it is reasonably certain that the Plan will exercise that option. Lease expense for lease payments is recognized on a straight-line basis over the lease term. The Plan uses a risk-free discount rate when the rate implicit in the lease contract is not readily determinable.

**Subsequent Events** - The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

### *(3) Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Interest-Bearing Cash:** Valued at amortized cost which approximates fair value.

**Common Collective Trust:** Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fund invests primarily in high-quality fixed-income securities and utilizes wrap contracts issued by insurance companies and banks to provide benefit-responsive liquidity at contract value. The fund's crediting rate is periodically adjusted based on the performance of the underlying investments.

#### ***(3) Fair Value Measurements (Continued)***

**Transfers Between Levels** - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

#### ***(4) Related Party Transactions and Party-in-Interest Transactions***

The Plan pays fees for several arrangements with service providers and affiliated entities. These transactions are considered exempt party-in-interest transactions under ERISA.

The amounts due from Local Union 456 IBEW Distribution Account ("Distribution Account") are unsecured, due on demand, noninterest bearing and are the results of the Distribution Account acting as a collection agent for employer contributions. As of December 31, 2024 and 2023, the amounts due from the Distribution Account amounted to \$54,984 and \$45,929, respectively.

The Plan leases office space on an annual basis from the New Brunswick Electrician's Club which is a wholly owned subsidiary of the Local. The Plan's current lease matured on September 30, 2026 and pays \$1,300 monthly. The amount of rent and occupancy expense paid during the Plan year ended December 31, 2024 and 2023 was \$16,469 and \$17,740, respectively.

#### ***(5) Commitments***

The Plan has a contract with I.E. Shaffer and Company (the "Administrator") for providing monthly administrative services expiring November 1, 2025 with consecutive one-year automatic renewals unless terminated by either party by written notice at least sixty days prior to the anniversary date. The fees paid to the administrator are a percentage of employer contributions received during a plan year, payable on a monthly basis. The rate is 2% of the first \$3.5 million of contributions during a plan year, and then 1% of the excess, payable on a monthly basis. The third party administrator fees incurred during the years ended December 31, 2024 and 2023 amounted to \$248,762 and \$259,908, respectively. As of December 31, 2024 and 2023, the Plan owes the Administrator \$-0- and \$40,568, respectively.

The Plan has a contract with Empower Retirement Insurance and Annuity Company ("Empower") for providing administrative and recordkeeping support. The agreement is effective on April 1, 2023 and continuances until terminated by either party by written notice at least sixty days prior to the anniversary date. The disclosure amount of the fee in 2024 and 2023 will equal the recordkeeping revenue (e.g. 12b-1 fees, Sub Accounting fees, Finder's fee, and Additional Fees) directly received by or allocated internally to Empower and will be deposited into the Plan Expense Account on a quarterly basis. As of December 2024 and 2023, the recordkeeping fees were \$76,449 and \$75,999, respectively.

#### ***(6) Reimbursement of Administrative Fees***

Empower has an agreement to reimburse the Plan for certain operating expenses. The reimbursement agreement is based on a percentage of the new deposits and the asset base, payable quarterly. The percentages range from 0% to 1% of all new deposits and 0% to 0.4% of the asset base for all Empower funds that the participants direct contributions to or have a balance in. The net administrative fees reimbursed for the years ended December 31, 2024 and 2023 amounted to \$321,516 and \$324,503, respectively. As of December 31, 2024 and 2023, the Plan had receivable balances for reimbursed expenses under this agreement of \$162,233 and \$127,213, respectively.

***(7) Reciprocal Transactions***

The Plan follows the Electrical Industry Pension Reciprocity Agreements. In accordance with these agreements, the Plan is required to remit amounts received and is entitled to receive payments from participating employers on behalf of temporary employees to and from the employees' participating local unions.

For the years ended December 31, 2024 and 2023, the Plan remitted reciprocal payments of \$9,355,234 and \$8,265,067 and received reciprocal contributions of \$1,429,634 and \$1,231,029, respectively, in accordance with these agreements with the participating local unions. Reciprocal contributions received and paid are included in the employer's contributions in the statement of changes in net assets available for benefits. No allowance for credit losses as of December 31, 2024 and 2023 was necessary for reciprocal payments due to the Plan.

***(8) Plan Termination***

If the Plan were to be terminated by the Trustees, all the assets of the Plan would be distributed to the participants in accordance with their account balances after providing for all expenses of the Plan. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation as federal regulations do not require or permit such insurance for this type of plan.

***(9) Tax Status***

The Plan obtained a favorable tax determination letter, dated January 12, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***(10) Risks and Uncertainties***

***Investment Risk*** - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.



