## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of  
**SRI International 401(k) Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the financial statements of SRI International 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

#### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the SRI International 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

General – The Plan, formed on January 1, 2023, is a defined contribution profit-sharing plan covering all U.S. payroll staff members of SRI International (the “Company”) with a hire date or most recent rehire date on or after January 1, 2023. Employees are eligible to participate in the Plan immediately upon employment for the purpose of making salary deferral contributions.

The Plan is administered by the Company’s Retirement Plan Committee (“Committee”), which is a committee of the board of directors of the Company. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

Contributions – The amount that may be contributed is limited by the Internal Revenue Service (“IRS”) on an annual basis. Employees may contribute, on a pre-tax or Roth after-tax basis, a minimum of 0.01% of eligible compensation up to an annual maximum of \$23,000 for 2024, limited to 75% of eligible compensation. If the employee has attained age 50 by the last day of the calendar year they are eligible to make an additional “catch-up contribution” of \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company will make matching contributions to each participant. Employees who are classified as a SRI Benefits Rate 2 employee are eligible to receive matching contributions equal to 50% of the participant’s elective deferrals; however, the Company shall not make a contribution on any participant’s elective deferral that exceeds 4% of the participant’s compensation. Thus, the maximum company matching contribution for any individual shall be 2% of the participant’s compensation. Employees who are not classified as a SRI Benefits Rate 2 employee are eligible to receive matching contributions equal to 125% of the participant’s elective deferrals; however, the Company shall not make a contribution on any participant’s elective deferral that exceeds 6% of the participant’s compensation. Thus, the maximum company matching contribution for any individual shall be 7.5% of the participant’s compensation. Compensation is defined as base salary, excluding payouts under the performance based compensation plan and excluding performance based executive bonuses.

Investment Options – Participants may direct their account balances into investment options provided by the Plan. Investment options are mutual funds, variable annuity accounts from College Retirement Equities Fund (“CREF”), a fixed annuity from Teachers Insurance and Annuity Association (“TIAA”), common collective trust funds, and a brokerage window managed by TIAA-CREF offering a large variety of additional mutual funds. Amounts in CREF are held under variable annuity accounts; CREF is thus an annuity carrier. Participants may transfer amounts between various investment options offered under the Plan and transfer amounts from the various investment options to TIAA Traditional Annuity Contracts on a daily basis. Under certain circumstances, participants may transfer a portion of their TIAA Traditional Annuity Contracts balance to other investments offered under the Plan.

## SRI INTERNATIONAL 401(k) PLAN

### NOTES TO FINANCIAL STATEMENTS

#### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Participants' Accounts – Participants' accounts are credited with participant contributions, employer matching contributions and an allocation of the Plan's earnings and/or losses and administrative expenses. Revenue sharing amounts not used to pay Plan expenses will be allocated to each participant's account in accordance with the Plan document. Allocation of the Plan's earnings and revenue sharing is based on the value of each participant's individual fund investments. Allocation of administrative expenses is based on account balances or specific participant transactions. Participants may elect to have contributions invested in one or more of the available investment options offered by the Plan. Participants may elect to apply the value of their account to the purchase of individual annuities from TIAA. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their own contributions and the related employer matching contributions made to the Plan.

Payment of Benefits – Upon the earlier of termination of employment, attainment of age 59½ while still employed, or during the year in which the participant attains age 72, the participant is entitled to receive benefits via periodic payments based on the annuity option selected. Participants may also receive benefits in a lump-sum settlement from the TIAA and CREF equal to the vested interest in their account. Distributions are also available in the event of financial hardship or if the participant becomes disabled. The full current value of a participant's account will be paid to the participant's beneficiary, subject to certain provisions, in the event of the participant's death at any time before retirement.

Expenses – The Plan permits the payment of Plan expenses to be made from the Plan's assets (see Note 6). Further, certain expenses specifically incurred by and attributable to a participant will be paid out of the related participant's account. Administrative expenses not paid by the Plan will be paid by the Company. Investment management related expenses are included in the net appreciation of fair value of investments.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's eligible account, as defined by the Plan. All notes shall bear a reasonable fixed rate of interest and shall be commensurate with rates charged by creditors in similar circumstances. The notes have fixed terms, not to exceed five years, unless the note is for the purchase of a primary residence for which the repayment period could be up to fifteen years. Principal and interest are paid directly from the bank account of the borrowers and can continue to be repaid even if a participant terminated employment.

#### NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting – These financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### NOTES TO FINANCIAL STATEMENTS

#### NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition – Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value, or net asset value (“NAV”)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors, TIAA and CREF. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments is reflected in the Statement of Changes in Net Assets Available for Benefits and includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

#### NOTE 3 – INFORMATION CERTIFIED BY THE INSURANCE COMPANIES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, as the insurance companies of the Plan and as agent for TIAA, FSB, directed custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at fair value
- Investments at net asset value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

#### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan, including mutual funds in the TIAA Participant Directed Brokerage Account, are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

CREF Accounts: The CREF Accounts are valued at the accumulation unit value (“AUV”) of units held by the Plan at year-end. The AUV for each fund is a function of the underlying investments’ performance and expenses and is listed on the National Association of Securities Dealers Automated Quotations. Accumulation units are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange is open for business. Participants will not be permitted to make electronic transfers into a CREF Account for 90 days if a purchase, sale and repurchase within that fund is made within a 60-day period, other than for the CREF Money Market.

Common Collective Trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

TIAA Traditional Annuity: The TIAA Traditional Annuity holdings are made up of liquid and illiquid contracts. The liquid contracts are considered fully benefit-responsive and, accordingly, are reported at contract value and excluded from the following fair value hierarchy tables. The illiquid contracts are considered non-benefit responsive and are reported at fair value. Fair value is determined based on accumulated contributions and interest credited to the Plan's contracts, less any withdrawals. This fair value determination approximates a discounted cash flow value, which is used to calculate fair value, using an appropriate risk-adjusted market discount rate which correlates closely with TIAA Traditional Annuity's historical crediting rates. TIAA issues various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The TIAA Traditional Annuity offers participants a fixed rate annuity contract that is fully and unconditionally guaranteed by TIAA. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest (generally 3%, but averaged 4.61% during 2024) and the potential for additional interest, if declared by TIAA. The guarantees and returns of the TIAA Traditional Annuity are backed by TIAA's claims-paying ability. TIAA's ability to meet its contractual obligations may be affected by future economic and regulatory developments. TIAA Traditional Annuity holdings of \$5,473,890 and \$5,116,341 as of December 31, 2024 and 2023, respectively, were held within liquid contracts and considered fully benefit-responsive and are reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if there were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's investments are shares of mutual funds and annuity contracts managed by TIAA and CREF. In addition, TIAA is the record keeper for the Plan. Therefore, these transactions involving TIAA and CREF, qualify as party-in-interest transactions.

TIAA provides certain administrative services to the Plan pursuant to a service agreement between the Company and TIAA. TIAA receives revenue from certain investment service providers for services TIAA provides to the funds. This revenue is used to offset certain amounts owed to TIAA for its administrative services to the Plan. If the revenue received by TIAA from such investment service providers exceeds the amount owed under the service agreement, TIAA remits the excess to the Plan as a plan servicing credit. Such amounts may be applied to pay Plan administration fees or can also be allocated to participants. As of December 31, 2024, the revenue credit account totaled \$14. During 2024, \$8,043 of plan servicing credits were allocated to participants.

Fees paid by the Plan to TIAA for administrative services amounted to \$10,232 for the year ended December 31, 2024, which were offset by Plan services credits of \$225.

#### NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 20.7% and 27.0% of the Plan's investments were invested in the TIAA Traditional Benefit Responsive Fund, respectively.

**NOTE 9 – TAX STATUS**

The IRS has determined and informed the Company by a letter dated September 6, 2024, that the Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
