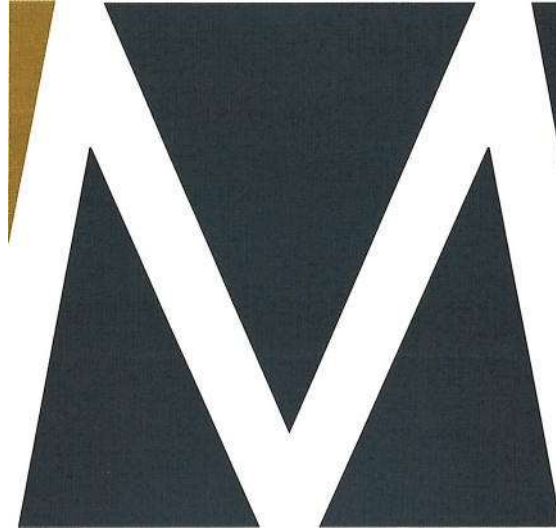

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SCI Engineering, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SCI Engineering, Inc. 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about SCI Engineering, Inc. 401(k) Retirement Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of SCI Engineering, Inc. 401(k) Retirement Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about SCI Engineering, Inc. 401(k) Retirement Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Years Ended December 31, 2024 and 2023

Note A - Description of Plan

The following description of SCI Engineering, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan, which is a prototype defined contribution plan, covers employees of SCI Engineering, Inc. (the "Plan sponsor" or "employer"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Covered employees are eligible for pre-tax, Roth and matching contributions upon attaining age 18 and completing three consecutive months of service.

Each year, participants may contribute up to 75% of pre-tax or after-tax annual compensation, as defined in the Plan, subject to limitations prescribed by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing rollover distributions from other qualified defined contribution plans. Additionally, the Plan permits participants who have attained age 50 to make "catch-up" contributions in accordance with, and subject to, the limitations present in the IRC. Participants direct the investment of their contributions and those of the Plan sponsor into various investment options offered by the Plan. For any eligible employee hired after February 1, 2008, if the eligible employee does not make an elective deferral election after receiving notice from the Plan sponsor, they will be deemed to have made an automatic deferral election of 3% of compensation. Additionally, automatic deferral elections will increase by 1% on each anniversary date until they reach 10%.

The Plan includes a safe-harbor employer match contribution. The employer will match participant contributed amounts equal to 100% of the first 3% of participants' eligible compensation contributed to the Plan, and 50% of the next 2% of participants eligible compensation contributed to the Plan. As defined by the Plan, the employer may also make discretionary contributions. The employer did not make significant discretionary contributions in 2024 or 2023.

Appreciation or depreciation in the value of the assets of the Plan is allocated to the participants on the basis of the daily value of each participant's account.

Participants are immediately vested in their contributions and the safe-harbor employer matching contributions plus actual earnings or losses thereon. Vesting in the employer's discretionary contributions and the related earnings or losses thereon, occurs 20% after the completion of two years of continuous service and 20% per year of completed continuous service thereafter. Participants are automatically fully vested at their normal retirement date or upon death or becoming disabled, regardless of the number of years of participation.

Loans are available to all participants in the Plan who are currently employed by the Plan sponsor. Loans are made to all participants on a reasonably equivalent and nondiscriminatory basis under the Plan's loan policy. Certain limits and rules apply to all participant loans. Principal and interest are paid ratably through payroll deductions.

On termination of service for any reason, including due to death, disability, retirement, or other reasons, a participant will receive the value of the participant's vested interest in his or her account in a lump-sum amount. A participant may elect to receive an amount prior to termination if they have attained age 59½ or have experienced financial hardship and satisfy certain conditions established by the Plan document. A participant who has attained a defined age and is no longer employed by the Plan sponsor but has a remaining account balance and has not elected to receive payment of benefits must receive a required minimum distribution ("RMD") as defined by the Internal Revenue Service.

The Plan stipulates that forfeited amounts are to be used to reduce future employer contributions or to pay Plan expenses. At December 31, 2024 and 2023, the Plan did not have a balance in forfeited nonvested accounts. The forfeitures utilized in 2024 and 2023 were not significant.

The Plan sponsor has the right to terminate the Plan at any time. In the event of termination, the value of the respective participant accounts, including employer contributions and earnings/losses thereon, would become fully vested at the date of termination.

Note B - Summary of Significant Accounting Policies

Basis of accounting The financial statements of the Plan are presented on the accrual basis of accounting.

Use of estimates The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of additions to and deductions from net assets available during the reporting periods. Actual results could differ from those estimates.

Investment valuation Investments of the Plan were held by the Plan's investment custodians. The investments of the Plan are in mutual funds and a fully benefit-responsive investment contract and are stated at fair value as determined and reported to the Plan sponsor by the investment custodians (see Notes C and D).

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan would measure fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are utilized when there are observable inputs other than quoted market prices for the asset, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the Plan. Level 3 inputs would only be used when Level 1 or Level 2 inputs are not available.

At December 31, 2024 and 2023, some of the Plan's assets are invested in a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America ("EAICA"). The statements of net assets available for benefits present the fair value of the investment contract, which equals the contract value (see Note D).

Payment of benefits Benefits are recorded when paid.

Notes receivable from participants Notes receivable from participants ("loans") are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Loans are considered delinquent in the event payments are not made when due or within the cure period stipulated in the Plan. Loan balances are secured by participant accounts.

Expenses Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan sponsor. Investment management expenses and certain costs of regulatory compliance and Plan administration are included in administrative expenses in the accompanying statements of changes in net assets available for benefits. Expenses that are paid by the Plan sponsor are excluded from these financial statements.

Subsequent events The Plan sponsor has determined that no subsequent events have occurred since December 31, 2024, that would require recognition or disclosure in the financial statements. The Plan sponsor has evaluated all subsequent events as of October 6, 2025, which is the date these financial statements were available to be issued, but have not evaluated any events after that date.

Note C - Certified Investments and Related Fair Value Measurements

Certain information related to investments and notes receivable from participants as presented in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net investment gain/loss (comprised of net appreciation (depreciation) in fair value of investments and realized gains/losses) as well as investment income (consisting of capital gains, interest and dividends) and contribution and benefit payment activities for the years then ended,

was obtained or derived from information supplied to the Plan sponsor and certified as complete and accurate by the investment custodians for the Plan, Empower Trust Company and EAICA.

As indicated in the table below, mutual funds are valued at the daily closing price at the Plan's year end as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 investment Participants can invest Plan assets in an investment contract with EAICA through its Key Guaranteed Portfolio Fund ("KGPF") which is not actively traded. However, other observable inputs are available as the KGPF is a general depository account of EAICA with no underlying maturities (see Note D).

Gains/losses (realized and unrealized) represent the Plan's allocable portion of the market appreciation/depreciation and actual gain/loss experienced on the various investments and are reported as net investment gain/loss in the statements of changes in net assets available for benefits. The statements of changes in net assets available for benefits include investment income related to the KGPF investment contract of \$13,715 and \$40 for the years ended December 31, 2024 and 2023, respectively. Substantially all of the remaining investment income, as well as all of the net investment gain, relates to the Plan's investments in mutual funds in both years.

Note D - Key Guaranteed Portfolio Fund Investment Contract

The Plan has entered into an investment contract with EAICA through its KGPF investment option. The repayment of principal and interest credited to participants holding the investment is a financial obligation of EAICA. The investment's contract or proceeds cannot and will not be assigned or sold to another party without consent of the Plan. Either the Plan or EAICA may terminate the investment contract with at least sixty days written notice.

The terms of the investment contract require all permitted participant-initiated transactions involving the KGPF to occur at contract value with no conditions, limits, or restrictions. Permitted participant-initiated transactions are those allowed by the Plan, such as withdrawals for benefits, loans, or transfers to other investment choices within the Plan. The KGPF investment option allows a participant reasonable access to their assets. Although Plan participants generally may withdraw assets from the KGPF investment option without restriction, EAICA may impose a hold period at the contract level in the event of full or partial contract cessation. Since the KGPF investment is an obligation of EAICA, the occurrence of an event that limits the ability of the investment to transact at contract value between EAICA and a participant holding the investment is not considered probable.

As such, the Plan considers this contract to be fully benefit-responsive. However, if an event should ever occur such that the realization of full contract value for the investment contract is no longer probable, the KGPF investment option may no longer be considered fully benefit-responsive. See also Note G.

As described in Note B, because the KGPF investment is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract because it represents the amount that would be paid or received by a participant if they were to initiate permitted transactions under the terms of the Plan.

The KGPF investment option seeks to achieve consistent returns to support a competitive crediting rate. Bonds invested in the EAICA general account segment have an average maturity between three and seven years; are investment-grade in quality; and are diversified across a range of fixed-income asset classes. The KGPF investment option has a portfolio investment rate design in which all deposits are credited with the same interest rate on a daily basis, and with no set maturity. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract to be 0%, and prevailing market conditions.

As contract value is equal to fair value at December 31, 2024 and 2023, the average yield earned by the Plan and the average yield earned by the Plan adjusted to reflect the actual interest rate credited to plan participants are 1.41% and 1.23% for the years then ended, respectively.

Note E - Income Tax Status

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan sponsor believes the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Note F - Related-Party and Party-in-Interest Transactions

The Plan's investments in the KGPF described in Note D are managed by EAICA. As EAICA is an investment custodian, transactions in this account and underlying investment securities qualify as party-in-interest transactions. The balance and activity of the Plan's investments managed by EAICA were insignificant as of and for the year ended December 31, 2023. In the year ended December 31, 2024, approximately \$1,019,700 was transferred into the KGPF from other Plan investment options, and approximately \$27,900 and \$7,000 was contributed to the Plan by participants and the employer, respectively.

Note G - Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of those securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

KGPF investment contract The KGPF is backed by the full faith and creditworthiness of EAICA, and the KGPF's principal and interest are guaranteed by EAICA's general account assets. However, any guarantees are subject to the claims paying ability of EAICA. This investment option is not guaranteed by the FDIC or any other government agency. The credit rating of EAICA's general account by outside rating agencies at December 31, 2024, was considered excellent/very strong and reserves against contract value for credit risk of EAICA or otherwise were insignificant in comparison to total assets of the general fund.
