## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Air New Zealand Limited 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**A. General**

Air New Zealand Limited (the “Company”) is the Plan Sponsor and plan administrator. The Plan is a defined contribution plan established by the Company for the purpose of providing retirement benefits for all eligible employees of the Company. There is no service requirement for eligibility to participate in the Plan. The service requirement for matching contributions and profit sharing contributions is thirty days of consecutive service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan funds are held by Empower Retirement, LLC and Empower Annuity Insurance Company of America (the “Trustees”).

**B. Contributions**

Each year, participants may contribute up to 75% of their eligible compensation in pre-tax or Roth contributions, as defined in the Plan. Participants may also rollover amounts representing distributions from other qualified plans. The Company’s safe harbor matching contribution is equal to 100% of the first 3% of participant contributions, and then 50% of the next 6% of participant contributions. The Company may also make profit sharing contributions at its discretion. The Company did not make any profit sharing contributions in 2024. Contributions are subject to Internal Revenue Code (“IRC”) limitations.

**C. Participant Accounts**

Each participant’s account is credited with the participant’s contributions, rollover contributions, investment earnings and Company matching and profit sharing contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may change their investment options at any time. During 2020, due to reduction in force, management determined a partial plan termination had occurred and affected participants were made 100% vested.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Valuation of Investments**

Investments held by an employee benefit plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are based on quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

**C. Valuation of Investments (Continued)**

Level 1 investments consist of mutual funds actively traded on a national exchange based on quoted market prices. The common/collective trusts and pooled separate accounts are valued at net asset value or its equivalent as a practical expedient. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the common/collective trusts or pooled separate accounts. Net appreciation of investments includes realized and unrealized gains and losses on investments sold or held during the year.

The Plan maintains a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America through the guaranteed income fund. Contributions to the guaranteed income fund are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The guaranteed income fund meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

**D. Administrative Expenses**

Most administrative expenses of the Plan are paid by the Company.

**E. Distributions and Withdrawals**

Each participant's share of the net assets of the Plan is allocated to an individual account. Vested benefits are payable upon termination, death or retirement. Additionally, a participant may withdraw vested amounts from his or her account prior to termination of employment with the Company, in accordance with Plan rules.

**F. Forfeiture of Benefits**

If a participant terminates prior to vesting 100% in Company contributions, the forfeited balance will be used to offset administrative expenses or reduce Company matching contributions. During 2024, forfeitures totaled \$2,007; forfeitures of \$524 were used to offset administrative expenses and \$0 were used to offset Company matching contributions. Forfeitures available for future use as of December 31, 2024 and 2023 totaled \$4,002 and \$2,449, respectively.

**NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Retirement, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan.

**NOTE 4 - INCOME TAX STATUS**

The Company has adopted the Empower Non-Standardized Prototype 401(k) and Profit Sharing Plan. The Internal Revenue Service granted the Prototype Plan an opinion dated December 4, 2020, stating that it was designed in accordance with applicable IRC requirements as of that date. The Plan's tax counsel believes that the Plan, as originally designed and as amended, is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. During 2020, due to reduction in force, management determined a partial plan termination had occurred and affected participants were made 100% vested.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan provides for investment options that are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 7 - RELATED PARTY TRANSACTIONS**

Plan investments are managed by Empower Retirement, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 29, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
