Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of OrthoLoneStar 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE 1 - PLAN DESCRIPTION

The following is a brief description of the OrthoLoneStar 401(k) Retirement Plan (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan sponsored by OrthoLoneStar, PLLC (the "Company"), for the benefit of its full-time employees. Initial enrollment is available at any time once age and service requirements have been met. To participate in the employer matching portion and employer nonelective contributions of the Plan, an employee must complete one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Governors oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Entrance Date

An employee is eligible to enter the Plan on the first day of the quarter coinciding with or next following the date eligibility requirements are satisfied.

Contributions

The Plan permits eligible employees to make annual contributions of up to 100% of eligible compensation through a salary reduction election, capped by allowable limits established by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions pursuant to IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Company contributions consists of a nonelective safe harbor contribution and a discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company made a non-elective safe harbor contribution of 3% of eligible compensation. The Company contributed approximately \$2,934,000 in safe harbor contributions to the Plan during the year ended December 31, 2024. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Governors. During the year ended December 31, 2024, the Company made approximately \$5,539,000 in profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Forfeitures

Forfeitures are used to reduce future Company contributions or administrative fees. For the year ended December 31, 2024, approximately \$235,000 was used to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts amount to approximately \$106,000 and \$217,000, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - PLAN DESCRIPTION (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earnings is based on years of service. A participant is 100% vested after six years of credited service.

Participant Notes Receivables

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate shall bear a reasonable rate of interest as determined by the Administrator, based on prevailing interest rates at the time of the loan. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon the termination of service, participants may elect to receive a lump-sum amount or installments equal to the value of their accounts. Account balances of terminated participants of \$5,000 or less will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant's consent before the participant's normal retirement age will be rolled over to an individual retirement plan designated by the Plan Administrator.

Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Fair Value Measurements

Accounting Standards Codification (ASC) 820 defines fair value, establishes a framework for measuring fair value, and enhances disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (or exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the inputs that market participants would use in pricing the asset or liability and are developed based on the best information available in the circumstances.

The fair value hierarchy input levels are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, then the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Management Evaluation of Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - PARTICIPANT DIRECTED INVESTMENTS

Participant contributions held in the Plan are participant-directed accounts. That is, individual participants decide how funds held in trust for them are allocated among various investment options.

NOTE 4 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by John Hancock Trust Company, LLC (the "Trustee"). The Trustee as defined by the Plan and, therefore, the related transactions qualify as party-in-interest. The Trustee provides to the Plan certain accounting and administrative services for which no fees are charged.

NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, John Hancock Trust Company LLC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information in the financial statements and supplemental schedule.

NOTE 6 - TAX STATUS

The Plan has adopted a prototype non-standardized profit-sharing plan with CODA and received an opinion letter dated June 30, 2020, stating that the Plan, as then designed, was qualified under Section 401 of the Internal Revenue Code. The prototype plan has been amended since receiving the opinion letter. The OrthoLoneStar 401(k) Retirement Plan has not requested a separate opinion letter. The Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - ADMINISTRATIVE EXPENSES

Administrative expenses of the Plan may be paid directly by the Company or from the assets of the Plan. The expenses that are paid from Plan assets will either be shared by all participants or charged directly to the account of the participant on whose sole behalf the expense is incurred. In addition, certain investment related expenses are included in the net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

NOTE 8 - FAIR VALUE MEASUREMENTS

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Self-directed brokerage accounts: Valued at the closing price of reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common / collective trust: Valued at fair value, using the practical expedient as provided by the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820. The Plan's investments in common and collective trusts, which invest in fixed income securities, guaranteed investment contracts, and money market funds, calculate NAV per unit. Investments in common and collective trusts are market to market and priced daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Company's policy is to recognize transfers between levels at the end of each reporting period, if applicable. There were no transfers between Level 1, 2, or 3 assets or liabilities during the year ended December 31, 2024.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 38% of the Plan's investments were invested in the following funds: Vanguard Target Retirement 2025 Fund, Vanguard Target Retirement 2035 Fund, and Fidelity 500 Index Fund. At December 31, 2023, approximately 37% of the Plan's investments were invested in the following funds: Vanguard Target Retirement 2025 Fund, Vanguard Target Retirement 2035 Fund, and Fidelity 500 Index Fund.
