Opinion

We have audited the financial statements of Curtis C. Gunn, Inc. Welfare Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan (modified cash basis) as of December 31, 2024 and 2023, and the changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

Note 1. Description of Plan

The following description of Curtis C. Gunn, Inc. Welfare Benefit Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established to provide various medical, dental, vision, prescription drug, cancer, medical reimbursement, short and long-term disability and life insurance under Internal Revenue Code Section 125 ("Cafeteria Plan") to the employees of Curtis C. Gunn, Inc. and its affiliates (the "Employer"). Eligible employees may become participants after 60 days of continuous full-time service. An employee must work a minimum of 30 hours per week to meet the full-time requirement. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan maintains stop-loss insurance to limit the losses on any one individual to \$110,000 annually and unlimited over a lifetime.

Benefits

The Plan provides health benefits (medical, prescription drugs, hospital, critical illness, vision, cancer, and dental), disability benefits, and death benefits to full-time employees of the Employer and to their beneficiaries and covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Self-insured benefits

Medical and prescription drug claims of active participants and their covered dependents are processed by a third-party administrator, Imagine360, LLC. The claims processor pays claims directly to or on behalf of participants from the trust's cash account. Despite the Plan's utilization of a third-party claims' processor, the responsibility for payments to providers is retained by the Plan.

The Plan maintains stop-loss insurance to limit its exposure for self-insured benefits on any one individual participant to \$110,000 with an unlimited annual maximum benefit.

Insured benefits

All benefits other than medical and prescription drug claims are fully insured. The Employer purchases annual insurance contracts for these insured benefits. Premiums for insured benefits are paid from the trust's cash account.

Contributions

The plan agreement provides that the Employer and participants make monthly contributions of a specified amount to the Plan. The contribution rates are determined annually. An employee may contribute specified amounts, determined annually, to extend coverage to eligible dependents of the employee.

From time to time, the Plan may request additional Employer contributions based upon claims experience and other expenses. During 2024, there were no additional Employer contributions received by the Plan to cover claims and expenses.

Note 2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the modified cash basis of accounting, which differs from accounting principles generally accepted in the United States of America ("GAAP"). On the modified cash basis, certain revenues (primarily Employer and participant contributions) are recognized when received rather than when earned, and certain expenses (primarily medical claims, premiums and fees) are recognized when paid rather than when the obligation is incurred. Accordingly, these financial statements are not intended to be presented in accordance with GAAP.

Use of Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimated amounts.

Stop Loss

Premiums for stop loss insurance are included in premium payments whereas stop loss refunds totaling \$506,691 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits (modified cash basis).

Plan Benefits

Benefits are recorded when paid.

Claims Incurred but Not Reported

Plan obligations as of December 31, 2024 and 2023, for medical claims incurred but not reported at that date are estimated by the Plan's management based on payments made subsequent to year-end per claims data provided by the Plan's third-party administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Subsequent Events

The Plan evaluated the effect subsequent events would have on the financial statements through October 3, 2025, which is the date the financial statements were available to be issued.

Note 3. Tax Status

The trust funding certain benefits of the Plan received an exemption letter from the IRS dated December 1, 1994, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"). However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by

the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4. Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to amend and terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Employer will contribute the necessary amounts to fund all claims incurred prior to the date of termination.

Note 5. Concentration of Credit Risk

The Plan maintains bank deposits, the balances of which usually exceed federally insured amounts.

Note 6. Risk and Uncertainties

The Plan's benefit obligations are reported based on certain assumptions pertaining to claims reporting lag times and payment history, both of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term-would-be material to the financial statements.

Note 7. Plan Benefit Obligations

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators. During 2024, the Plan paid Gunn GP, LLC, an affiliate of the plan administrator, \$61,200 in management fees and \$2,400 in shared technology expenses. These expenses are reported on the statement of changes in net assets available for benefits (modified cash basis) as administrative expenses. These transactions are considered exempt party-in-interest transactions under ERISA.
