Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of HFS 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - PLAN DESCRIPTION

The following description of HFS 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by Hallmark Financial Services, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is administered by the Company, whereby employees of the Company serve as the Benefits Committee. The Plan also utilizes Vanguard Fiduciary Trust Company as its trustee and recordkeeper.

Contributions

Employees who have completed one month of service are eligible to participate in the Plan except for the following:

- Leased employees
- Employees who become employees due to an asset or stock acquisition, merger or similar transaction involving a change in the employer of a trade or business (during the transition period only)
- Nonresident aliens
- Employees covered by a collective bargaining agreement
- Temporary employees, including interns, who have not attained 1,000 hours of service

Unless otherwise elected, each eligible participant will automatically have 6% of eligible compensation before taxes deferred into the Plan immediately upon meeting eligibility requirements.

Effective March 1, 2022, Roth deferrals are now permitted under the Plan. A Participant may defer any dollar amount, that when converted to a percentage, is not in excess of 85% of Plan Compensation each pay period, not to exceed Internal Revenue Service (“IRS”) limitations. The maximum limits apply to the combination of pre-tax elective deferrals and Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options by the Plan. The minimum investment that can be directed into any one option is 1% and whole increments of 1% must be used. Investment options are changed from time to time by the Benefits Committee.

The Company may make discretionary profit-sharing, matching and qualified matching contributions. Participants must be employed on the last day of the year and have been credited with at least 1,000 hours of service to be eligible to receive the discretionary match and profit-sharing contributions. Any participant making deferrals who is a non-highly compensated employee is eligible to receive qualified matching contributions. During the 2024 Plan year, the Company made quarterly discretionary matching contributions. Discretionary profit-sharing and qualified matching contributions were not made during the Plan year 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of (a) the Company's discretionary matching, profit sharing, and qualified matching contributions, (b) Plan earnings or losses and (c) certain administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined in the Plan agreement.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for discretionary company matching, qualified matching and profit-sharing contributions is based on vesting periods of service. Participants are credited with a period of service for 1,000 hours of service. A participant becomes 100% vested in all contributions upon death, disability, or attaining normal retirement age.

Participants are vested in Company discretionary matching, profit-sharing, and qualified matching contributions based on the following schedule:

Forfeitures

Employer contributions, which are not vested at the time a participant withdraws from the Plan by reason of termination of employment, are forfeited and may be used for certain items as specified in the Plan agreement, including payment of expenses of the Plan, to restore participants' individual accounts, or reduce employer contributions. At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$1,292 and \$12,275, respectively. Forfeiture of \$23,999 were used to reduce employer contribution for the year ended December 31, 2024.

Notes Receivable from Participants

The loans are secured by the balance in the participant's account. Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, are secured by the balances in the participant's account, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Interest rates on outstanding notes receivable ranged from 4.25% to 9.50% at December 31, 2024. Note terms generally range from one to five years except for notes to purchase a principal residence, which can exceed five years. Principal and interest are paid ratably through payroll deductions, and notes receivable outstanding at December 31, 2024 are due in various amounts through July 2036.

Benefits Paid to Participants

Upon termination of service due to death, disability, or retirement, a participant is entitled to receive the vested percentage of their account balance. If the participant's account balance is less than \$5,000, the Plan will distribute that portion in a lump sum, subject to the automatic rollover provisions, as defined, as soon as administratively practicable. If the participant's vested account balance is greater than \$5,000, the participant may elect to receive distribution either in a lump sum, partial payment, or in installments over a specified period of time.

Participants may receive an in-service distribution from the Plan prior to termination provided they have attained age 59½. In addition, hardship distributions may be made to satisfy certain immediate and heavy financial needs a participant may have, subject to certain limitations as defined in the Plan agreement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("US GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the framework are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at fair value based on published market prices as of the close of business on the last business day of the Plan year, which represents the net asset value ("NAV") of shares held by the Plan.

Collective trust funds: Stated at fair value as determined by the issuer of the collective investment trusts based on the fair market value of the underlying investments, which is valued at the NAV of units of the collective investment trusts. The NAV is used as a practical expedient to estimate the fair value. This practical expedient would not be used in it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain administrative fees related to the administration of the Plan are paid by the Plan or by the Company. Certain fees incurred by the Plan are included in net appreciation in fair value of investments on the statement of changes in net assets as they are paid through revenue sharing, rather than a direct payment. The Plan makes direct payments to service providers which are not covered by revenue sharing. The Plan also provides loans to participants from their vested account balance. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transactions rules under ERISA.

NOTE 6 - INCOME TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by the Vanguard Group ("Vanguard"). Vanguard obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the document, as then designed, was in compliance with the applicable provisions of the Internal Revenue Code of 1986, as amended (the "Code"). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The Plan Administrator has analyzed the Plan's tax positions and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for investments in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, all participants would become fully vested in their entire account balances and the net assets of the Plan would be distributed to the participants of the Plan in accordance with the provisions of ERISA.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated events subsequent to December 31, 2024 and through October 9, 2025, the date on which the financial statements were available to be issued and determined no such events were identified for disclosure in the financial statements.
