Report of Independent Auditors

To the Participants and Plan Administrators of
CPL Pacific 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CPL Pacific 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) and delinquent participant contributions as of December 31, 2024 (referred to as the “supplemental schedules”), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

December 31, 2024 and 2023

1. Description of the Plan

The following description of the CPL Pacific 401(k) Savings Plan (the Plan), formerly The Micronesian Telecommunications Corporation Non Union 401(k) Plan, provides general information about the Plan's provisions. CPL Pacific, LLC is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan covering all eligible employees of the following entities: CPL Pacific, LLC, The Micronesian Telecommunications Corporation; PTI Pacifica Inc.; IP&E Holdings, LLC; IP&E Services LLC; Mariana Acquisition Corporation; and Fujita Property Guam, Inc. All of the above entities are collectively referred to as the "Company".

The Plan is a defined contribution plan established by the Company covering substantially all employees who have attained the age of 18 and older except for union employees, nonresident aliens, leased employees and independent contractors or other individuals who are non-employees but who are recharacterized as employees by the Internal Revenue Service (IRS).

The Company is the plan administrator and is responsible for the general administration of the Plan. ASC Trust LLC (ASC) is the trustee and recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching and discretionary contributions and allocations of plan earnings. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements, continued

1. Description of the Plan, continued

Contributions

Each plan year, participants may contribute a percentage of their annual compensation, as defined in the Plan. If automatically enrolled, a participant's deferral is set at 3% of eligible compensation and will be increased in 1% increments for each succeeding plan year of participation up to a maximum of 6% until changed by the participant. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Company contributes 100% of the participant's elective deferrals that do not exceed 3% of participant compensation. The Company may also contribute 50% of the participant's elective deferrals that exceed 3% but do not exceed 6% of participant compensation. In addition, the Company may elect to make discretionary contributions. No such amount was contributed for the plan year ended December 31, 2024. The Plan also permits rollover contributions from other qualified plans. All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Plan assets are held in trust by ASC. Participants may direct the investment of their contributions among one or more of the several options offered under the Plan, and may elect to change the amount of their contributions or to transfer all or part of their individual plan account balances among such options, subject in each case to applicable conditions and limitations established under the Plan. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching, discretionary matching and discretionary contribution portions of a participant's account plus actual earnings thereon is based on years of service as follows:

<u>Years of Vesting Service</u>	<u>Vested Percentage</u>
Less than 3 years	0%
3 years	100%

For vesting purposes, the year of service means the participant has completed at least 1,000 service hours during the plan year. Participants shall become fully vested in their account balance at the time of death, permanent disability or upon attaining normal retirement age as defined in the plan document.

Payment of Benefits

Upon separation of service with the Company due to retirement, disability, death or termination, a participant may elect to receive either a lump-sum or elect a direct rollover to another qualified plan.

1. Description of the Plan, continued

Payment of Benefits, continued

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the IRS and a participant must exhaust all available loan options and available distributions prior to requesting hardship withdrawals.

Forfeitures

Forfeitures occur when participants leave the Company and are not fully vested in the Plan. Forfeitures are applied to reduce the employer contribution and/or added to employer matching contribution and allocated as an additional matching contribution. Unallocated forfeiture balances as of December 31, 2024 and 2023 totaled \$239,978 and \$117,924, respectively, and forfeitures used to reduce the Company contributions for 2024 were approximately \$1,000.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess of the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan or 50% of their nonforfeitable account balance. Loan terms can be up to five years except when the loan is used to purchase a principal residence. A participant may not have more than two personal loans outstanding at any point in time. The loans are secured by the balance in the participant's account, not to exceed 50% of the participant's total nonforfeitable amount, and bear interest based on the U.S. prime interest rate prevailing at the time of the loan is granted, plus one percent. Principal and interest are paid through periodic payroll deductions. Loan transactions are recorded as a transfer from the investment funds to the corresponding participant's notes receivable. The balance of the loan will be due upon termination of employment, otherwise the loan will be declared to be in default and will automatically be treated as a distribution to the participant. The loan is deemed to be in default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment or the participant makes or furnishes any false representation or statement to the Plan.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. All other administrative expenses of the Plan are paid by the Company and are excluded from the financial statements. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions

Participant contributions and the matching employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Loan maintenance fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies, continued

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by ASC.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 - Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

Notes to Financial Statements, continued

4. Fair Value Measurements, continued

Following is a description of the valuation methodologies and inputs used for each general type of investment measured at fair value by the Plan:

Common/Collective Trust Funds: Collective trust fund investments are valued at their fair value that is readily determinable, published and is the basis for current transactions. These funds are classified within level 1 of the valuation hierarchy.

Registered Investment Companies: Registered investment companies consist primarily of mutual fund investments. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common/collective trust funds consist of separate investment profiles that provide an appropriate mix of investments that has the potential to produce the desired return while reducing volatility in the overall value of the portfolio. The profiles primarily invest in registered mutual funds, exchange-traded funds and collective trust funds. The participant directed redemption has no restrictions.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Income Tax Status

The underlying prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan holds units of common/collective trust funds managed by ASC. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

8. Delinquent Participant Contributions

During 2024, the Company failed to transmit certain participant contributions to the Plan in the amount of \$520,749 within the time period prescribed by ERISA. Late transmissions of participant contributions constitute a prohibited transaction under ERISA section 406, regardless of materiality. The Company subsequently transmitted the delinquent participant contributions to the Plan and will reimburse the Plan for lost earnings. Related excise taxes will be paid by the Company.

9. Subsequent Event

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.
