Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Ryan Lawn & Tree, Inc. Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Ryan Lawn & Tree, Inc. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions, which is available from the Plan Administrator.

General – The Plan is a defined contribution plan covering all eligible employees of Ryan Lawn & Tree, Inc. and subsidiaries (the “Company”) who are 19 years of age and have completed three months of service. Eligible employees may enter the Plan on the first day of the month following the date the employee has met the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Alerus Financial, N.A. (“Alerus”) serves as the Plan’s custodian, participant recordkeeper, and third-party administrator. The president and employees of the Company serve as the Plan’s trustees.

Previously, Empower Trust Company, LLC (“Empower”) served as the custodian and recordkeeper and DeMars Pension Consulting Services, Inc. served as the Plan’s third-party administrator.

Plan Restatement – The Plan was restated effective January 1, 2024, to adopt the Alerus Prototype Non-Standardized Defined Contribution Plan and Trust. The assets of the Plan were transferred to Alerus Financial, N.A., who assumed custodial, recordkeeping, and third-party administrator duties for the Plan. As a result of the restatement, the Plan was amended with the following changes to the Plan’s provisions:

- Eligible employees may enter the Plan on the first day of the month following the date the employee has met the eligibility requirements.
- Effective April 1, 2024, the Plan will withhold an automatic deferral amount of 5% from each participant’s compensation unless:
 - a) The participant has in effect, on April 1, 2024, a salary reduction agreement with an elective deferral amount of 5% or greater, or
 - b) Unless the participant makes a contrary election.
- At the beginning of each Plan year, automatically enrolled participants will have their deferral election increased by 1%, up to a maximum of 10%, unless the participant makes a contrary deferral election.
- Mandatory automatic rollovers for all balances less than \$5,000.
- Effective April 1, 2024, the Plan permits In-Plan Roth Rollover contributions.

Contributions – Participants may contribute any amount of their annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. The Plan includes an auto-enrollment provision. Eligible participants will have an automatic deferral amount of 5% of eligible compensation, unless the participant opted in writing to have another amount or 0% withheld.

The Company may make discretionary matching contributions to the Plan. In 2024, the Company matched 25% of the first 10% of compensation that a participant contributed to the Plan.

The Company may also make a discretionary nonelective contribution. In order to share in the discretionary nonelective contribution, if any, a participant must be employed on the last day of the Plan year and have 1,000 hours of service during the plan year. The discretionary nonelective contribution will be allocated to participant accounts based on the proportion a participant's compensation bears to the total compensation of all eligible employees, as defined in the Plan. No discretionary nonelective contribution was made by the Company during 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution, an allocation of Company contributions (if any), and allocations of Plan earnings (losses), and is charged with the participant's withdrawals and distributions, and an allocation of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments – Participants direct their contributions into various mutual funds and common collective trusts.

Vesting – Participants are vested immediately in their voluntary salary deferral contributions and earnings thereon. Vesting for the discretionary employer contributions is 20% after two years of service, with an additional 20% accruing with each additional year of service. Full vesting occurs after 6 years of service.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures may be used by the Company to reduce future employer contributions and to pay plan expenses. During 2024, \$54,030 of forfeitures was used to reduce employer matching contributions, and forfeitures of \$17,539 were used to pay administrative expenses. At December 31, 2024 and 2023, there is \$1,285 and \$2,415, respectively, in forfeitures.

Payment of Benefits – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary receives the participant's account balance in a single lump-sum. If the vested portion of the account balance is less than \$5,000, the participant's vested account balance will be automatically distributed if the participant does not elect to roll-over the balance to another qualified plan. Balances between \$1,000 and \$5,000 will be automatically rolled over to an IRA account.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Adoption Agreement and permitted by the IRC. Hardship withdrawals are limited to the participant's deferral account balance.

Participants who have obtained the age of 59½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

Administrative Expenses – Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan. Fees paid by the Plan in 2024 include investment management fees of \$120,512, and administrative expenses of \$21,493.

Termination of the Plan – Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Contributions – Company and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in mutual funds, money market fund, and common collective trusts (“CCT”) are deducted from income earned on a daily basis and are not separately reflected. Consequently, a portion of management fees and operating expenses are reflected as a reduction of investment return for such investments.

Excess Refundable Contributions – Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management’s Review – Management has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has

a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies at December 31, 2024 and 2023.

Common Collective Trust – Valued at the net asset value “(NAV)” of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held in the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds and Money Market Fund – Valued at the published NAV of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value as follows at December 31, 2024 and 2023.

4. RISKS AND UNCERTAINTIES

The Plan invests in mutual funds and a collective investment trust, which hold various securities, including U.S. Government Securities, corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIANS

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Alerus Financial, N.A., the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024, and for the period April 1, 2024 to December 31, 2024. Also, Empower Trust Company, the prior custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2023, and for the period January 1, 2024 to March 31, 2024:

- Investments at fair value
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investment include a money market fund managed by Alerus. Alerus is the custodian of the Plan, and therefore, these transactions qualify as exempt party-in-interest. The Plan pays certain fees to Alerus to administer the Plan. These transactions qualify as exempt party-in-interest.

Previously, Plan investments included a common collective trust managed by Putnam Fiduciary Trust Company. Putnam Fiduciary Trust Company is an affiliated company of Empower, the prior custodian of the Plan, and therefore these transactions qualified as exempt party-in-interest transactions.

Additionally, the Plan previously paid certain fees to Empower and DeMars Pension Consulting Services, Inc., the prior third-party administrator, to administer the Plan. These transactions qualified as party-in-interest.

7. TAX STATUS

The Company adopted a Prototype Non-Standardized 401(k) Profit-Sharing Plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
