Note 1. Description of the Plan

The following description of Indiana Organ Procurement Organization, Inc. dba Indiana Donor Network 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Indiana Organ Procurement Organization, Inc. dba Indiana Donor Network (Organization) for the benefit of its employees who are age 18 or older. NLW, Inc. is a participating employer of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The National Bank of Indianapolis (NBI) serves as Plan custodian. Effective January 1, 2024, EPIC Retirement Plan Services (EPIC) serves as the Plan recordkeeper. Prior to January 1, 2024, Nyhart served as the Plan recordkeeper.

The change in recordkeepers initiated a blackout period beginning December 26, 2023 and continued through January 22, 2024. During this period, participants were unable to direct, diversify or withdraw the assets held in their accounts.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions of up to 100% of eligible compensation up to the maximum allowed by law. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Organization matching and non-elective contributions are discretionary as determined by the Organization's Board of Directors annually. The Organization elected to make a matching contributions of 50% of the participant's deferral on the first 3% of eligible compensation plus 100% of the participant deferral on the next 3% of eligible compensation for the years ended December 31, 2024 and 2023. Non-elective contributions are only provided to participants who are actively employed at Plan year end and have worked at least 1,000 hours during the Plan year, unless they meet certain criteria. Contributions are subject to certain limitations. During 2024 and 2023, the Organization elected to make a discretionary non-elective contribution of 5% of eligible compensation.

The Plan also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant makes an affirmative election otherwise. The automatic deferral feature includes an automatic increase feature where all of those automatically enrolled at 3% deferral on eligible compensation will have an automatic increase of 1% of deferral on the first day of every Plan year, to a maximum of 6% deferral on eligible compensation.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and discretionary matching contributions plus earnings thereon. Vesting in the Organization's discretionary non-elective contributions is based on years of credited service. A participant is fully vested after three years of credited service. The nonvested balance is forfeited upon termination of service. Forfeitures are first used to pay administrative expenses and then used to reduce Organization contributions.

Those hired after January 1, 2021 have Organization matching contributions vest at 50% after two years of credited service and 100% vested after three years of credited service. For participants in the Plan prior to January 1, 2021, Organization matching contributions deposited to the Plan after January 1, 2021, will continue to be 100% vested immediately.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his account. In-service withdrawals are allowed under certain circumstances provided by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$76,995 and \$4,373, respectively. These accounts will be used to pay Plan administrative expenses or offset Organization contributions. Forfeitures used to pay administrative expenses amounted to \$38,343 and \$39,751 in 2024 and 2023, respectively. Forfeitures used to reduce Organization contributions amounted to \$20,779 and \$11,325 in 2024 and 2023, respectively. The employer's contribution receivable was reduced by \$117,230 and \$20,779 by forfeitures to be used in the subsequent period as of December 31, 2024 and 2023, respectively.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. Only one loan may be outstanding. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payments made directly through payroll deductions. Loan interest rates are prime rate plus 1%.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefits paid based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

Effective January 1, 2024, the Plan operates under a volume submitter 403(b) prototype plan document sponsored by EPIC Advisors, Inc. Prior to January 1, 2024, the Plan operated under a volume submitter adoption agreement in connection with a prototype 403b plan document sponsored by Nyhart. These prototype plan documents have been filed with the appropriate agency. The Plan has not obtained or requested a determination letter as the prototype documents have received favorable opinion letters. The Plan has been restated since the prototypes received favorable opinion letters. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

Note 3. Certification of Plan Custodian

The Organization has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The National Bank of Indianapolis, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, notes receivable from participants and other receivables as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and a money market fund. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3. There are no Level 2 or Level 3 securities held by the Plan.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

During 2024 and 2023, the Plan paid \$32,877 and \$29,499, respectively, of recordkeeping fees to EPIC and Nyhart, respectively. Investment management fees paid to NBI during 2024 and 2023 was \$35,901 and \$27,127, respectively. The Organization provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Subsequent Events

Effective January 1, 2025, participants only receive the annual discretionary employer contribution if actively employed at Plan year end and have worked at least 1,000 hours. There is no longer any exceptions for termination due to death, disability or normal retirement age.

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.
