Notes to Financial Statements

Family Guidance Center of Alabama 403(b) Plan Montgomery, Alabama December 31, 2024

Note 1 – Description of the Plan

The following description of the Family Guidance Center of Alabama 403(b) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility - There are no age or service requirements for eligibility to make elective deferrals. Employees are eligible to make elective deferrals as of their employment date. Employees who have completed one year of service are eligible to receive employer matching contributions as long as the 1,000 hour service requirement is met during the year. Non-resident aliens and employees who normally work on average less than 20 hours per week are excluded from participation in the Plan.

Participation - An eligible employee shall become a participant the first day of each month, provided the employee has satisfied the age and service requirements for employer matching contributions.

Contributions - Each year, participants may elect to have a percentage of their salary, as defined in the Plan, withheld and contributed to the Plan on their behalf. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization contributes 100% of the first 4% of base compensation that a participant contributes to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts - Each participant's account is credited with the participant's contributions and the Organization's matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Participant's Interest - Participants will always be one-hundred-percent vested in their own contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A year of service for vesting purposes is defined as a year in which an employee completes at least one thousand hours of service.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, through installments, or in the form of an annuity.

Forfeited Accounts - Forfeited non-vested accounts may be used to pay administrative expenses of the Plan or applied to reduce future employer contributions. During the year ended December 31, 2024, the plan utilized \$2,900 of forfeited amounts to reduce employer contributions. At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$0.

Plan Amendment – As of January 1, 2024, Roth contributions are now allowed into the Plan.

Note 2 – Summary of Accounting Policies

Basis of Presentation - The financial statements are prepared on the accrual basis of accounting.

Use of Estimates in the Preparation of Financial Statements - In preparing financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - The Plan's assets are presented at fair value or contract value as reported to the Plan by American United Life Insurance Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. See Note 4 for a discussion of the Plan's fully benefit-responsive investment contract which is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Separate accounts: Valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is based on the fair value of the underlying investments adjusted for applicable fees.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Investment Contract with Insurance Company

The Plan has an investment contract with American United Life Insurance Company (AUL). The contract offers a stable value investment option plus variable (separate account) options. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by AUL. Contributions directed into the separate account investment options are not guaranteed as to a fixed dollar amount but will fluctuate based on the performance of the underlying investments.

Note 4 – Investment Contract with Insurance Company (Continued)

For December 31, 2024 and 2023, the Plan offered the AUL stable value account, which is a benefit-responsive investment contract with AUL. For the investment, AUL maintains the contributions in a general account. Amounts allocated to the accounts will earn interest at the higher of the rate guaranteed under the contract or the current rates established and declared in advance by AUL. As of December 31, 2024 and 2023, the contract value of the Plan's stable value account was \$485,803 and \$457,427, respectively.

For December 31, 2024 and 2023, the year's contributions and the corresponding interest rate are tracked together administratively in a separate interest rate pocket. Prior to the beginning of a new calendar year, a new interest rate is established and declared. This rate is based on past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments. The contractually guaranteed rate for 2024 and 2023 was 1.50% and 1.25%, respectively.

All benefit-responsive Plan benefit payments made prior to contract liquidation are made at contract value. A participant may transfer any amount from the fixed account. However, he/she may transfer funds to the fixed account only after 90 days have elapsed since the date of his/her last transfer from the fixed account. Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value. This total liquidation is a contingent event, which cannot be initiated by Plan participants and can only be initiated by the plan sponsor upon termination of the Plan or complete termination of the contract. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 5 – Information Prepared and Certified by the Custodian (Unaudited)

The Plan's investments were embodied in an investment contract with American United Life Insurance Company (AUL) at December 31, 2024 and 2023 (See Note 3). The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the custodian, AUL, as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note 6 – Related Party Transactions and Party in Interest Transactions

The Organization provides certain accounting and administrative services to the Plan for which no fees are charged. Certain expenses incurred in connection with the general administration of the Plan are paid by the Organization, and therefore, qualify as party-in-interest transactions.

Certain investment options offered by the Plan are managed by American United Life Insurance Company. American United Life Insurance Company is the custodian of the Plan's assets and, therefore, these transactions qualify as party-in-interest transactions.

Note 7 – Plan Termination

Although it has not expressed an intent to do so, the Organization has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 8 – Income Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 22, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
