Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the Orlando Orthopaedic Center, M.D., P.A. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers substantially all employees of Orlando Orthopaedic, M.D., P.A., (the Organization/Employer) who have attained twenty-one years of age and are employed for a 12 consecutive month period during which they complete at least 1,000 hours of service as an employee. The original effective date of the Plan was June 1, 1974. The restatement provisions of the Plan became effective on January 1, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of eligible compensation into pre-tax or Roth deferral accounts, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For each plan year, the Employer may contribute to the Plan an amount of matching contributions determined by the Employer's board of directors at its discretion. Additional profit sharing amounts may be contributed at the option of the Employer's board of directors and are allocated pro rata based on compensation. The Employer also contributes ADP test safe harbor contributions of 3% of participants' qualified compensation.

Participant Accounts

The Plan permits participants to direct their account balances among various investment options in the form of mutual funds, as well as a fixed account and self-directed brokerage account. Each participant's account is credited with the participant's contribution, the employer's contribution and an allocation of the Plan's earnings, and is charged with an allocation of administrative expenses, if any. Participants may change their investment options periodically. Contributions of \$42,206 had not been allocated to participants' accounts at December 31, 2024.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. Participants vest 20% per year after two years of service, and are 100% vested after six years of service. A participant is also 100% vested upon death, disability, or attainment of normal retirement age.

Participant Loans

Participants may borrow from their accounts up to 100% of their vested account balance. The term of the loan is limited to ten years. The loans are secured by the balance in the participant's account and bear interest at a rate of one percentage point over the prime interest rate. Principal and interest is paid ratably through biweekly payroll deductions. The minimum loan amount is \$1,000.

Payment of Benefits

Participants are eligible to receive the vested portion of their Plan account upon age 59 1/2, termination of employment, hardship, disability or death. Payment may be made in a lump-sum.

Forfeitures

The nonvested portion of a participant's account is forfeited as of the earlier of: (a) the date of distribution of the participant's entire vested account balance, or (b) the date the participant incurs five consecutive vesting breaks in service, as defined in the Plan document. Forfeitures are used to reduce employer contributions. During the year ended December 31, 2024, \$28,774 of non-vested accounts was forfeited. No forfeited plan assets were used to reduce employer contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are therefore excluded from these financial statements.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means.• If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE C – FAIR VALUE MEASUREMENTS – CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Fixed Account: Fair value consists of the sum of the contributions plus interest.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account investments:

Mutual funds: See “Mutual funds” above.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Unit investment trusts: These investments consist of exchange traded funds, valued at the closing price reported on the active market on which the individual funds are traded, and are classified within level 1 of the valuation hierarchy.

U.S. government securities and corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities.

Cash equivalents – interest-bearing: These investments are substantially equivalent to cash.

NOTE D – PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Voya, the trustee as defined by the Plan and, therefore, certain transactions qualify as party-in-interest transactions. Administrative fees were paid to Voya, and its affiliates, during the years ended December 31, 2024 and 2023 by Orlando Orthopaedic Center, M.D., P.A.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE E – PLAN TERMINATION

Although it has not expressed any interest to do so, the Employer has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE F – FEDERAL INCOME TAX STATUS

The Internal Revenue Service has informed the Organization by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrators and certified as complete and accurate by Voya.
