We have performed audits of the financial statements of Advance 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of the Plan and Nature of Operations

The following description of the Advance 401(k) Plan (the Plan) of Advance Publications, Inc. (the Company, the Plan Sponsor, or Plan Administrator) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution plan for the benefit of employees of the Company and a controlled group of companies and its affiliates. The Plan was adopted effective April 15, 2011 and has since been amended from time to time thereafter. Effective September 1, 2018, the Plan changed from a single-employer plan to a multiple-employer plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Investment assets of the Plan are maintained under a trust agreement with Fidelity Management Trust Company (the Trustee), and the Plan's recordkeeping administrative services are provided by Fidelity Workplace Services LLC (collectively, Fidelity). All investment and participant loan transactions are executed by Fidelity at the direction of, and for the exclusive benefit of, participants under the Plan. The Plan uses a pre-approved volume submitter plan document sponsored by Fidelity and was most recently amended and restated effective as of December 1, 2021.

Participants' Accounts

Each participant's share of the Plan's assets is recorded in an account established for that participant. Each participant's account is credited with the participant's contribution, if any, and the participant's share of the Company's contribution, adjusted to reflect income and expenses, realized gains and losses, and unrealized appreciation or depreciation in the value of the Plan's assets. All contributions are invested based on participant direction. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may elect to divide their contributions or initiate a transfer among the investment fund options in whole increments of 1% on a daily basis, subject to certain restrictions. A self-directed brokerage account option is also available to allow participants to select mutual fund investment options not specifically offered by the Plan. An eligible participant may elect to suspend or resume his or her contributions, subject to the Plan's notice requirements. Changes requested by participants are implemented as soon as administratively practicable, in accordance with the Plan document.

Contributions

Under the Plan, the applicable contribution rates and matching contribution rates differ by division. Eligible employees, as defined in the Plan document, may, at their option, contribute up to certain percentages, depending upon divisions, each year of their eligible pre-tax compensation, subject to certain Internal Revenue Code (IRC) limitations, into any of the available investment elections. The Plan document provides for the Company to make nondiscretionary matching contributions, and permits a discretionary nonelective contribution and a discretionary matching employer contribution to be determined annually based on division. During the Plan year ended December 31, 2024, the Company made nondiscretionary matching contributions ranging from (i) 66 2/3% of up to 6% of eligible compensation contributed to the Plan, to (ii) 60% of up to 8% of

eligible compensation contributed to the Plan. During the Plan year ended December 31, 2024, the Company made discretionary matching employer contributions ranging from (i) 100% of the first 1.0% plus 50% of the next 2% of eligible compensation contributed to the Plan, to (ii) 60% of up to 8% of eligible compensation contributed to the Plan.

Newly hired or rehired eligible full-time employees are automatically enrolled in the Plan. The default pre-tax contribution rate is 3% to 5%, depending on the division, and is implemented following notification to the participant, in accordance with the Plan Sponsor's administrative procedures. These employees can elect to participate at a different rate, or opt out of the Plan, and their future contribution rates will be adjusted as soon as practicable.

Participants may also choose to make contributions on an after-tax basis through a Roth 401(k) option. Roth contributions are made in lieu of all or a portion of the pre-tax contribution the participant is otherwise eligible to make under the Plan. Contributions and earnings for the Roth 401(k) option are not subject to taxation at the time of distribution, as long as the distribution is a qualified distribution due to termination of service, death, disability, or after reaching age 59½.

A participant who has made the maximum amount of permitted deferral contributions for a Plan year, and who has attained or will attain age 50 during such Plan year, may elect to make additional catch-up contributions. Catch-up contributions will be considered elective deferral contributions for all purposes under the Plan, except that catch-up contributions (a) will not be subject to the percentage contribution limitations, and (b) will not exceed \$7,500 for 2024.

Rollover Contributions and Transfers

The Plan permits active participants to have their interests in other qualified plans rolled over to the Plan, or to make rollover contributions into the Plan from a conduit individual retirement account (IRA), which holds amounts attributable solely to a rollover from another qualified plan. In addition, the Plan permits for direct transfers of participant accounts for employees in businesses that were acquired by the Company. Such transfers or rollovers to the Plan may only be made with the approval of the Plan Administrator and do not affect any other contributions made by or on behalf of a participant.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,657,803 and \$1,950,262, respectively. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$1,851,736 using forfeited nonvested accounts.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon.

Vesting in the Company's contributions and related earnings is based on the vesting schedule for the applicable division, as defined in the Plan document.

Payment of Benefits

Upon retirement at normal retirement age, as defined, death, or termination of service, a participant's vested interest in the Plan becomes payable to the participant (or his or her assigned beneficiary in the case of death). A participant may elect to receive benefit payments in periodic installments, a lump-sum amount, or as a direct rollover contribution to an IRA or an eligible retirement plan of all or part of the payment. Withdrawals prior to attaining retirement age are not permitted except for in-service withdrawals after reaching the age of 59½, or in the event of termination or disability, for a qualified birth or adoption, or as a hardship distribution. Upon proof—to the satisfaction of the Plan Administrator and in compliance with the IRC—of an immediate and heavy financial need, certain amounts contributed may be withdrawn for hardship purposes. Certain income tax penalties may apply to withdrawals or distributions prior to retirement age.

Notes Receivable from Participants

Subject to approval by the Plan Administrator, participants may have two loans outstanding at one time: a general-purpose loan and a home purchase loan, or two general-purpose loans. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 (reduced by the participant's highest outstanding loan balance during the preceding 12-month period), or (b) 50% of the vested portion in the participant's account. The loans are secured by the balance in the participant's account. Such borrowings generally must be repaid (through payroll deductions) within five years (or ten years when it is for the purchase of a principal residence). All loans have interest at a rate fixed by the Plan Administrator based on the interest rate currently being charged for loans of comparable size, risk, and maturity when the application for the loan was approved. Notes receivable from participants bore interest at rates ranging from 3.25% and 8.50% as of December 31, 2024 and 3.25% and 9.00% as of December 31 2023. Notes receivable from participants at December 31, 2024 and 2023 amounted to \$10,669,254 and \$10,223,979, respectively, and represent unpaid principal balance.

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the modified cash basis of accounting under which contributions are recorded when received, investment income is recorded when collected, and benefit payments and expenses are recorded when paid. Investments are adjusted to fair value. The modified cash basis of accounting is a comprehensive basis of accounting other than U.S. generally accepted accounting principles (GAAP).

Use of Estimates

The preparation of financial statements on the modified cash basis requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets, additions to net assets, deductions from net assets, and disclosures of contingent liabilities, if any. Actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for a discussion of fair value measurements.

The Fidelity Managed Income Portfolio II, a common/collective trust fund, is a stable value fund that is a commingled pool of the Fidelity Trust for Employee Benefit Plans. The fund may invest in fixed interest insurance investment contracts or Guaranteed Investment Contracts (GICs), money market funds, corporate and government bonds, mortgage-backed securities, bond funds, and other fixed-income securities. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals.

See Note 4 for further information concerning the Fidelity Managed Income Portfolio II.

The Fidelity Managed Income Portfolio II is presented at fair value, which represents net asset value (NAV) of the fund at contract value, as contract value is the amount that participants will receive under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when collected. The Plan's investment assets are not guaranteed as to principal or interest, and their values vary depending upon the performance of the underlying investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Investment management, investment advisory fees, and certain administrative fees of the Plan are paid from the assets of the Plan. Participants are charged for a portion of the cost to administer the Plan, including the recordkeeping, accounting, legal, and Trustee services, and other

administrative services, which are deducted automatically from the participant's account. Participants are also charged for certain transactions, such as the processing of a loan. Certain other administrative and advisory fee expenses in 2024 were paid by the Company.

Certain investment fees and transaction-based fees are paid within the funds held by the Plan. These fees are deducted from income earned on a daily basis and are not separately reflected. Consequently, these fees are reflected as a reduction of investment return for such investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

4. Fair Value Measurements

The fair value of an asset or liability is based on the assumptions that market participants would use in pricing the asset or liability. Valuation techniques consistent with the market approach, income approach, and/or cost approach are used to measure fair value. The Plan follows a three-tiered fair value hierarchy when determining the inputs to valuation techniques. The fair value hierarchy prioritizes the inputs to valuation techniques into three broad levels in order to maximize the use of observable inputs and minimize the use of unobservable inputs. The levels of the fair value hierarchy are as follows:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level consists of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of assets or liabilities whose significant value drivers are unobservable.

The following is a description of the valuation methodologies for the Plan assets measured at fair value:

Registered Investment Company Mutual Funds - These assets are valued at the NAV of shares held by the Plan at year-end. Mutual funds are quoted and redeemable daily, and exchange-traded funds may be traded at any time on the exchange that they primarily trade. There are no restrictions on redemptions; however, a fee may be charged if the Plan only holds the security for a short period of time. Mutual funds are classified as Level 1 investments.

Self-Directed Brokerage Account - The Plan offers a brokerage option, BrokerageLink, whereby participants can elect to invest their Plan accounts in numerous mutual funds not offered directly by the Trustee. The Plan's investments in cash and mutual funds within the BrokerageLink accounts are valued at unadjusted quoted prices in active markets.

Common/Collective Trust Funds - Common/collective trust funds are valued at the NAV as determined by the respective collective trust fund as of the valuation date, which approximates fair value. The NAV is based on the fair value of the underlying investments held by each fund, less its liabilities. A daily NAV is available from the issuer. Common/collective trust funds are classified as Level 1 investments.

Stable Value Funds - Investments in stable value funds are valued at fair value based on the NAV of the shares held by the Plan at year-end, which represents contract value. The stable value funds use independent pricing services approved by the Trustee to value its investments. When current market prices or quotations are not readily available or reliable, valuations may be determined in good faith in accordance with procedures adopted by the Trustee. Factors used in determining value may include market or security specific events, changes in interest rates, and credit quality. The stable value funds are classified as a Level 2 investment.

There were no changes in methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest Transactions

Certain Plan investments are shares of registered investment company mutual funds, a self-directed brokerage account, common/collective trust funds, or stable value funds managed by Fidelity, which is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Notes receivable from participants also qualify as exempt party-in-interest transactions.

6. Tax Status

The Plan has adopted a volume-submitter plan document that received an Internal Revenue Service (IRS) advisory letter, dated June 30, 2020, stating that the volume submitter plan is designed in accordance with applicable sections of the IRC. The Plan document has been amended since receiving the determination letter. In the opinion of the Plan Administrator, the Plan and its underlying trust are currently designed and have operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there were no uncertain tax positions that would require recognition of a liability (or derecognition of an asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed the intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate its participation, subject to the provisions of ERISA. In the event the Company terminates the Plan, participants become fully vested in their accounts, and the assets of the Plan will be distributed to the participants in accordance with the provisions of ERISA.
